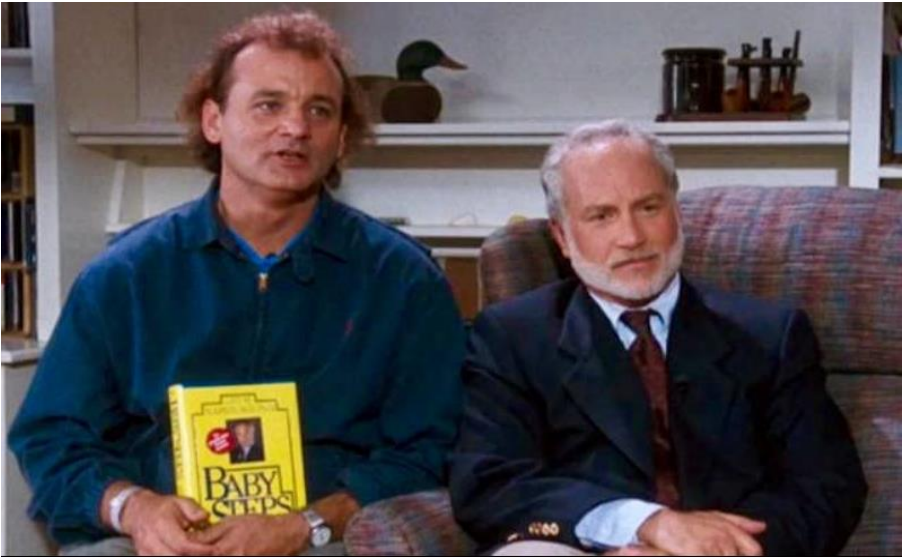

The fact is that the Congress makes it worse by purposely miscalculating the true inflation rate using gimmicks instead of reality. The result is that even with a higher-than-average cost of living increase. Social Security benefits typically do not keep up with the everyday expenses retirees face as they age. Folks, especially seniors pay the price but seniors have a tough time believing their favorite Democrats would be cheating them. We are talking real expenses seniors must pay to live.

How about livings expenses like rent, food, transportation (including gas), and of course, health care and the astronomical

amount of money people must pay for life-saving prescription drugs. How do I know this? From the research I have done for the five books about my recommended boosting of social security, I have become one of the most knowledgeable sources on the subject who ever lived.

What is the biggest truth to support my claim? Consider the fact that The Social Security Act was signed into law by President Roosevelt on August 14, 1935. In addition to several provisions for general welfare, the new Act created a social insurance program designed to pay retired workers age 65 or older a continuing income after retirement. It was about five years later on January 31, 1940 that the first dime was paid from the fund.

The recipient was Ida May Fuller. From Ida May Fuller's Payroll Tax Contributions and the contributions of others over those five or so years, the fund was able to be paying out to retirees, On January 31, 1940, the first monthly retirement check was issued to Ida May Fuller of Ludlow, Vermont, in the amount of \$22.54. How much would that \$22.54 cents a month payment amount to on January 31, 2021?

Calculating the Date difference from Jan 31, 1940 (1st SSR check) to Aug 21, 2021 (today)

The total number of days between Wednesday, January 31st, 1940 and Saturday, August 21st, 2021 is 29,788 days.

This is equal to 81 years, 6 months, and 21 days.

This does not include the end date, so it's accurate if you're measuring your age in days, or the total days between the start and end date. But if you want the duration of an event that includes both the starting date and the ending date, then it would actually be 29,789 days.

Unfortunately, the cheap (no cost) inflation calculators on the Internet work only with whole years. So let's use 1940 through 2021 knowing we will be short a few bucks. We're short a lot of bucks right now.

\$22.40 in 1940 is equivalent in purchasing power to about \$436.80 today, an increase of \$414.40 over 81 years. The calculator uses a dollar with an average inflation rate of 3.74% per year between 1940 and today, producing a cumulative price increase of 1,850.02%. I did not try to assure the inflation rate.

This means that today's prices are 19.50 times higher than average prices since 1940, according to the Bureau of Labor Statistics consumer price index. A dollar today only buys 5.13% of what it could buy back then.

The 1940 inflation rate was 0.72%. The current year-over-year inflation rate (2020 to 2021) is now 5.37%¹. If this number holds, \$22.40 today will be equivalent in buying power to \$23.60 next year. The current inflation rate page gives more detail on the latest inflation rates.

Let's now use the Accurate Historical Inflation Calculator

This Historical Inflation Calculator will calculate the amount of CPI price inflation between any two dates from 1913 up to the latest month reported by the U.S. Bureau of Labor Statistics (BLS).

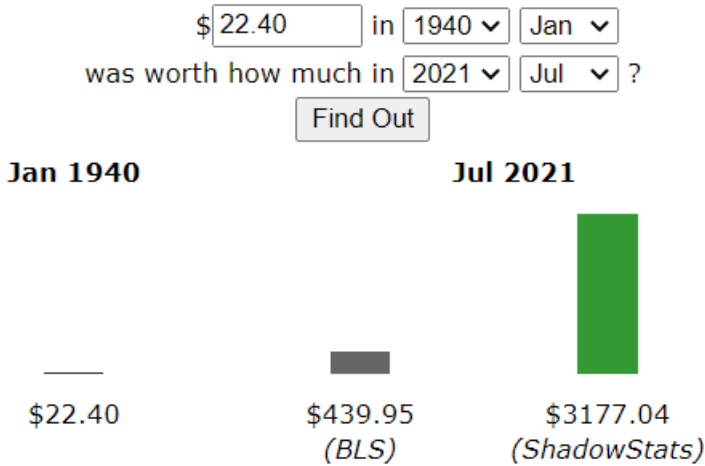
The CPI data is sourced from the BLS. However, we also present our own "Alternate Shadowstats" CPI (the real cost of living) estimates for comparison purposes.

Further background on the SGS-Alternate CPI series is available in the Shadowstats Public Comment on Inflation Measurement. Note that we show the Alternate SGS estimates graphically for non-subscribers, and with numerical precision for subscribers.

Shadowstats, which we will discuss in detail in this report is an alternate (real) way to figure out the inflation rate. Consider this when calculating how the government has short-changed seniors by using various tools known as consumer price indexes, which are engineered to give the government some of your money each year by not using the real cost of goods in the inflation rate. However, the shadowstats alternate index gives a true reading.

Here is how much a senior living in 1940 collecting SSR has lost to today. Yes, I know there are not too many left if any but it shows the rip-off employed by our government.

Inflation Calculator



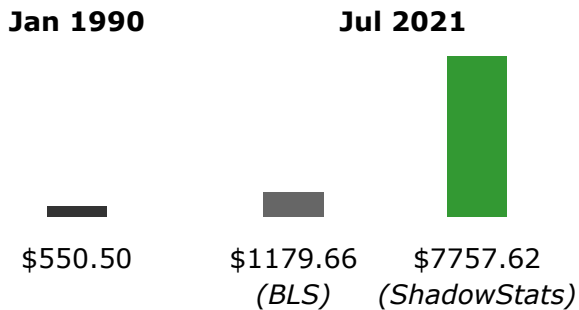
BLS: Bureau of Labor Statistics, CPI-U (Urban Workers, All Items).
ShadowStats: Shadow Government Statistics Alternate CPI.

What this means folks is that a dollar in 1940 is today worth \$141.83. Yes, that means a dollar is worth 141.83 times less now than in 1940. The first SS check given out was \$22.40. If that

check were invested at the Shadowstats alternate rate, it would be worth \$3177.04 today. In other words, if the government adjusted COLA with a real cost of living index, Ida May Fuller would be collecting a check in the amount of \$3177.04 every month using true inflation.

If the same \$22.40 that Ida collected in 1940 were adjusted by the Consumer price index as used in the Bureau of Labor Statistics, the monthly check would be 439.95 which is 7.22 times less than the amount she would have been collecting if the government used a real cost of goods number in their inflation statistics. Ida would have been ripped off by 722%.

Let's look at the average Social Security check from in 1990. Today 31 years later this would be worth which was 550.50

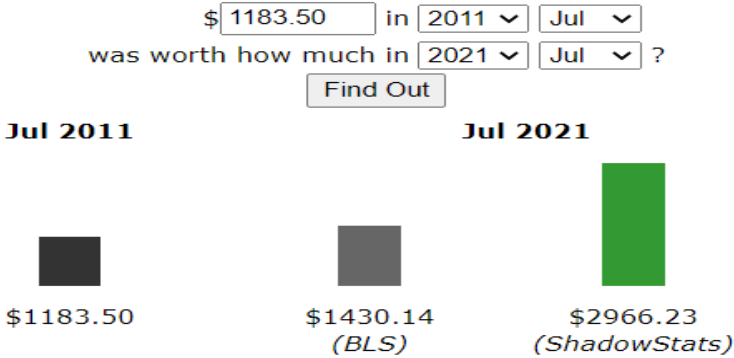


The BLS number (1179.66) is what you would be receiving in your Social Security check. If the real cost of goods was used as the check determinant, you would be receiving \$7,757.62 per month. That is a huge discrepancy because the government uses a bogus method to calculate inflation to keep your check amount a lot lower. \$7,757.62 v \$1179.66. I bet you knew you were being ripped off but not by so much. The government shortchanged your check by a factor of 6.57 or 657 percent. In real dollars your check is shortchanged by \$6577.96. I bet you could use that money now rather than be teetering on the verge of poorhouse residency.

For those who have been on SSR for ten years since July 2011, let's see how much you lost on your last paycheck.

The average SS check in 2011 was 1183.50. Let's see what that computes to with inflation by 2021 using this special calculator:

BLS: Bureau of Labor Statistics, CPI-U (Urban Workers, All Items).
ShadowStats: Shadow Government Statistics Alternate CPI.

As you can see, in ten years from 2011 to 2021, the average SSR check increased to \$1430.14 from \$1183.50 = a 246.64 per check gain instead of a 1782.73 per check gain. That is real money folks. The check amount should have almost tripled. Who gets the money you lost. The government. Can they pay you back?

The Democrats are ready to spend about \$6 trillion in 2021's budget. I think they could afford to pay seniors back for what they stole. Don't you?

Because low COLAs compound over time, this loss of income due to low COLAs will continue to grow deeper as beneficiaries age. "This has not gone unnoticed by those who depend on these annual adjustments," she says. "Many Social Security recipients tell us their standard of living has declined," Johnson says. For some, feeding the family has become an almost impossible task because the government has stolen money from seniors. We prove our point in this book.

The true cost of inflation is available

Americans have no inherent bartering system upon entering a marketplace as we find in other countries so no matter which decision we make, we survive—at least for small while. The vendor, not the consumer, is king in America. But seniors know that for real, the government holds all the cards for seniors.

Seniors have few choices but the three annotated above. We can also try other markets after we leave the store that disappoints us. Figuring out the expensive and inexpensive stores is one of our

choices and I guess, duties as a consumer. It's better for sure than no choices at all.

But, when all stores raise their prices, the senior choices are minimized, especially if your income does not increase by the rate of inflation that the prices are tuned in-to. Nobody likes being ripped off so when we check out the other stores, and their prices increase also, we know it may be an invisible hand raising all the prices but at least it is not a mechanism that we perceive as unfair. But, what if a guy writing a book such as this insists that it is very unfair for seniors. Would seniors believe me. I think not I say regrettably.

Seniors have pride and even though they paid into SSR, they feel a little guilty being on the take. So when the government hoses them with a minimal COLA each year, many grumble to themselves and take it on the chin. Recently many grumble and then cut back on food or get rid of a pet or so something else they should not have to do to survive. If you check out the Walter Williams' Site—shadowstats.com, you will be surrounded by the truth on inflation. The US

We lost Williams about a year ago. Walter Williams, one of the great ones lived in Devon, Pennsylvania, since 1973. ... Williams died in his car on December 1, 2020, at age 84, shortly after teaching a class at George Mason University. His daughter said that he suffered from chronic obstructive pulmonary disease and hypertension.

Williams' index will show you that even in years when government says COLA is at zero, the real inflation rate is at least 5% and often as high as 10% more. That's why seniors have lost at least \$15,000 or more in just the last decade. Despite the proof, the government is created to not admit this truth to the public.

Understanding all the work and misapplied calculation that the BLS analysts do to defraud seniors is so complex, seniors feel compromised to complain. Most seniors choose not to say anything because they are not sure. Nonetheless not speaking up is the worst thing seniors can do. If they did, they would be forced to give seniors an accurate cost of living adjustment that reflected the real inflation rate, not their bogus rip-off.

It exposes why middle-class Americans — salaried workers who are given routine pay hikes and retirees who depend on annual increases in their corporate pension and Social Security payments — can't maintain their standards of living.

Plainly and simply, the Index shows that their income cannot keep up with their expenses without an accurate adjustment, and it explains why they increasingly have to turn to the government for entitlements to bail them out.

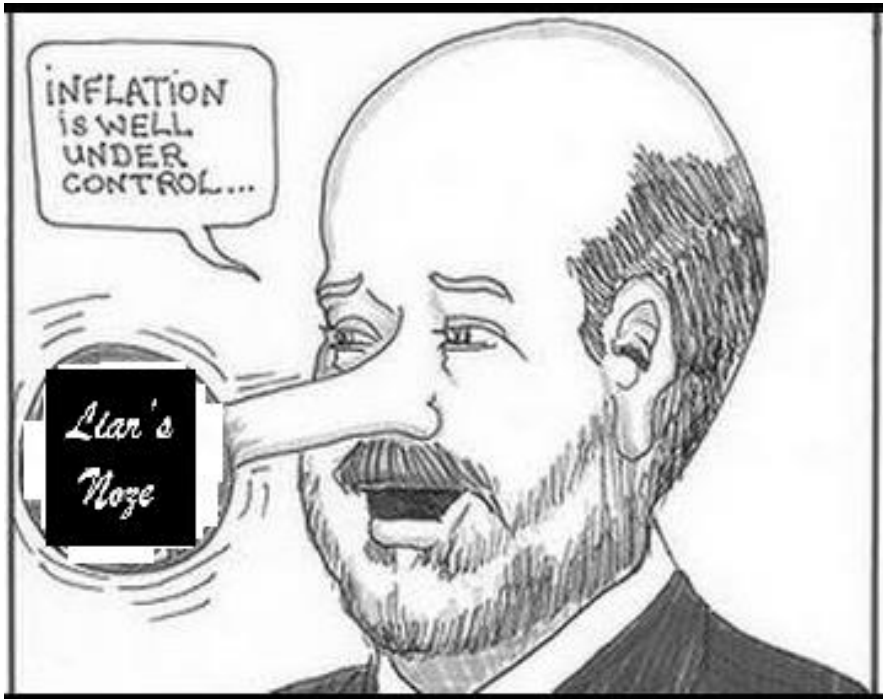

Chapter 3 Does Government Lie about Real Inflation? Yes!!!



Is Government lying to us about inflation? Yes!

In today's Outside the Box, Gary D. Halbert (my old and very dear friend and former business partner of many years) reminds us about a few significant facts concerning the Consumer Price Index (CPI) that mainstream economists and the media tend to ignore. The central question is whether the CPI is really indicative of the actual inflation rate. Not likely, says Gary, since the US Bureau of Labor Statistics (BLS), which compiles the CPI, has engaged in methodological shenanigans over the past couple decades (as has been well documented by John Williams of ShadowStats, among others).

The upshot of all their monkeying with the numbers is that the official rate of inflation may be two to four times lower than the actual rate (which is rather convenient if you're a government bureaucrat trying to hold down interest costs and Social Security payments).

[Isn't that terrible? Screwed by our own government intentionally... This insert is from the author. That means folks that when Obama gave zero, you should have gotten 2 to 4 percent and as I recall a few of those years it was as high as 6%. That's a lot to permit yourself to not receive because of government cheating. Seniors, according to all the experts have a large payback coming.]

These changes are hotly debated in academic circles *[where the coffee-breath professors are prevalent.]* . There are many economists who agree with the changes and can show with their models that inflation is low. That is the currently accepted wisdom, or what passes for it. The problem is that inflation only shows up, as one person put it, in the things we actually buy.

If your main costs are food, energy, education, and healthcare (ring any bells?), then inflation is a great deal higher than 2%. Other items are actually falling in price. It comes down to the mix of items in the calculations and whether you buy into the concepts of substitution (if beef gets too expensive we buy hamburger rather than steak) and "hedonics," which says that prices of products drop over time as quality and manufacturing efficiency improve, so the calculation of inflation should take this into account.

[That, my friends is double-speak for the government having the last word, right or wrong about whether you receive a true cost of living adjustment]

Which means you can have official inflation at a low level (or even falling for certain items), while the amount you actually spend out of your very real pocket is rising! And thus the debate.

Having refreshed us on the basic techniques of CPI massage, Gary turns to food and energy, which the BLS includes in "headline CPI" but omits from "core CPI." He points out that while

headline CPI jumped an unexpected 0.7% in February, core CPI rose only 0.2%. That is, food and energy price increases accounted for more than 70% of the rise. “Not good for the economy,” he notes.

And of course, this is all bad news for unwary investors, since Those who believe that inflation is only 2%, when it may be 5-8%, may be making investment decisions that are almost guaranteed to erode the purchasing power of their money over time. This is especially true with low-yielding investments such as CDs, Treasuries, etc.

Gary wraps up by taking a look at “chained CPI,” which he explains as follows:

[C]hained CPI assumes that when prices rise, consumers will resort to entirely different products, rather than just seeking a cheaper brand. For example, if beef prices rise, chained CPI would assume that consumers might opt for chicken to save money.

The chained CPI debate is raging as we speak: I got an email from the AARP this morning, urging me to tell my Senators to say no to chained CPI being used to calculate Social Security cost-of-living adjustments (COLA) – sounds like they may vote today (Friday) on a bill to do just that.

But as Gary points out, we either calculate benefits using chained CPI – which, yes, is tough on those living on a fixed income – or we eliminate the cap on salary subject to Social Security taxation (that is, we raise taxes). As Gary says, “Either way, somebody’s got to pay, and it might end up being a little [of] both.”

[seniors should be out of this and should receive what Roosevelt intended, a true cost of living increase based on what seniors buy. But for too many years, the Congress, knowing this is true and knowing seniors are getting further and further behind by faulty if not downright fraudulent calculations, have permitted it to continue simply because seniors are the least likely government constituent to threaten to send a congress-person home for keeps. I hope seniors are listening.] --- End of article ---

Government Payback for Past Fraud a Must

You'll see in subsequent chapters proof that the average social security recipient has lost over \$15,000 in the past decade. Since the losses for seniors are cumulative (meaning this year's increase is on top of last year's amount plus last year's COLA), technically we need to go back to the 1970's when the fraudulent calculations began with CPI-W et al.

This was given to us when the Bureau of Labor Statistics on behalf of the Social Security Administration (SSA). They chose government bureaucrats and coffee breath professors from academe to systematically create arguments to reduce the inflation rate to save government dollars. The savings were intended to be raised off the backs of seniors needing to break-even year after year.

The BLS bureaucrats with their academe coffee breath professors, some smoking sweet pipe tobacco, concocted a scheme that created a fake CPI. The former CPI before the manipulators were given license to manipulate, meant the actual unadulterated rate of inflation and at the time it was legitimately called the consumer price index (CPI).

After the machinations of the bureaucratic analysts in the BLS and those under contract from academe, the CPI-W became the buzzword for the calculation that ultimately was used with respect—as if it were legitimate—to make seniors pay dearly for their CPI machination. To repeat, in the last decade, it has cost seniors more than \$15,000 on the average.

But it is a fraud. Despite its existence as a known prevarication, it is used by all government entities dealing with money and inflation. Surrogates in these areas systematically and purposefully reduce the SSR's monthly payments for senior citizens. These payments often are the major, if not the only "pension" source for a regular family. Seniors, growing up in a different time, are unaccustomed to fighting the government. To survive in these corrupt times, however, seniors will have to learn how to fight.

The truth on inflation is available outside the government

As we more than intimated in prior chapters, there are a number of reputable organizations including the late Walter Williams' Shadowstats.com that have proven that the government's dishonest CPI-W misses the mark often by as much as 500%. It produces an inflation number that is inaccurate but very favorable to the government's mission of reducing payments to SSR recipients. It is thus not a secret to our Congress that seniors are forced to move further behind each year in attempting to afford the natural increasing expenses of living.

You tell me how much this has hurt seniors. Check the foreclosures. There are no poor houses anymore but more and more people today would be in the poor house if there was not welfare and Medicaid booster systems to help. To the heartless coffee-breath professors in academe, however, if seniors could afford to buy cat-tuna to eat themselves, they should not have to give up their homes in foreclosure. Just tighten your belts! Check it out yourself.

When you and I go to the store and something is double in price we know without checking the CPI that there is inflation. Over the years, the things we buy have been increasing by 2%; 5%; 10%; 20%; 50%; and even higher and new things with larger continual increases have been added to the senior citizens' burden.

Can seniors afford life with a crooked COLA?

It may not be a punch that gives seniors a real black eye. However, the government hurts seniors in the worst possible place—their ability to be able to afford to live.

Can you believe that such excluded items from the BLS list include health insurance, medical expenses, gasoline, car

expenses, and huge property taxes, other taxes and fees as well as new but deemed necessary items.

Seniors get zero while paying for others such as welfare class, government employees, and illegal aliens. For example, in my home town, every year that Obama denied seniors any COLA, city employees actually got a 3% pay raise. Their raise of course was paid for by local tax increases paid by seniors.

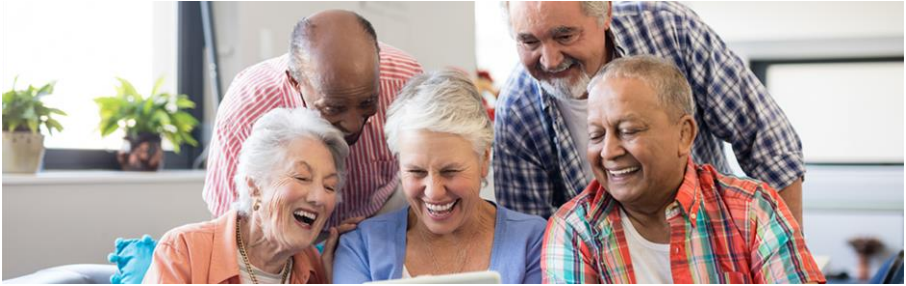

Chapter 4 It's Time for "The Seniors Administration."



Senior's advocates could influence govt decision makers.

I for one believe that when an agency is created for seniors, life will get better. If the Agency broadcasted the plight of today's senior citizens, they would also insist that the Congress create a great Seniors Administration (SA) that would be comparable in quality with the Veterans' Administration (VA) without all of the special funding needs.

Senior funding today comes from the people who contribute or have contributed to the FICA payroll deduction for most of their lives. It is administered by the Social Security Administration (SSA) and the COLA is calculated and also diminished by the Bureau of Labor Statistics (BLS).

A dedicated Senior Administration (SA) agency would measure among other major plusses for seniors. It would stop a negligent Congress from continuing to stiff seniors from reasonable increases to stay even with inflation.

Who would not love to see the days of home foreclosures and life style minimization come to an end abruptly. Just because seniors are older, does not mean we do not deserve a happy life.

Before President Donald Trump solved the VA issues by making veterans a national priority, things were not so good. Then, the President set the Veterans Administration on a course to make life right for veterans. Despite solid military traditions, life was not so good for the many who had given so much for our country.

That moment left no doubt that the Trump administration was and still is determined to use the new law to expand the private sector's role in veterans' health care. No more long lines at the VA hospital. This change for veterans is monumental. Trump is a big difference maker for veterans.

Any president who cares about seniors can play as important a role in the problems that seniors are having in getting a fair shake

from the government. A Politico headline saw this as the new mantra for Democrats in their disdain for seniors:

“Democrats to seniors: *Drop Dead.*”

As noted previously, even though the military’s slogan for years has been *leave no one behind on the battlefield*, before Donald Trump vowed to solve the problem at the VA, far too many veterans had begun to believe their country had left them behind at home, once they were out of uniform and in need of help.

The president took the right action and things are now much better in terms of the Veterans Administration. With Trump full-time on the job, few Vets today have to remember this was their old motto:

“Delay, Deny and Hope That I Die.”

Before Trump, at the VA, this was reality!

Few can deny that with the callous treatment seniors receive from the same government, they have been left behind. It has been a long time since seniors got a fair shake. It was back at least when the CPI-W was instituted during the recession of 1973-1975. Seniors have been left behind and in the woods. Those past their prime today need a real slogan very much like the battlefield slogan of the veterans to help guide the care that is to be given to America’s greatest generation and those who qualify for SSR.

Most Americans today are well aware that the “Greatest Generation” refers to those Americans, all of whom are now seniors. They were born in the 1900s through the 1920s. The Greatest Generation members all lived through the Great Depression and many of them fought in World War II. The Greatest Generation members also tend to be the parents of the Baby Boomer generation. Some historians stretch the greatest generation well through the 1940’s and even into the 1950’s to

respect the role today's elderly had in saving America during World War II.

Stretching the Greatest Generation to Other Demographics

Categorizing the generations is an inexact notion depending on who is marking off the years. Generally speaking, the Greatest Generation are the parents of the "Baby Boomers" and are the children of the "Lost Generation" (those who grew up during or came of age during World War I). They preceded what is known as the "Silent Generation," a cohort born between the mid-1920s to the early-to-mid 1940s, which some stretch through the 1950's.

The grandchildren of the Greatest Generation therefore are members of Generation X, , Generation Y, and the Millennials. For our purposes the following chart works well for this book:

The senior citizen designation for "old farts" like me is not a legal term but is most often used for Americans over age 49. Since normal social security payments can begin at age 62, those above this age are most often known as senior citizens or seniors. If you are not yet 62, you may still be eligible for social security if you are disabled. I know, like many of the seniors reading this book, I would prefer to be fully functional rather than disabled and having to wait a few years for benefits. Nobody denies the disabled their due.

Here is the Social Security Administration's definition of disability: You are entitled to receive Social Security disability

(SSDI) or Supplemental Security Income (SSI) benefits when you are no longer able to perform a "substantial" amount of work as the result of a physical or mental impairment that is expected to last at least 12 months, or possibly result in death. To Social Security, a substantial amount of work, called "substantial gainful activity," is making \$1,220 or more per month, before taxes (or \$2,040 per month for people who are blind, in 2019).

Even though many collecting SSR do not know this, it is possible for someone who has never worked a day to obtain disability benefits under a program called SSI or "Supplemental Security Income." Fortunately, people who become disabled but have never worked are covered under the SSI program if they do not qualify for Social Security Disability. Since these folks did not contribute, there is some resentment, yet, nobody would like to trade their benefits for anybody else's disability.

Raises come to all SSR and disability recipients but they are not intended to be raises. They are intended to be break-even adjustments so that the ravages of inflation do not put all seniors and the disabled in the proverbial poorhouse.

Cost of Living Adjustments

All SS Recipients get an automatic cost-of-living increase when they are on disability. A cost-of-living adjustment (COLA) is available to everyone who receives benefits from a Social Security program, including Social Security Disability Insurance (SSDI), Supplemental Security Income (SSI), and Social Security Retirement (SSR).

The issues regarding the COLA as discussed in this book are germane for all recipients of Social Security benefits, not just for those collecting retirement. The Social Security Administration (SSA) administers SSDI.

Some 8.5 million people receive disabled-worker benefits from Social Security. Payments also go to some of their family members: 117,000 spouses and 1.5 million children.

More than 8 million people—including 1.2 million children with disabilities—rely on SSI to meet their basic needs. Monthly benefits average just \$541. The Social Security Administration runs SSI

Is Social Security Bad News?

Social Security is tremendous. It is a life-saving government program—probably the best government program there ever was. It is without a doubt—a wonderful program. Without it, many senior citizens would not have been and still would not be able to survive.

In my research for this book, I could not find statistics for the years that life was lengthened for those seniors who were collecting SSR benefits versus the very same seniors if they were not able to collect the benefits (adjusted for inflation) of their contributions.

If I were to estimate with no supporting data, my guess would be that 20% of all seniors collecting benefits would have died much sooner without the major benefits provided by the SSR system.

My rough estimate would be that seniors on SSR would last at least five years longer than those not on such benefits. That would mean 20% (X 60 million on SSR==12 million) of all beneficiaries gained 5 years onto their natural lives.

That would mean that 12 million people would have lived five years longer. So, we can say that every five years, over 60 million people have lived five years longer. That is a major benefit for Social Security. Moreover, all of these beneficiaries paid in something so this is not welfare. SSR is a great system.

Much of this book is about the COLA (Cost of Living Adjustment). Bureaucrats and coffee-breath professors in academe, think COLA should be ACOLA (*Almost cost of living adjustments*).

COLA for SSR and SSDI and SSI is designed to keep senior benefits steady (constant) regardless of inflation. The reason this is important today more than in the past is that the work of the BLS in shortchanging the COLA has taken its toll on the ability for seniors to survive in life.

By not keeping the market basket constant, the BLS exerts a cumulative negative effect on the ability of seniors to make ends meet. Inflation was understated so that seniors could not maintain their normal lives with the same relative ability to afford living as time was moving on.

As great a system that the contributory pension scheme of Social Security provided over the years, its goodness was diminished by BLS Bureaucrats and coffee-breath professors who had forgotten that the numbers they produced as a “CPI,” affected real people who did not know they had signed up for a charade.

The real people counted on a 1940 dollar being adjusted each year by a true consumer price index, not a cheating imitation concocted by glory seeking bureaucrats looking for kudos by stiffing seniors.

President Roosevelt’s intention for SSR was not to diminish the dollar’s purchasing power of seniors as inflation hit the economy each year over time. His idea was to lift the dollar up so that it had what could be called a constant value for all and its value could be counted on even as it differed from the face value. Its value was not supposed to be decreased over the years. The purpose of Social Security was always for the elderly to retire with dignity. Stealing what keeps seniors breaking even every year shortchanges that dignity.

Unfortunately, because of the BLS bureaucrats and the coffee-breathed professors in academe, the temptation for the bureaucrats to give money back to the US treasury has ruled the day. There is no concern for dignity of any kind and government cheating is permitted or by now people would be in jail. The BLS found that the true COLA could easily be stolen from seniors . This was far too great a temptation for these government employees and

contractors to give a flat “no!” to the scheme. They chose to be dishonest to please their higher-ups.

So, systematically seniors have been denied the full breakeven calculations. Instead without revealing the net effect of their charade, the government analysts and contractors have reported the CPI as being far less than it really was—as if it were a true measure of inflation. Each year, the reality of their work product takes real money right out of the wallets of seniors.

This would have been an innocuous notion if the jerrymandered numbers were not used to fool senior Americans who required a fair and accurate consumer price index (CPI). Instead, what seniors got and still get is a Kentucky-windage estimate that serves their low-life purposes for reducing the adjustment seniors receive.

There is no question that social security itself from Roosevelt onward, even with the cheating, extends the lives of seniors. However, the bureaucrats have made it very difficult to make ends meet for seniors by not treating the COLA fairly. It was not supposed to be this way. To give a perspective, please check out the following chart:

Like the Veterans forced to cry out because for years at the poorly run VA Hospital system, they had been left behind, seniors suffer

similar abuse. Where ineptitude seemed part of the VA's problem, seniors are actually cheated by the government intentionally. Think about that sentence for a while. Chew on it.

With major publications characterizing a major political party's best suggestion for seniors as "Drop Dead," it is clear that Democrat Party respect for what seniors deserve has dropped to an all-time low in recent times. Nobody who "drops dead" has to be paid by the Social Security system. Is that what this is?

Additionally, no oversight government agency is charged to make sure that seniors are being treated properly by the government. The Department of Veterans Affairs does that job for veterans and even with them, the VA system became a sham until Trump fixed it. There is no agency making sure that Seniors are not being mistreated by the government. I would say having the Bureau of Labor Statistics (BLS) steal money that with a little honesty would be going into the pockets of seniors, is a prosecutable crime. Americans know if this notion were brought to the attention of a good President, with all the seniors of today teetering at the poverty border, it would become his national priority. It is up to us all to help seniors get noticed by our President and our Congress.

It was Abraham Lincoln who said the purpose of the VA was to "care for him who shall have borne the battle." But the wars in

Iraq and Afghanistan pushed the VA further behind in that mission, and on the way to President Trump, there were a million veterans waiting for the VA to handle their disability claims.

As we noted previously, that had led some veterans to find solace by latching onto another motto that had made the rounds for how the VA had been operating: "Delay, Deny and Hope That I Die." Thanks to President Trump, things have changed for Veterans.

Would it not be nice if seniors had a day and if seniors had their own Seniors Administration run by a gentleman as capable and compassionate as former US Secretary of Veterans Anthony Joseph Principi. Now that Trump has the Veterans Administration running smooth like it is part of the military again, seniors know that such an organization for seniors would be very welcome. As you read this nice message from Secretary Principi, think about just how wonderful such an organization would be to serve seniors.

Veterans Affairs reform is now reality under President Trump

The latest reforms at the Department of Veterans Affairs under the Trump administration give me a lot of hope on this Veterans Day. As a veteran myself, I recognize that we must do more than honor the sacrifices and achievements of those who have answered the call of duty. It is about remembering our own duty as a society to ensure veterans are not left to

fend for themselves with the challenges and issues service can bring.

I served during the Vietnam War, a conflict that put tremendous strain on servicemen and women and their families. Then 18 years of sustained conflict since 9/11 resulted in even more of the same stresses. Under that pressure, the safeguards we had in place to protect veterans faltered. By the final years of the Obama administration, the situation had blossomed into a full blown crisis, with veterans reportedly dying on waiting lists.

During the 2016 campaign, Donald Trump made correcting this problem one of his top priorities, and he has not relented on that objective since taking office. To that end, he has done everything in his power to wind down the seemingly endless wars of the last two administrations and avoid entangling our troops in anymore bloody overseas conflicts.

President Trump has been adamant that Veterans Affairs establish the key programs to care for both the physical and psychological wounds of our returning service members. Through taking executive action and signing bipartisan reforms into law, he has time and again demonstrated his own commitment to delivering the reforms our veterans deserve. He has also made sure the government provides them adequate resources.

The budget allocation was a record \$201 billion for Veterans Affairs this year, and the budget request for next year calls for raising that figure to \$220 billion. Some of that money will go toward attracting medical and management talent to Veterans Affairs that was lacking in certain areas, a task furthered by the Veterans Affairs Choice and Quality Employment Act. The Trump administration has also taken crucial steps to improve the prospects of future veterans. The National Defense Authorization Act this year has raised military salaries by 2.6 percent, the most in nine years.

Money is not everything, though, which is why President Trump has also worked with lawmakers to reform how Veterans Affairs works and will continue to ensure that dollars are spent wisely for our veterans and their families. To that end, he signed the Veteran Appeals Improvement and Modernization Act, the Veterans Affairs Accountability and Whistleblower Protection Act, and the Mission Act, all designed to create flexible new treatment options while building a culture of accountability. The Mission Act notably allows veterans to use benefits at private medical facilities if their local Veterans Affairs hospital is unable to fully meet their needs.

On his own authority, President Trump has signed executive orders to improve treatment at Veterans Affairs. Understanding that suicide and mental health issues are very often as devastating as any physical injury incurred in the service, President Trump signed two executive orders specifically addressing suicide among veterans, which has ballooned to tragic levels. Veterans who live far from traditional federal hospitals can take advantage of new telehealth options to connect with doctors and therapists, including mental health professionals, from their homes.

The White House also launched an official hotline two years ago to help veterans navigate the complexities of the Department of Veterans Affairs. Since then, the hotline, primarily staffed by veterans and direct family members of veterans, has fielded more than a quarter million calls from veterans and resolved an impressive 94 percent of its cases. Our duty to our veterans is eternal. This year's and every future Veterans Day, Americans can be proud that our commander in chief is honoring our national promise to them.

Administration on Aging

The closest thing to a VA for senior citizens is known as *The Administration on Aging (TAA)*. It is a nice idea but it simply is not enough. No cigars go for this agency but it is better than nothing.

You can tell the difference in scope of various government programs by looking at their respective budgets. It also gives an idea how far a program such as the seniors administration (SA) would have to go before it began to make a dent in the issues with the elderly population.

With a \$2 Billion budget, The Administration on Aging (TAA) allocation is not chump change but compared to over \$200 Billion for the VA, you can see that the purpose of the TAA is light advocacy for the aging whereas the VA is a substantive solution to Veterans' issues.

Most of us already know the purpose and the reach of the VA system. It is a real difference maker for veterans, Thank God it now works. The TAA as an agency to help seniors is 1/100 the size of the VA. Its mission currently is to work to keep other government organizations aware of the issues that influence seniors so that legislation affecting the senior population keeps their needs and issues top of mind, and they provide grants to various other organizations that provide direct services and education to seniors

That is a fine mission but there is a problem. Most seniors know nothing about the agency. If its purpose were as a simple advocacy group to stop other government agencies from ripping off seniors by reducing the COLA, the Administration on Aging would be much more welcome by seniors. But nobody, of whom I am aware, knows what it is or does.

Consider this \$2Billion dollars bureaucracy about which its principal client—all the seniors in America, are mostly unaware. This tells the whole story. The agency is obviously not impacting seniors in any meaningful way. I am seventy-one years old. This means I have been a senior about ten years and I have never heard of this agency.

What would give it purpose is if its mission were to satisfy the needs of seniors by being an advocate for legislation as well as a conduit for the President to understand better the problems seniors

face. I have yet to hear President Trump speak once about the COLA rip-off, which costs seniors as much as \$15,000 in one decade and then since it is cumulative, it costs more as time goes by.

We all know how President Trump enjoyed being able to help veterans. President Biden speaks little about seniors. We should be sure that any president would likewise help seniors if he were tuned into this nasty trick pulled off by government.

Chapter 5 How Would a Seniors Administration (SA) Help Seniors?

The chapter title unfortunately tells too much. Why should seniors need protection against the US government? And, why would anybody think that the US government would be the best vehicle to provide such support?

The answer to the second question is the most important. We have seen recently when major advocacy agencies such as the VA are reengaged, they do a fine job. Seniors would like a model agency built somewhat like the VA in its determination to do right by seniors to lead an effort to make things as they should be for the elderly community in America. I am especially talking about those seniors on social security as well as citizens on SSI and SSDI, who are subject today to the whims of a rogue agency, the BLS, comprised of uncaring bureaucrats and coffee-breath professors from academe.

The answer to the first question is because the Bureau of Labor Statistics (BLS) on behalf of the Social Security Administration has found that with no oversight such as from a watchdog seniors administration, they have been able to run roughshod over the

Since the BLS is a government agency and since they have been committing the crime of theft from seniors for over 36 years, they must be stopped. Samuelson from the Washington Post who wrote a column recently titled: “Don’t expand Social Security. Our elderly are mostly fine.” Glad you think so Mr. Samuelson. How much has government fake calculations on the CPI cost you recently? However much it is; it is too much.

His talking points net out to his idea that expanding Social Security is mostly a political bribe that comes at the expense of other programs and workers, who must pay the resulting taxes. Seems like Samuelson wants seniors to demand that their benefits get cut. Fat chance. Seniors may be getting old but they are not nuts.

How would the Seniors Administration Function?

Government likes to set up agencies that purportedly are there to help people. My proposal in these two chapters is to create one of those agencies and call it the *Seniors Administration (SA)*. The role of this agency would be simple—to prevent other government agencies such as the Social Security Administration (SSA) and the Bureau of Labor Statistics BLS from pillaging and defrauding seniors.

How would this be done? The SA would not be a full-service agency like the VA. It would simply be a watchdog to make sure they SSA and the BLS can never go south again on the American people.

A separate group from the current BLS CPI-team needs to be established who. Their job would be to contract with an outside group such as the Shadowstats Group and the Chapwood Group where the true inflation rate would be calculated as part of their normal business. From these outside groups, the true inflation rate would be determined and the Seniors Administration would make sure that it is correct before passing it on to the BLS to be announced to the public.

Since the government owes seniors over \$2.5 trillion, most of that amount will be paid back. How? It will be according to the Payback Plan and the payback program will be finished in three years as follows:

Beginning in 2020, instead of the normal CPI-W that has been the method for 36 years, instead for a three year period, seniors will receive a 10% COLA twice a year. Ten percent will be distributed in January and ten percent will be distributed in July. This will have the effect of a 20% increase per year for seniors but since it will be cumulative every six months (Bases on the SSR payment at the time), the overall effect each year will be somewhat more than 20% in total. After the 6th payment, seniors will begin to receive an amount calculated by the real inflation rate once a year as their annual COLA

“Safeguard against the hazards and vicissitudes of life”

Roosevelt never suggested that seniors be stiffed if the government decided it did not want to keep the dollars constant. To be sure, Roosevelt’s proposition on June 8, 1934, “promised a plan for social insurance as a safeguard "against the hazards and vicissitudes of life." Today, I regret the hazards and vicissitudes have come mostly from the BLS and SSA – agencies of the government itself. SSR recipients need to be paid back for all their losses according to the prescription announced above.

Can the dead corpses of seniors help the government make its bottom-line numbers?. Is there any group of which any of us are aware that represents senior citizens in the same fashion as the Vets are represented and supported by the VA?

This chapter is based on an article by Sean Williams writing for Motley Fool just about two years ago in October 2019. He first announced like me, that seniors got another rip-off-calculated COLA from the Democrats in government along with the coffee-breath beauties in academe. It was the annual announcement which occurs in the middle of October--Social Security's most anticipated announcement of the year was put out again and now is almost two years in the past.

The message is that things will not be getting much better for seniors. Need it or not, all recipients were going to get a mouth-watering "*generous*" 1.6% bump. Isn't life just grand? If this is your eleventh raise, Using the real inflation rate, Sean Williams has news for you that will put a big tear in your eye. The analysts in the Bureau of Labor Statistics (BLS) from academe and

government, using their CPI-W recipe for fraud, over the last ten years have stolen an average \$15,258 from you and every other SSR recipient in the past decade. Think about whether you and other seniors should ever trust the government again,

It all happened on Oct. 10, 2019 when the U.S. Bureau of Labor Statistics (BLS) released inflation data from September, which happened to be the final puzzle piece needed for the "experts" to calculate the various CPI rates which ultimately determine the Social Security Retirement's (SSR) cost-of-living adjustment (COLA) for 2020.

In simple terms, COLA is the "raise" that SSR beneficiaries receive from one year to the next that takes into account the inflation they've faced. Of course, it's not a raise in the truest sense of the word, because COLA is only designed to keep up with inflation, not outpace it.

When the news release crossed the wire, we learned seniors from across America had begun figuratively to get sick to their stomachs. And, of course there was a run on Pepto-Bismol at Seven-Elevens.

OK I jest. But this is not far from the mark. I know it sickened me as I do get sick when I am ripped off by anybody, especially the government. It is almost 100% certain that the program's nearly 64 million beneficiaries will receive their hard-fought 1.6% raise per month on the average per month for 2020. What is not certain is whether they can find a store that still takes pennies so that they will be able to spend their wad each month.

For those calculating your increase, save your grey matter as Sean Williams did the calculation for us all. He predicts that the number is about \$24.00 per month extra for the average retired worker. Isn't Uncle Sam the greatest?

Sean is a fair minded guy so he admits in his piece written for motleyfool.com that this \$24.00 bonanza does not tell the full story of Social Security's COLA. Over the past decade, this yearly paltry increase has cost seniors a lot of money. About that I am

not kidding. That’s a sanitized way of saying that the government, based on the committee of Democrat analysts in government and coffee-breath professors in academe, stole \$15,258 out of the pockets of each and every senior citizen in the last decade. Did you complain about your loss? It is OK if you did not. I know most did not see the loss but surely we all felt it.

Williams does not let on but since his article was published, senior citizens receiving as little as zero percent per year during the Obama Administration, as a group had never complained to the cheating perpetrators in the government who committed this major crime.

I do think that if seniors would let the “bums” in Congress know they are really ruffled,” and that they are no longer going to vote for their regular Congress-persons, I predict that something good would begin to happen for seniors. Congress-persons who stiff seniors are not worthy of being reelected.

Reelecting such louts is not the answer for seniors to be able to make ends meet and make mortgage payments. The Congress is on the other side folks. Unless you are willing to kick them out of office, things will definitely stay the same.

Why? Williams says “The CPI-W is inherently flawed”

Social Security's COLA has been determined by the Consumer Price Index for Urban Wage Earners and Clerical Workers, or CPI-W, since 1975. To put this in perspective, it is a swindle calculation. It is designed so the government can exploit seniors who collect SSR, thereby save the rest of the taxpayers money. That money comes right out of senior’s pockets and it mounts quickly.

The CPI-W index is devised so seniors cannot understand it and will not try. It is an index with eight major spending categories and countless subcategories. It is complex so you cannot

understand it without a lawyer. The lawyer won't save you any money but they can explain why you are losing so much each year. Short of firing the Congress (great idea), or pleading your 2021 case to President Biden, there is not much you can do about it. Firing the louts in office would make you feel better.

Each of the subcategories has a predetermined weighting that allows the BLS to express aggregate inflation in one simple and concise number each month. When it comes to Social Security's COLA, only the readings from the third quarter (July through September) factor into the calculation.

The coffee breath professors and key Democrat government official analysts were never before, and still are not, interested in providing a fair representation of the inflation rate, or they would simply use the actual inflation rate. Dah! This rate is available across the Internet in many places. Two of my favorites are Shadowstats.com and Chapwoodindex.com. It is amazing how the government has intentionally ripped off the elderly community. Watch that you do not get too angry.

The machination which the experts decided is their baby is called the CPI-W. The W stands for *worker* even though SSR recipients are retired and do not work. You figure that one out. Experts on inflation who do not have a dog in the hunt concluded years ago that the CPI-W does an awful job at representing the true inflation that seniors face every day. Consequently each and every year seniors are shortchanged when they received their skinned down COLA. Their loss is not theoretical. It can be counted in real dollars.

Congress has been aware for years that seniors are getting squeezed unfairly but the Congress has chosen not to fix the problem. Why? Because seniors rarely complain and it helps to balance the budget. You can bet that it is more of the former than the latter as seniors have not been complaining enough to make it worth Congress's while to effect a real change.

Here is one of the excuses they give. They say it is because, as the name of the index implies (*the dash W part*), it's measuring the

spending habits of urban and clerical *workers*, many of whom are not 62 or older, nor are they receiving a Social Security retirement benefit.

In short, urban and clerical workers spend their money very differently than senior citizens spend their smaller amounts. Despite knowing this, Congress keeps the fraudulent extortion going. Congress simply has no time for seniors who choose not to complain.

Although apples-to-apples comparisons are hard to come by, the BLS did compare expenditures using the CPI-W and an experimental index known as the Consumer Price Index for the Elderly (CPI-E) in December 2011. Your author suggests that if given the opportunity to speak up, all seniors reject and of the BLS CPI dash measurements, including the W, the U, the E, and the chained version of the CPI. Do not buy into their charade. Reject all of the BLS work.

The CPI-E measure is not in effect. It is still experimental. However, if ever it is implemented, produce an inexact measurement of the real inflation rate. Its only claim to fame so far is that if it were substituted for the CPI-W, it would measure the spending habits of households with persons 62 and older.

Despite this alternate measurement being better than CPI-W, even with this Congress continues to cheat seniors—just not as much as the other CPI’s such as CPI-W and the Chained CPI. Congress can create legislation to make life better for those in most need of a fair shake by taking away all the hocus pocus and merely creating an inflation rate based on real market conditions as we had until the corrupt BLS got in the act.

In their test case, what the BLS found was that CPI-E spending on medical care was double that of the CPI-W, with housing costs also notably higher. This tells us that the CPI-W has always been regularly underweighting the true inflation that seniors actually contend with in regard to medical care and housing costs.

It does grant higher weighting to categories that don't matter much to seniors, such as apparel and the cost of a college or university education. Nonetheless, it, too is a contrivance to keep the BLS lording over seniors. Advise Congress to reject it and go back to the market basket year-to-year comparison.

The lack of believability in any government index is a very big problem considering that more than 4 out of 5 Social Security recipients are at least 62 years old. Not one member of Congress has stepped up and said that they know how to solve the problem and that they will solve the problem for seniors. I know how to solve it and I have solved it in numerous chapters in this book and other books that I have written about the subject. Would somebody please tell the current president that the solution to his troubles on the COLA for seniors is right here in this book.



Seniors lost major purchasing power because of Congress in last ten years.

The Senior Citizens League has been working on this for a long time. With 1.2 million supporters, The Senior Citizens League (TSCL) is one of the nation's largest nonpartisan seniors' groups.

Their mission is to promote and assist members and supporters, to educate and alert senior citizens about their rights and freedoms as U.S. Citizens, and to protect and defend the benefits senior citizens have earned and paid for. TSCL is not a friend of our do-nothing Congress. Instead, it consists of vocally active senior citizens concerned about the protection of their Social Security, Medicare, and veteran or military retiree benefits.

The group was first established as a special project—The Enlisted Association on January 1, 1995. At this time, TSCL became an independent 501[c][4] citizens' action organization.

Sean Williams noted that according to a news analysis from The Senior Citizens League (TSCL), extremely low COLAs over the past decade have cost retired workers a fortune. Whereas COLAs averaged 3% over the previous decade, the past 10 years have seen the average annual COLA dip to 1.4%. This includes three instances in Obama Times where no COLA was passed along in 2010, 2011, and 2016 due to what the Democrats called “deflation.” My response to that is the name of one of my favorite animals—Bull.

Obama’s administration created records in its propensity to stiff seniors out of a proper inflation-based COLA. For example, it was also responsible for the lowest positive COLA in COLA history—a meager 0.3% increase from Obama’s team in 2017. And then, last year, approximately half of all beneficiaries saw no real increase as Social Security’s 2.8% COLA was gobbled up by increases to Medicare Part B premiums. There have been no big surprises for seniors as their possible spending trajectory points to the floor.

To show you in some real numbers why the CPI-W is a rip-off, remember last year’s “big” 2.8% COLA disappeared because of Medicare Part B since medical is not included in CPI-W. This year, the supplemental insurance as well as Medicare Part D put a lot of seniors into the poor-house. I was close and if this book is successful, maybe I can avoid the poor house again next year.

Pardon the boredom but this is true and exact

Here are the specifics. My Humana Pharmacy policy last year was about \$28.00 per month per person. This year the same policy is \$56.00. It doubled perfectly. This doubling ate up the total of the \$24.00 COLA and added another \$4.00 per month in out of pocket expenses. To be frank, at this point, the COLA was

G-O-N-E!

Since my wife also has Humana, she has to come up with her own \$4.00 per month also. For both of us together, the cost is \$8.00 X 12 months == \$96.00 out of pocket for the family for the year. Not only was the COLA not enough for Pharmacy (Medicare Part D) but there is not a dime left for any other inflationary increases such as food price increases and clothing increases, taxes, and other insurances. The government inflation system is a lousy system i .

Of course that is not all. Last year our AARP supplemental from United Health Care was \$187 00 or \$374 for both my wife and me. This year, it is \$202.00 per month each or \$404.00 for both of us. So, this year, we owe another \$40.00 per month more (40 X12 = \$480 for the year.) Since the \$24.00 COLA was already eaten up by the Humana Pharmacy, there was no COLA left to apply to this extra \$40.00 per month due to United Health Care Supplemental Medicare increase. Pat and I had to absorb it ourselves from zero increases from any source. Eventually, after a few years of this, people run out of money. Why? One word:

G-O-V-E-R-N-M-E-N-T

Out of nowhere, with no COLAs left, and no other pension increases, and no job at 73 years of age, my wife and I have to absorb \$480.00 for a Medicare Supplemental policy. Seniors in our situation are asking themselves. *How are we supposed to pay for this?* My wife and I have similar sentiments. *How are we supposed to pay*

for this? I sure hope this book is successful to help our own bottom-line expenses.

Remember COLA is supposed to be the "raise" that we as SSR beneficiaries receive from one year to the next. It is supposed to take into account every dime of the inflation that seniors have faced. Seniors are not supposed to have lots of extra out of pocket expenses because we are not to receive anything extra. Why?

Because the COLA is not a raise in the truest sense of the word. COLA is only designed to keep up with inflation, not outpace it. As noted in our case, and in all previous years, with the bogus CPI calculations from the BLS it does not even keep up with inflation. Recently, the facts show that it gives less and less and less when seniors are looking from a last-year's perspective for same, same, and same. There is never a chance for more, more and more.

If the government were not using the CPI-W, the Medicare premiums would have been factored into the formula as well as the Pharma costs and the Medicare Supplemental. For my wife and I to break even, we would need a very good CPI-E COLA or my recommendation to the president and Congress—Dear President Trump, please fix this.

Unfortunately, in creating the CPI-W, the coffee-breath professors from academe, the Congress and the Democrat government BLS analysts were not interested in helping seniors so it is what it is.

More specifically, Social Security policy analyst Mary Johnson at TSCL found that the purchasing power of Social Security dollars has declined substantially over the past 10 years. [No kidding Mary!]

In dollar terms, Johnson notes that a retiree with a small average benefit of \$1,075 a month in 2009 has lost \$15,258 in financial growth between 2010 and 2019 because of the aforementioned 1.4% average COLA, when compared with what a 3% average COLA would have delivered.

Blame Congress and the Democrat government analysts whose mission is to reduce the federal deficit by stiffing seniors. Don't forget to save a second dose of blame for the coffee-breath professors who teach our children to stiff the elderly at every opportunity, especially if they support Donald Trump in his role as President of the United States of America.

If Congress and the regulatory bodies who are supposed to honestly determine the actual inflation rate, choose not to do their jobs correctly, what should the people do. While seniors are being stiffed overtly by these people, their loss of purchasing power is even more striking when we look back further over the years.

This is not a new phenomenon. seniors have always been threatened by Democrats, one election after another. Now there are no threats; instead the Democrats simply retaliate against seniors for their nerve to love their God and for God's love of President Donald J. Trump.

TSCL's analysis says that a COLA should never average lower than 3% in any year to lessen the drain of retirement savings on seniors, and in order to keep the elderly out of poverty.



Chapter 7 Congress Has Power to Fix Social Security for Seniors



Congress agrees that CPI-W hurts the elderly; but won't do anything about it.

Like everything else for seniors, Congress is underfunding the Social Security Administration. Perhaps what's the most intriguing notion about Social Security's inflation issue is that Congress wholeheartedly agrees that seniors are getting the nasty from them and the rest of the government and the academe elite.

Democrats and Republicans agree on virtually nothing when it comes to Social Security, but both parties firmly believe that the CPI-W fails to do a good job of accurately measuring the real inflation that program beneficiaries face. Seniors are partially to blame because they just take it on the chin rather than fighting back. Seniors must speak up or they will be rewarding the very slugs in the Congress who are hurting them.

Unfortunately, that's where the agreement with seniors' advocates ends, and why nothing is being done about fixing Social Security's inflationary tether on Capitol Hill.

Democrats, who brought the CPI-W upon us initially, now publicly prefer replacing the CPI-W with the aforementioned CPI-E. Yet, back when they controlled the presidency and the Congress, they did not take any action to make this happen. Now that they have control again with Biden and an all-D Congress, there is not a peep at the Capitol in support of seniors.

In doing so, if a recalcitrant Congress ever acts together to help seniors, the belief is that COLA would expand over time since the CPI-E would do a much better job of measuring the costs that are important to seniors. But Republicans aren't in favor of using the CPI-E, which is still considered to be an experimental measure in the eyes of the BLS.

Perhaps Republicans in Congress need a few personal visits from seniors to help show Trump's coattails were never wide enough to support Republicans who may think they can get away with stiffing seniors. If I were to create a message from any President to Republicans in Congress, it would say: Give Seniors what they want and need. Do not be a *horse's ass*. Your whinny will give you away.

As hard as it is for me to believe, I have been told that Republicans have proposed switching from the CPI-W to the Chained CPI. If Republicans ever want to get elected again, my recommendation is to immediately back off the whole idea of a COLA that cheats seniors. The Democrats learned their lesson. Take a tip from those who now know that seniors count. Chained CPI 'R No Good!

The COLA produced by a chained-CPI would further reduce the seniors' COLA. This has not happened yet and the thinking has been around for a long while. Obama was ready to institute the Chained-CPI. Some wise advisors in BHO's administration talked the Democrat President out of using this nasty index. Republicans who like holding office must pay heed to the consequences to their future electability. My advice to all who like holding office is to Say NO to Chained CPI or forever pay the consequences. Seniors will never forgive you.

The Chained CPI takes into account the idea of substitution bias. FYI, this is a bogus way of forcing seniors to accept less COLA and getting nothing, even a smile, in return. It is the worst idea I can think of, for making right the Democrat's initial fraud in the formation of the CPI-W.

As discussed, Obama when he was president, and his Democrat advisors, were smart enough in 2014 to reject this notion. If Republicans adopt this asinine notion, they should be known ad infinitum as the Dumb Party and the Democrats should automagically become the enlightened Party. Republicans should know that time is running out to discard the Chained-CPI as even a remote possibility.

Think about this. Whereby a consumer trades down to similar goods or services because of inflation (e.g., buying pork or chicken if ground beef prices rise), this should have no effect on the real inflation rate.

Yes, we admit that this is a real-world consumer reaction to higher prices, but no other inflationary index accounts for substitution bias as a means of punishing the ultimate consumer—the voter.

It would be dishonest not to note that switching to the Chained CPI would likely help the government's coffers and reduce the senior's COLA -- and therefore purchasing power -- even more than under the CPI-W. That's not something congressional Democrats would want to stand behind for long. If Republicans become known as the Chained CPI sponsors, their political lives will be shortened by a good measure while Democrats are laughing hard for having rejected the notion.

The Democrats so far own all the problems with CPI-W, since their minions in academe and in government have pushed the CPI-W, a mechanism to assure that seniors go further behind year after year.

However, if seniors spent more time working with advocates, the lily livered Republicans, fearing a voter retaliation would quickly

abandon their designs for the totally fraudulent Chained CPI and would look towards something like the CPI-E.

For me, however, because of all the intentional punishment that seniors have been forced to endure over the years, even CPI-E is not enough. But, it would be an OK start with a *Seniors' Administration* pushing for the right solution

I have already revealed my plan in prior chapters. My suggestion is simply to begin a restitution process that will bring seniors back close to an "even notion." The idea is the deal has to be sweet enough that seniors would be willing to accept, and they would soon be collecting a lot of gravy.

Consider this: Nobody seemed to care when the Democrats robbed seniors of their original well-endowed social security fund to pay everyday bills. Consequently, I refuse to entertain that seniors need to consider this in a restitution plan. The government spent seniors' dollars fraudulently and caused many seniors over the years to lose their homes. Check the records and you will find it.

My plan is to make the yearly COLA correct and very quickly. For three consecutive years, my recommendation is to suspend the calculation of the CPI-W. Instead, I would ask President Trump to order a makeup COLA of 10% with that 10% paid twice, once every six months in each of those three years.

With this process seniors would get gobs of dollars additional in their checks every six months that they should have had before being made poor by the BLS. They would even be able to get their grandkids Christmas presents again like before the BLS started to steal from them.

As a senior myself, getting such an influx of cash (10% COLA twice a year for three years) after being stiffed for so long, I would recognize that the government was ready to make it all right for seniors.

So, after this seniors would get back a major proportion of that which was fraudulently stolen by the Democrat backed BLS and the SSA. Why not be happy if you are a senior?

Seniors would get 10% increases twice a year with no calculators needed. Fire the government bureaucrat calculators and the consultant coffee breath professors in academe and use the savings to help the treasury fund the senior restitution program. That is not all that is needed, however.

Instead of any version of the CPI dash—such as -W, -U, -E, or the totally bogus dash Chained-CPI, designed to stiff seniors, the BLS should be ordered to fire 90% of their workers who had worked solely on SSR issues. They had purposely made life miserable for seniors.

The BLS organization needs to be forced to go back to the simple days of the market basket. So, after the three-years, twice a year 10% payment make-up deal, life from the BLS can go back to a better normal for seniors. How about a real cost of living based on a real inflation rate. Who would not want that? Bring Shadowstats from the late Walter Williams organization as paid consultants for five years to set up an enduring COLA and SSR payment system that keeps seniors at or a peep ahead of the real inflation rate. n

There would be no need for any of the hocus pocus CPIs that have screwed seniors for too many years. Just use the inflation rate of 50 market basket items with the Seniors Administration doing the oversight and Shadowstats as the consultant team so the bureaucrats are never emboldened enough again to try to trick seniors out of their true cost of living bump. If necessary, let's take names.

To be sure the CPI calculation is correct without extra influence by a deep-state version of the left-behind BLS, the new honest BLS must be monitored by the Seniors Administration using easily purchasable statistics from Shadowstats and the Chapwood Index. BLS and the Social Security Administration should never be without major oversight. We have seen first-hand the harm they can do.

The CPI dash nothing, which are also Shadowstats notions must be continually evaluated by fair minded presidents such as Donald Trump and after 2024, the next president and then the next, etc. The objective of course would be to assure a cybernetic system in which renegades and rogues cannot mess with the rights of seniors to receive a true inflation based COLA. The annual inflation-based increase should have nothing to do with calculations intended to diminish proper recompense.

That sounds simple does it not. The Congress could do this in an instant and the right president would sign properly written legislation. My view is that the legislation should be one or two pages or less, not more. Whichever party proposed such a bailout for seniors, in my opinion, would be in power a long time. I sure hope somebody presents this notion to Congress and the current President in the White House soon...please!

The *Medicare for all Party* that I suspect would not be in contention for many House or Senate Seats in future years, would be expected to vote against seniors. Consequently, if seniors ever want to achieve their true recompense from the government, it stands to reason that it should be many, many years for the smart American people ever entrust their government again to goofy Democrats.

There is no doubt even in Congress today, that Social Security's COLA needs fixing. But what that fix would look like, or when it would take shape, would be anyone's guess. I sure hope my recommendation gains some weight and preference.

There is no way that the ship can make a 1940 dollar's value with real inflation the benchmark as that bird has flown away a long time ago. But the 10% twice a year for three years would get seniors out of the poorhouse. To make sure the proposal I outlined above ever happens, the major expediting factor would be for seniors to stop being legislation watchers, but instead become vocal. My suggestion for seniors is to schedule meetings and conferences and keep the cards and letters coming to Congress.

Social Security is a godsend to the nation's elderly but that does not mean that seniors should forgive the Congress for the fraud in the CPI-W calculation for so many years. We have proven the case already in this book. So we first need to bring most seniors out of poverty with the three years of 10% twice a year COLA bumps.

But that is not all. We all know that Democrats want to spend \$6 trillion this year alone on pork. None of the pork, however, is intended to help seniors. It just demonstrates that there is plenty of means in government printing or whatever to create funds for "important causes" out of thin air. I would rather give it all to seniors than to have the cash go to pork projects for politicians.

Considering that this \$6 Trillion is twice as much as what is left in Social Security's infamous trust fund, clearly a government that would take \$6 Trillion for pork could afford to pay seniors back for the fraud perpetrated by not using the true value of a dollar as a yardstick over the years. There should be no measures taken such as the 24% benefits cuts because some pencil pusher thinks would be needed to save the system of the IOUs ever go to zero.

Since most rich people make money that is of the unearned variety, they pay no SS tax on it. That needs to be fixed. How you make your money over a certain amount – say \$500,000 should not matter. It should be taxed. Additionally, there should be no cap on the amount of earnings taxed for social security. These two measures alone would do wonders to bolster the SS fund by as much as \$2 Trillion per year.

The other idea never discussed is that the government has stolen much of what would be much larger current payments from SSR recipients by not calculating a fair cost of goods (inflation). So, seniors are due a ton of money from the government which actually still cheats seniors by shortchanging their COLA each year.

Whenever the mythical fund, stuffed with un-collectible IOUs (Federal Treasury Notes) gets to zero, the payments to seniors should not be reduced. Instead, the checks should come out of the

general fund and it would take at least 100 years for the government to pay back seniors for what it has stolen from them. Let the government figure out how to get the funds to pay back seniors. Seniors should not pay to have seniors reconstituted. That makes no sense.

I am not for means-testing Social security benefits. My dad always said social security is for retirement with dignity. But if means testing ever is determined to be the best way to collect welfare payments from the rich then Chris Christie, when he was a presidential candidate, did outline one of the best and simplest plans I have seen.

Before we get to that let's consider that The most an individual who files a claim for Social Security retirement benefits in 2021 can receive per month is: \$3,895 for someone who files at age 70; \$3,148 for someone who files at full retirement age (currently 66 and 2 months); and thirdly, \$2,324 for someone who files at 62.

My suggestion before we get into Christie's is that we encourage rich people to quietly and not publicly donate their SSR checks to the SSR fund. Let's leave it at that.

We know that even the richest Americans can qualify for Social Security retirement benefits. Even though they don't need the extra income, social security is not a welfare plan and seniors do not want to receive welfare from anybody unless they need it.

Billionaires and less can qualify for Social Security benefits when they reach age 62, and many of the richest Americans are currently collecting a monthly Social Security check that they really do not need for sustenance. I think it would be good for government to create a compelling argument for these people to donate their SSR back to the SSR fund. It is that simple.

If we ever decided to make Social Security (SS) a welfare program and I would be against it because there are better ways, the Christie plan is simple as a way to save dollars for the sustenance of the IOU fund. Here is what Christie said:

"I propose a modest means test that only affects those with non-Social Security income of over \$80,000 per year, and phases out Social Security payments entirely for those that have \$200,000 a year of other income." He also added the qualification that these proposals would not apply to people who are currently old—if you are already collecting in other words, you would continue to collect.

Raise the income cap for SSR

Among the many ideas put on the table to strengthen Social Security, none has garnered more popularity with the American public (via surveys) than raising or eliminating the maximum taxable earnings cap associated with the payroll tax.

Social Security's 12.4% payroll tax on earned income is unquestionably the program's funding workhorse. In 2019, almost \$945 billion of the \$1.06 trillion collected was derived from the payroll tax. Take note that while the self-employed are responsible for the full 12.4% tax, workers employed by a company or someone else split this payroll tax liability with their employer. Thus, most workers only pay 6.2% of their earned income into Social Security, with their employer also covering a 6.2% share.

The catch is that the payroll tax only applies to earned income (that's wages and salary, but not investment income) between \$0.01 and \$137,700, as of 2020. This \$137,700 figure is what's known as the maximum taxable earnings cap.

The year-over-year percentage increase in the National Average Wage Index dictates how much the tax cap will rise each year.

Approximately 94% of working Americans won't earn \$137,700 in wages or salary this year, which means they'll be paying into Social Security with every dollar they make.

Comparatively, the roughly 6% of workers who will top \$137,700 will see a portion, or perhaps the majority, of their income exempted from the payroll tax. Between 1983 and 2016, the amount of earnings exempted from the payroll tax roughly quadrupled from north of \$300 billion to \$1.2 trillion. That is a lot of shekles.

Thus, raising or eliminating the payroll tax cap is a means of taxing well-to-do workers in order to generate additional income for Social Security.

I would like to help others run for Congress. I hope they would want to be fair and honest. I think all seniors should send in their cards and letters. To me, a lot of impact would be if a constituent said they had had enough and were ready to write about running for Congress themselves in a nicely penned letter to the editor in the home town paper.

The point for seniors is that real inflation rate is anywhere from 6% to 9% (splitting the difference of Chapwood and Shadowstats at 7.5%). In recent years, three of five elderly Americans get a portion of their sustenance from the Social Security Fund. Unlike welfare, which was enacted by Congress to take dollars from the treasury to give to those deemed needy, Social Security is not an entitlement. It is contributory.

The system was set up so that most Americans would earn themselves a retirement benefit by working hard for decades before they were permitted to retire with dignity and begin collecting their due pension from what was then a huge Social Security Fund.

The idea is that when seniors do hang up their work gloves for good, there's a good chance they'll be collecting in some form from Social Security. Of the 60% leaning on the program, they will be receiving about half of their income from reliance on Social Security in some capacity to make ends meet. It is what it is.

Americans would have to be living in Space or the Twilight Zone to not have been introduced to the fact that the program is facing hardships like never before. The biggest challenge since its inception, according to the Board of Trustees report is that this important program soon will expend more than it collects in revenue each year.

How Social Security got into this bind is often a source of contentious debate. However, one avenue of blame almost always leads to the Lyndon B. Johnson administration.

Did President Johnson Steal SSR Funds?

Back in 1968, President Johnson made a change to the presentation of the federal budget, choosing to include Social Security and its trust funds. This created what was known then as the "unified budget." With this, many economists found that there was a good chance that SSR funds were mixed with regular treasury funds to handle big expenses such as the Vietnam War and the War on Poverty.

1969, the height of the Vietnam War was the first year that Social Security and its trust funds were presented "on-budget" with all federal spending.

Americans believe Congress raided SSR

We'd be lying if we suggested that Americans think Congress has managed the Social Security Funds judiciously. Quite the opposite. A big concern among many Americans is that the Democrat tinkering with on-budget and off-budget approaches while juggling huge SSR balances permitted the federal government to comingle funds from Social Security's trusts and net cash surpluses with general government spending. In essence, there's the belief that Congress raided the Social Security trust funds to finance government activities, ranging from education and healthcare to the ongoing Vietnam War. Do you trust the government? Think about while you read the rest of this book.

To be more specific about the SSR cash fund story we have discussed, the rest of the story is that they're currently loaned out to the federal government, as required by law. Yes, the treasury does get its hands on SSR cash—all \$2.9 trillion of it that has been built up since its inception. It is not sitting in a vault collecting dust.

Instead, the Feds are using it. They borrowed this money by selling the Social Security Administration (SSA) special-issue

bonds, and they do use it to fund various line items in its general budget. Some folks strongly believe that if the federal government paid back what it has borrowed, with interest, Social Security would be just fine and not facing any long-term problems. Do you trust your government?

Government bureaucrats call this wishful thinking. I find it very plausible and it would take an awful lot for me to believe the central government is not responsible for any shortfall that may be projected. Seniors should not ever be forced to pony up to make up for what the feds stole from Social Security.

As the mainstream Democrats kowtow to cultural elites and financial institutions, turning their backs on the workers and middle-class that defined their constituency for much of the 20th century, it is up to us to pick up the slack and fight for the rights of everyday Americans. We cannot afford to trust the treasury department to do it for us.

When SSR was enacted, the president promised full dollar value throughout the years in order to ensure its passage in 1935. We cannot let this be undermined by the likes of Chuck Schumer and Nancy Pelosi.

Many Americans are concerned that the Social Security program itself may not be able to sustain itself while others see the government cheating on the cost of living increases (CPI) thereby predetermining a life of squalor for seniors.

All successful societies throughout the ages, have maintained respect and dignity for their elders. Not only is cheating seniors a moral failure, it is a sign of a civilization entering an era of decay.

While seniors are losing their homes and many, for want of bread and milk, are on the verge of heading to the proverbial poorhouse or worse—the clutches of the Grim Reaper, Congress in 2018 pretended to care, giving a 2% raise, but then quickly snatched it right back in the dead of night via a Medicare Part B premium increase.

This additional Medicare Part B charge for necessary health services for seniors was excluded from the cost of living calculations. How could Congress have missed that? They pulled a repeat performance this year again for 2020 yet it was worse—just 1.3%.

Thus, to pay Medicare part B, seniors were forced in this past year, to use their “generous” 2% raises, rather than to offset the costs brought forth from inflation for which the 2% was intended. Since the real inflationary cost increases were closer to 11% using the popular non-government indexes, that means that instead of 9% that seniors were to endure, they accrued a full load of 11% in price increases. It’s easy to understand why this constant drainage of resources is unsustainable for a senior citizen. More and more are forced to go to welfare or give up as their homes are foreclosed.

It is my contention that Congress must pay this back to seniors. There is a lot owed. Even three of semi-annual 10% COLA bumps (6 in total) as I recommend will not pay back seniors all of what has been stolen and thus what is owed. However, it will place seniors on a positive road to the future.

After the first three years, the payback period would be over. Then, real market basket price inflation must then be used to calculate COLA—no more estimates. This is money owed to seniors. It is not a gift or welfare of any kind. It should have no impact on the government’s ability to create a way to fund social security for the long haul

Think about it. The big argument against the SSR fund ever going bankrupt is that Congress would never allow a huge cut to Social Security benefits in light of the program’s popularity and the importance of benefits. Even if the trust fund were to run dry, lawmakers would simply make up the difference out of general revenue. We know that. They are politicians.

Why has Congress not fixed the CPI-W problem?

Given the fact that almost every analyst knows Congress would not permit the impact of a cut in SSR benefits, how can Congress give 1.6%. When the cost of living is really 6% or more, how has Congress gotten away with giving 1.6%? It is simple. *Subterfuge*. Most seniors do not know they are being stiffed. That's why I wrote this book?

Picture government bureaucrats and coffee breath professors from academe as consultants. They go into a room with the objective being to stiff seniors and add dollars to the general fund. They dust off the prior year's methodology and figure out how to take a few extra bucks for Uncle Sam. They agree that their numbers are good and then; they set a low expectation level with some leaks and finally announce an almost zero number and call it the new CPI-W for the next year. That's what we see. It is all lies.

I regret to say that this method of continual lying is very effective and was used by Germany in its darkest days during the big War. Here is the methodology used by Wartime Minister of Propaganda in Germany, Joseph Goebbels. It is very scary. Our own government now is using this method and that makes it even scarier:

Think about this. "If you tell a lie big enough and keep repeating it, people will eventually come to believe it. The lie can be maintained only for such time as the State can shield the people from the political, economic and /or military consequences of the lie. It thus becomes vitally important for the State to use all of its powers to repress dissent, for the truth is the mortal enemy of the lie, and thus by extension, the truth is the greatest enemy of the State. Think a little longer. Is this what you see?"

This year their number is 1.6 % while Shadowstats says true inflation is approximately 6% while the Chapwood Index says it is over 9%. And, so the CPI-W is a rip-off for seniors of 500% to 700% and our government is not open about it. They instead

pretend their calculations are truthful but we know they are not. My one-time adjustment over three years and then using the real cost of living will solve this problem forever as long as we have a Seniors Administration assuring that the government stays honest.

To repeat the solution, seniors would get 10% COLA for three straight years, twice a year. So, after six, six-month COLAs, followed by receiving the true inflation rate as an annual cola after the third year, life for seniors would be better. All of the government bureaucrats in the BLS hoax and their coffee-breath assistants in academe could be laid off or fired.

And, so, to repeat, from year four onward, the *actual inflation rate*, not the CPI-W, CPI-U, CPI-E, or the Chained CPI would be used henceforth to calculate a proper COLA for each senior's payment to be of constant value from year to year.

How did we reach this point?

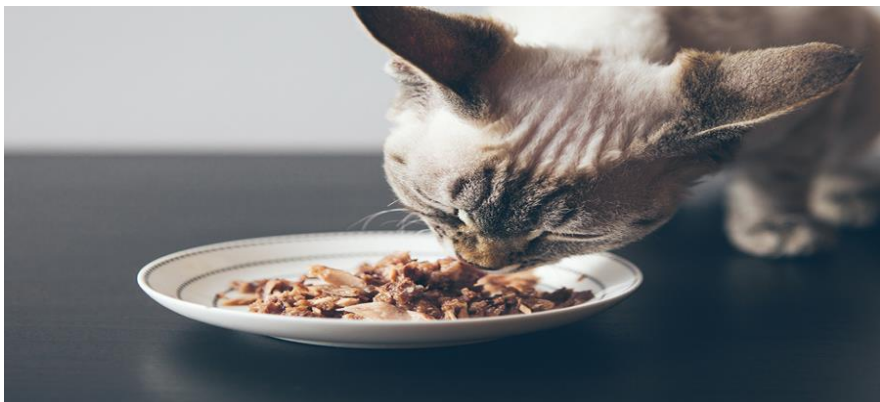
Early in the administration of disgraced former Democrat President Bill Clinton, an economist named Michael Boskin, and Alan Greenspan, Chairman of the Board of Governors of the Federal Reserve System, devised a scheme that would allow for market basket “substitutions” to artificially lower the cost of living and result in lower payments to our oldest Americans. It was a scheme to purposely stiff seniors from ever achieving a true cost of living COLA again.

These guys found value in having senior citizens help save the big government money. Prior to their involvement, the consumer price index (CPI) was measured using the cost of a fixed basket of goods, a fairly simple and straightforward concept.

The identical basket of goods would be priced at prevailing market costs for each period, and the period-to-period change in the cost of that market basket represented the rate of inflation in terms of maintaining a constant standard of living. That was self-evidently

fair and reasonable, and predictably resulted in seniors receiving annual COLA increases in tandem with the prices of goods actually increasing.

But Boskin and Alan Greenspan argued that when one item in the basket, for instance steak, became too expensive, the consumer would substitute hamburger for the steak, and that the inflation measure should reflect the costs tied to buying hamburger rather than the steak. Eventually, it became OK for the bureaucrats to replace hamburger with less expensive tuna and eventually because the protein value was the same, the price of cat tuna replaced regular tuna in the market basket.



The Bureaucrats like to tell observers that seniors did not have to eat the cat tuna, but their basket costs would be the same if they did.

In simple terms, the government began to play games with Social Security's annual inflation adjustments. It was intentional. To further obscure the true cost of living, other items were selectively removed from the basket when the prices were high and then reinserted when the prices were low. The objective was to save the government money--not to make sure that things were fair for elderly Americans. Shame on the bureaucrats!

Over the years, many people have been familiar with this ruse. For example, an economic commentator named Barry Ritholtz joked that Greenspan's core inflation metric can more accurately be described as "inflation ex-inflation," meaning inflation after all of the inflation has been excluded. This demonstrates that the deception of seniors has been intentional, and it continues with a new notion called the chained CPI that would cost seniors even more. We need a president and a Congress to get this back on track.

The fact is that government has deceitfully stolen directly from the pockets of our beloved seniors by denying them a fair cost of living increase—just to stay even. Some have even suggested that the government believes a natural limit exists so they won't get caught in their ruse. They think they will get no criticism because over time, many of the complainants will be silenced by their deaths when they can no longer afford to pay up. Charming thought?

Walter J. Williams, an American blessing who operated the Shadowstats site until he recently passed away, demonstrated that seniors have been stiffed by much more than just 125% and in fact should be receiving more than 4 times what their dollars were worth in 1980. That's \$450 instead of \$100.00.

Any senior would love to have even a small proportion of that loss back. Government lies cost \$350.00 since 1980. But nobody will

ever see that and even great representatives, are not telling Americans that it is happening. They lie even to their loyal constituents.

I hope I have convinced you all that seniors have been ripped off and are being ripped off financially all the time by their own government. Congress is the real culprit.

A gradual remedy for seniors, since it would be difficult to give seniors the proper increase immediately needed to offset this total quagmire caused by government malfeasance over many years, my recommendation would be to approach it gradually, in a way that seniors would be somewhat pleased, and be able to live out their golden years in a much more dignified manner. SSR Benefits Raise 2018/2019 was a net of zero

FYI, there is no official abbreviation for social security or social security retirement. Therefore, in this book as noted previously, we choose to use our own abbreviation *SSR* to mean social security as well as for social security retirement. As many know, the German Army in World War II commandeered the term SS and, so we will stay far away from any negative connotation by staying away from that abbreviation. Think *SSR* for Social Security Retirement.

When President Trump was inaugurated in 2017, the paltry increase from President Obama's last year in office was 0.3%. That is .003 for those like me who want to really know where the decimal point is. It was the smallest non-zero COLA ever given and many wondered if Obama felt he could really afford it. What a miser.

I don't think that President Trump intended to slam seniors like Obama did; but they got slammed nonetheless. Obama's last approved COLA increment was implemented by the newly elected President Trump. Seniors who think this President does no wrong are now hoping he sees what happened throughout the Obama years and about thirty-six years before, and that he adjusts things retroactively soon to where they should be awful close to being correct. No senior should have to miss a wholesome meal because their government has cheated them.

The potential benefits increase for millions of seniors in 2018 for 2019 was expected to be larger than usual to make up for the past abuses by government in calculating the inflation rate. After Obama's almost-zero last rate at 0.3%, President Trump's announced the rate at 2%. Admittedly this was about six times more than the 4 bucks (.03%) raise per month in Obama's swan-song last year .

But it still did not make up for the actual inflation rate's impact on seniors' income. President Trump did not focus on seniors as he had a big mess to clean up plus Democrats were making it difficult all the while for him during his tenure as our president. To the rest of the Country, the Trump era was the bringing in of prosperity that had been absent for at least eight years. But, as we have pointed out in this book, not everybody was gaining. “In effect, this means that increases in Social Security benefits were minimal, for a fourth year, for many people, putting them in a bind,” said Mary Johnson, Social Security and Medicare policy consultant at the senior citizens League in 2016. In a new study, her organization estimates that seniors have lost more than one-third of their buying power since 2000 as Social Security cost-of-living adjustments have flattened, and health care and housing costs have soared.

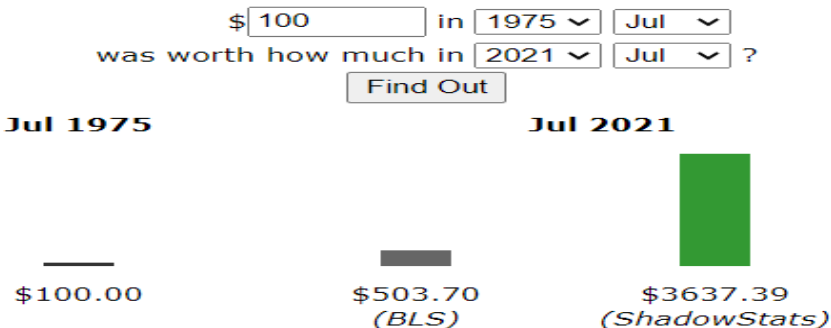

Also on that same "line," you can see when you look really hard that to get this calculator to show the 46-year inflation value from 1975 through 2015, I typed in \$100.00 for the value of the money in 1975. The CPI total of \$503.70 is the amount that \$100 was worth in August 2015 about forty six years later. The value of money never stands still. This is about a 500% difference. The government bureaucrats and the coffee-breath professors under contract, cost seniors at least this much as they committed fraud that was OK’s by the US government. 3679.39 is how much the real inflation rate would make that same \$100.00 over 36 times more value.

CPI has become a political tool

We have already learned that the late Walter J. To be sure, we must reform it, root out the fraud, make it more efficient, and ensure that the program is solvent. Same goes for Medicare. Again, people have lived up to their end of the bargain and paid into the program in good faith...Of course they believe they're 'entitled' to receive the benefits they paid—for they are!"

Will Congress Ever Fix the CPI Problem?

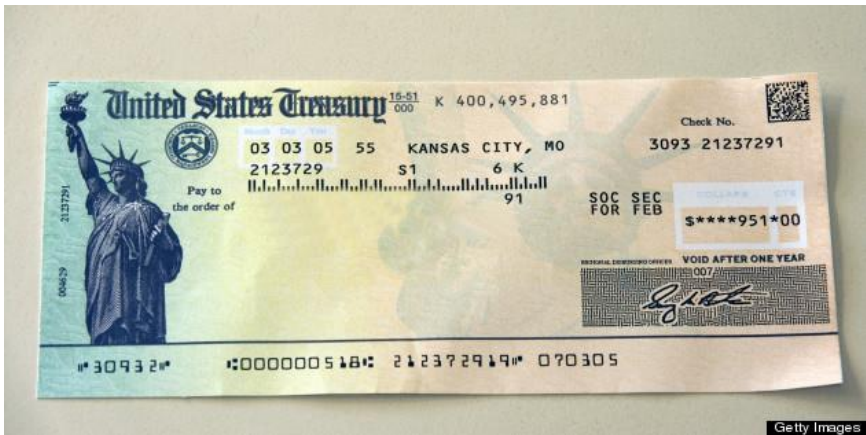
Even financial experts say Trump's call to reform Social Security does have some merit.

"Surprisingly enough, Trump's few comments on Social Security could actually be the start of an effective overhaul," says Chris Carosa, a retirement specialist and author of the book, *Hey! What's My Number? How to Improve the Odds You Will Retire in Comfort*."

It all starts with not cutting benefits to those within 15 to 20 years of retirement -- i.e. those 50 and over -- something only Trump is adamant about."

Social Security prevents approximately 26 million seniors from falling below the poverty line each year. When anybody, especially a senior on just SSR, is on a fixed income—that right now is a mere \$14,000 per year on average, there is no provision to deal with the ever-increasing costs of healthcare, prescriptions, and housing. And so, this creates a situation that breaks the promises made over 80 years ago when social security began.

Can the US afford to pay for seniors to be OK?

First of all, the government needs to give trillions of stolen dollars back to seniors. Please do not ask again about whether the government can afford any solution to the senior crisis with COLA and Social Security. Government can do whatever it chooses. Think about the current Democrats in Congress thinking they can afford \$6 Trillion for pork. That tells you they can rescue seniors from the COLA fraud and pay them back for the money the government stole.

For example, in recent years it stole a whopping \$16 trillion from the treasury to pay off the big banks in the financial crisis right after Obama became president. Did the big banks ask where the money came from? No way! Seniors should not care either. Government has a million hideaways where it has more than enough to effect any solution to the senior crisis that it wishes.

Government can do whatever it wants and there is no excuse for them to not pay back seniors for raiding their social security fund

and for stealing from individual seniors each and every year in the past thirty-six years.

Take note dear seniors that the US Treasury owes 65 million seniors over \$2.5 Trillion dollars for major fraud committed over thirty-six years of cheating on the COLA. A few pennies a year per person per month really do mount up.

The authorities stole the money from seniors with no permission granted. Since at least from 1983 on, through the BLS bureaucrats and the contract-based coffee-breath professors, the government has been systematically and intentionally cheating seniors based on BLS-generated bastardized price indexes. To say the indexes released as the truth were fake, would be an understatement. The theft was so brazenly fraudulent that some of us are surprised that the government hasn't tried to pay us back with three dollar bills.

If this deception had not been perpetrated by the US government itself, it would be a crime punishable with a real sentence. That means that a lot of bureaucrats would be going to jail if life was fair.

It is tough to calculate the exact amount of dollars seniors have lost from this ruse. I have my own estimate. The Chapwood Index (chapwoodindex.com) gives us a good starter estimate of the total cost to seniors as they posit on their web site: "It is estimated that between 1996 and 2006, this reconfiguration of the CPI saved the US government over \$680 billion." What does this mean? For one, it means that over a 10-year period, the government stole \$680 billion from seniors. Considering that the miscalculations have continued for over thirty-six years, not just ten years, from 1983 to today, we can estimate the total cost.

Since 1983, according to the highly respected Chapwood Investment Group, the government has been artificially deflating the CPI to keep COLA figures for Social Security as low as possible. The government's CPI readings you see published today no longer represent the real out of pocket expenditures incurred by most Americans. It's been wrong for thirty-six years with the 1.6%

announced in October 2019 and the 1.3% from October 2020 were the 36th & 37th straight corrupt pronouncement.

The government has not ceased nor desisted in this transgression and continues to perpetuate this continual scam on the public to this very day with impunity. Very simply, the government has committed a fraud upon the people. The results of its calculations are bogus and for thirty-seven- plus years at least, they have cost seniors their annual opportunity to break-even on inflation as required by President Roosevelt's Social Security Act.

Among other tricks used to fleece seniors is the use of what is known as the corrupt baseline CPI (consumer price index). It excludes items such as taxes, energy, and food; which are not only necessities, but also often a majority of everybody's daily expenditures—especially seniors. Of course I am not suggesting that those other than seniors require no food. When food prices go up as they have for years, we know it hurts our budgets.

As previously noted, the US government saved \$680 billion using fake measurements in the ten year period from 1996 to 2006. Who lost these dollars?—mostly seniors. The total period in question, however, is from 1983 to 2019—36 years. If ten years=\$680 billion, then 36 years, assuming an even straight-line flow, would compute to just about \$2.5 Trillion in lost inflation recompense dollars--mostly by seniors.

The purpose of the above exercise was to factually answer the question posed at the beginning of this chapter.

Can the US afford to pay for seniors to be OK?

Since every senior has been cheated every month for the past 36 years, and those seniors total approximately 65 million people, there is a big cost for the government to repay the full amount of its dishonesty. For seniors, not to be hard hearted, but that folks is not our problem. If the government did not expect to pay seniors back, it should not have stolen from us in the first place. Any fair

court in the country would give us the money we deserve with interest.

The estimate above is \$2.5 trillion. It is possible that the total is off a bit as it is an estimate based on incomplete work by the Chapwood Investment Group. But, I'll bet Chapwood and Shadowstats know the real number and I would make a bet it is more than \$2.5 trillion.

Through my request, which I have repeated several times in this book, seniors are not asking for every dollar stolen to come back with interest. We are asking for less but it will be an amount that will make a major difference in the lives of most seniors. Those who are well-to-do-and choose not to receive the recompense may request that they not be included with our thank you's, of course. I would encourage those who do not need to take this, to let those that need it be the beneficiaries.

The amount confiscated at a 5% to 10% rate each and every year for 36 years from seniors without permission is enormous. In 1983, thirty-six years ago, about 40 million seniors collected Social Security payments. This year, the number is about 65 million. To know the extent of the theft from all seniors, you would have to take the fraudulent COLA given from the proper COLA that should have been given and multiply it by the number collecting. Like I said, it is an enormous number. That is why we rounded it all up using the Chapwood index using a ten year period from Chapwood as our base. That number is \$2.5 Trillion.

My point is the US stole this money dollar by dollar, payment by payment, year by year times the number of people cheated. So, as you can see, not only can the US afford to pay what is due, it is not a choice. It is recompense for a theft by the government of extremely large sums of money taken a couple bucks at a time. Nobody expects seniors to fund the government.

The United States cannot afford *not* to do what is right. This is America! If we could afford to give the biggest banks a \$16 trillion bailout and we can afford \$6 Trillion in the Democrat pork budget in 2021, we can afford to fix social security and give seniors a

make-up payment that lets them keep their houses and keep them out of the poorhouse. You remember the big bank bailouts around the time Bush was exiting and Obama was taking the oath. What is owed seniors is a very small percentage of that.

There are lots of other ways to pay for a recompense for seniors, but first the government must accept publicly that they (what's that proper word that can be used in place of screwed) seniors for so many years, many seniors forgot they were getting it handed to them.

The noticeable symptom for seniors was that all of a sudden after years of cumulative thievery by the government, seniors could no longer keep up with their expenses. This would not have happened if constant dollars were used as promised in the legislation. The government cheated—plain and simple. they could not keep their hands off the people's money with which they were entrusted.

Lots has been written about the government's money (our money) bailing out corporations and big banks. Petrino DiLeo on September 7, 2011 after the bailout notion was really settling in and somehow was accepted, wrote how Wall Street banks are still not finished raking in taxpayer dollars. This paragraph gives his perspective:

“While the media focused on the Washington charade over raising the federal debt ceiling and cutting the estimated budget deficit, a “a one-time audit of the Federal Reserve released in late July” showed that the Treasury Department and Federal Reserve Bank have doled out an incredible \$16 trillion in assistance to financial institutions and corporations in the U.S. and around the world.”

Did anybody ask where that money came from?

Seniors should not even try to tell the government where to get the money to make the pay back. The money guys in the government already know where to find it.

If somebody says we cannot afford to assure that seniors can lead lives in which the poorhouse is not a constant threat, please tell them to remember the promise of Franklin D. Roosevelt about constant dollars for those collecting Social Security. Certainly not one dollar should be paid in welfare to illegal aliens if ever, until seniors receive their rightful benefits back pay.

I have confidence that OMB Director Mick Mulvaney is as sharp as a tack. He is so good with numbers, he can look everywhere to find a way to make seniors whole and like Trump says, make the benefits means tested so that billionaires do not collect unless they insist they be paid. Then we publish their names. We can afford making senior citizens on SSR whole again; and we must. We're smart enough to get the job done.

Today's Social Security dilemma began after Lyndon Johnson permitted the SSR Trust Fund to be robbed to pay for his social welfare programs in the late 1960's.

Then sometime in the 1980's the dirtiest politicians in America colluded with coffee-breath professors in academe so they would not have to take the real cost of living into consideration when calculating the percentage increase in senior's benefits, AKA COLA.

They contrived notions such as CPI-U, CPI-W, and the Chained CPI—all schemes to reduce COLA and return dollars to the treasury from the backs of senior citizens.

All SSR recipients wanted was what Roosevelt promised. They wanted to be paid in constant dollars. None of the CPI machinations do that and none ever did that, and until the President and Congress orders the BLS to calculate inflation using the real market basket technique and not those invented to cheat seniors, the elderly will never get to ever see a constant dollar.

None of these BLS contrivances were intended to provide the true cost of living and /or the true out of pocket expense increases endured by senior citizens who were fortunate enough to that

point to be able to survive in America despite losing money each year.

Nobody in America other than the Bureau of Labor Statistics (BLS) and coffee breath professors in academe want this perpetration to stand, especially seniors who face record foreclosures and the terrible decisions about whether to eat or buy their prescription medicine. Government employees do not know the plight they have created for seniors. What would they do if they faced the threat of losing their homes or they had to scrape to find their next substantial meal?

I am sure the President and the few members of Congress who represent the people can handle the deep thinking to pull this reversal off in the right way. Remember, the dollars are owed to seniors. This is not a gift.

Maybe it would be OK if seniors were paid back more than needed but I am not suggesting that. The fact is these make-up COLAs of 10% every half-year for three years can certainly be paid from sources known only to the government.

I can recall as he ran for the presidency, then Mr. Trump said that the US had enough oil in the ground to pay off the national debt. My suggestion is to first take care of the cheated seniors and then go back and pay off the national debt. Why not? The government owes seniors much more than my recommendation for a proper payback amount and a social security system reset.

Going back to Trump's campaign braggadocio, it helps to remember that Donald Trump once said that he could pay off the national debt with the oil reserves that are in this country. Using new estimates that prove that the US has more reserves than any other country—at least 264 billion barrels, we are sitting on a lot of black gold with much of it on public lands.

I do not want to tap it today for the full seniors' payback. I do not care where the money comes from. However, I will not permit anybody who hates seniors to poor-mouth me about the US

running out of money anytime soon. And, please do not dare to say this country cannot pay back seniors for the involuntary sacrifice we made for over 36 years. Who was going to give the Democrats the \$6 Trillion in this year's budget? Take care of US seniors first.

From verified calculations, it is now fact that seniors on SSR are owed about \$4.5 dollars for every dollar in benefits received in their monthly e-checks. Seniors therefore receive \$3.50 less than due against each dollar they receive because of the inherent fraud in the new versions of the CPI as perpetrated by our very own national government.

Seniors are not greedy and therefore do not need to be paid in full all at once. A 10% per year COLA every six months three full years (six COLA bumps altogether before the SSR reset), would go a long way in getting seniors back on track. In my opinion, and by now it is surely your opinion also, this is a debt due from theft by government. It is not a gift.

The cost of providing Social Security benefits is huge at about \$900 billion per year. Providing a semiannual 10% make-up COLA for seniors beginning in 2021, and continuing to 2024 to start can be handled by a combination of cost savings and revenue from oil and from the great mind of a calculator like Mick Mulvaney. .

The oil reserve is a major bonanza. I have another way in which a \$Trillion per year can be saved in immigration costs but I would prefer to release the notes on how to do this when I put out my next book on how to solve the immigration crisis the American way. There is enough money to be saved on immigration to pay most of the senior debt.

My point is that there are a zillion ways to fund the senior payback. As an aside, with appropriate legislation, a 10% tax on oil extraction can keep Social Security going forever with seniors again being able to afford a nice steak every now and then and maybe even a Lobster Tail on New Year's Eve.

One of my objectives for the senior payback and the system reset is that seniors stop eating cat tuna even if the BLS and the coffee-breath professors in academe suggest it. Without a major action by the president (things can then happen overnight), our biggest problem seems to be that our politicians are not sure if they want to be honest or not. Seniors can solve that one also by not sending these scoundrels back into office.

If our politicians had the political will to do the right thing, we would not have to threaten their jobs. Unfortunately, politicians think they are above the people they serve, and remain reluctant to do the right thing. So, what should we do?

Can you imagine the savings we can amass when we discover that there are 60 million, not 11 million illegal aliens who live in America? If we cut off the funding for that other government boondoggle—paying the ride for non-Americans, there should be

a few dollars to not only pay back seniors but also provide some reparations—not that we are asking for reparations.

The thing that I would recommend for seniors to do after reading this book is to not just get out the bottle and have a few swills to calm down the depression. That would be OK, but after one day of swilling to drown the sorrows of the past, seniors must move on to the future.

We can solve this and make it work for us. Even bigger than millennials, we are the biggest singular voting bloc in the country with a ton of almost seniors in our on-deck circle—just waiting to collect their share of a pie that must not be made smaller by cheating bureaucrats.

The time for seniors sitting back, taking it on the chin, wringing their hands and saying *what can I do* are over. We must get energized; write cards and letters to our representatives and the president and write letters to the editor. Perhaps a few senior demonstrations would be good exercise for us all.

I am seeing more signs that something good can happen if we stay at it. For example, we now have Congressmen writing letters hoping to get other Congressmen to begin working on behalf of seniors

Here is a letter from Congressman John Garamendi (D-CA-3). The title of his public letter written to the Seniors League on April 30, 2019 is “Its Time for Seniors to Get a Fair COLA.” He sure is right but will his activity end with this letter. I hope not.

Social Security benefits and cost-of-living adjustments (COLA) specifically, have not kept up with inflation. Americans everywhere agree: Social Security is not an entitlement; it is a benefit that seniors earn through decades of work serving our nation’s economy. According to the Social Security Administration, approximately 63 million Americans received Social Security benefits in 2018, and of those 63 million, 72% were retired workers and dependents.

Garamendi notes that in 2017, seniors received a mere 0.3% COLA increase to their benefits. 2016 was even worse. For just the third time since Social Security was created, Americas seniors received no cost-of-living adjustment at all in 2016. However, in 2018, with Trump's first COLA, we saw the highest COLA in years: 2.8%. This is the largest increase since 2012, and we must continue this upward trend.

He went on to explain the CPI-W and how it is designed to stiff seniors. He noted that according to The Senior Citizens League, recipients of Social Security have seen a 34% decrease in their buying power since 2000. Other indexes say the loss is even greater. He also complains about seniors who are enrolled in Medicare Part B programs, having faced very large cost increases. He says it is simply unacceptable and that is why it needs to change. So, he is introducing the Fair COLA for Seniors Act.

This is a great idea for a start. Seniors, however, are already so far behind the eight-ball that they need action like I recommend in this chapter. Both a payback and a reset to an inflation-based system.

Garamendi says that it is unfair and unjust to expect American seniors to settle for a COLA that is less than what they have spent their entire lives working for. This is why it is critical to base COLAs on an index that reflects what seniors actually spend their money on. It is time for Congress to take action and give our nation's seniors what they deserve.

It sure is. Thank you Congressman Garamendi. Now, please go to the Congressional Cocktail Lounge and start talking to you buddies—both Democrats and Republican and go get something done for real instead of talking about it.

Chapter 13 Senior Solution Review: Pay Back the Big Rip-Off

Mike Huckabee as you may recall was the first brave Republican in the 2016 debates to complain when he publicly accused: *"illegals, prostitutes, pimps, (and) drug dealers"* of freeloading off the Social Security system He did not add *"with the permission of the Democrat Party"* but it would have been just as true if he had.

The government will not admit nor publish the costs registered in the SSR system that are caused by generous government workers out in the field certifying illegals as eligible.
