Dear First Lady of the Trump Presidency

I have several messages for you today. It is my first time writing you so I want to send a few messages. Thank you.

I am 76 years of age and I spent my first 24 work years after college with the IBM corporation. Then, I started my own technical consulting business and kept at that until the mid 1980's when I began to write books and publish them through many sources. I was published by Harper Collins / Ballinger, John Wiley & Sons, Cardinal Business Media, Midrange Computing and others before I signed up with Amazon. I published 262 books with Amazon and well over 300 books in total. I was beginning to have enough royalties with my Amazon books that I felt my career as a writer was becoming much more than my expectations. About 25 of my Amazon books had the name Donald Trump in the titles so Amazon knew I was conservative and they knew I was a definite Trump Supporter.

In retrospect though at the time I thought life was fair, when Amazon terminated my account in 2021, I believe it had to do with Amazon's concern for my conservative books and they obviously did not like all of my Trump books. I tried numerous times to be reinstated as at the time, Amazon had dropped all my titles and I lost all of what would have been a reasonable royalty income to keep me going. I sued them pro se (without a lawyer) because of the unfair treatment and their stubbornness on the termination.

A group of three AAA arbitrators ruled against my case. I learned then that life is not fair and Amazon is OK not playing fair. Thank God for my IBM pension and Social Security as life could have been even more difficult.

One of the tenets of my case is that Amazon would not permit me to be published by any publisher that had an affiliation with them. I had found a great publisher Draft2Digital where I produced about ten eBooks and hardcopy books. Out of nowhere they contacted me and said that because I was terminated by Amazon, they were not allowed to produce hardcopy books for me in the future and they were forced to delist those books that already had been completed and had been available for sale. In Arbitration, Amazon denied any interference with Draft2Digital yet, would not give me a short note to notify Draft2Digital or any other publisher like them that it was OK to publish my books for printing. Concerned that Amazon would punish them if they reinstated me as a hardcopy client. Draft2Digital said it was not worth the risk.

Just recently I decided to take all of my reasonably current books (several hundred) and offer them to the public for free downloads. You can see these books at my site itsfreebooks.com. I sent a note to winningpublishing.com to see if this Trump company would like to publish my Trump books or any other conservative books.

I know that you and your husband root for the underdog and that is why I am writing you. I sure am the underdog.

My most current Trump book is titled **The Greatest Man In Our time**. It was originally published by Xlibris at a time when nobody knew Barron Trump would be so tall.

As noted, I had over 262 books published with Amazon until September 2021 when Amazon terminated my account. I sued with no lawyer but as noted, unfortunately, I lost in arbitration.

So, I have a lot of books available for any publisher to put in their catalog.

Most are available for a free download at itsfreebooks.com. I hold the copyright for all my books. Here are the Trump titles followed by children's books that would be wonderful for a grandmother or grandfather to read to their grandchildren every night.


