Instead of helping authors correct mistakes that might be in the text, the Amazon reviewer seems to hide the specific issues they "found," hoping the corrections cannot be made.



Brian Kelly's Information for the Amazon Complaint

This chapter contains light information about the full Arbitration case against Amazon for its use of its massive monopoly power to block its author client base, specifically, in this case, Brian W. Kelly and his small company, Lets Go Publish!) v Amazon. Amazon KDP, who in many ways behaved in the proceedings as an incompetent bunch of goons. It was like dealing with a gestapo who did their best to prevent the truth from escaping from Amazon.

Amazon's action against Brian Kelly's sole proprietorship publishing company prevented me from enjoying my right of free speech as Amazon ignored the implied contract that was in effect since I began to use the services of CreateSpace, a wholly owned company of Amazon's from the 2016 time frame. By the way, Amazon bought out CreateSpace because at the time, CreateSpace was the best stop for independent authors and publishers who did not have the patience to be discovered by the elite industry publishers.

All went well between the parties until Amazon imposed its full control of CreateSpace after four years concluding in 2020. In 2020, Amazon began to exert what could be called a bully-monopoly power into the formerly CreateSpace's smooth operating business.

Amazon and the other Big Tech Oligarchs who are known to censor free speech by shutting down customer accounts in an act euphemistically referred to as canceling, do not act independently. Instead they serve as surrogates of what today might be labeled as the WOKE mob in concert with the Democrat controlled national government.

Scholars have referred to these exceptions as the entanglement exception and the entwinement exceptions of the First Amendment. They apply when private companies such as Amazon do the government's bidding. Do they receive anything in return? Of course.

The entanglement exception applies when an action to restrict speech by a private party is such that the state has significantly involved, or entangled itself, with the private action. This occurs when the "power, property, and prestige" of the government is behind the private action, and where there is evidence of the overt, significant assistance of state officials. In this case it is the cancellation of conservatives from Amazon and other Big tech services.

The entwinement exception applies when an action of a private party can be treated as though the action were of the government itself (i.e., overlapping identities). These exceptions are rarely used in free speech cases and apply in very limited situations, typically in cases involving the Equal Protection or Establishment Clauses which are not relevant in most social media contexts. Today many people cannot tell when the government has ordered Big Tech to behave in a certain way or they are restricting free speech on their own hoping to receives some government leavings.

As such, Amazon does the bidding of the US government, and thus their conduct fits within the scope of the Free Speech Clause of the First Amendment to the Constitution. I did not argue this in my arbitration case against Amazon because I would have needed a law degree to make my case on Constitutional grounds.

Well, here we are folks. Perhaps we are already in the future and the notion of free speech and independent thought have already passed us by. Or perhaps it is not too late for the world to get a grip and arrest control of our minds from the Big Tech Oligarchs that have surreptitiously stolen that ability from all of us, whether we know it or not. We stand at the threshold of a change that has the potential to become a disaster. Can unconstrained thought survive?

This lawsuit against one of the largest Corporate Big Tech Oligarchs – Amazon, Inc. if not the largest, was about much more than Brian Kelly, a small time publisher and Lets Go Publish! a small publishing company from Wilkes-Barre Pennsylvania. Amazon insisted that we go to arbitration and I lost the case because I did not know enough

This lawsuit and the issues it presents, seeking fair solutions was not resolved by the PA courts, not the largest courts in the land. Three arbitrators paid for by Amazon and Yours Truly paid these "jusges for their work. Amazon should be pleased but I am not.

In this case, I was well aware that behemoth Amazon was at an advantage but I thought my case was compelling. For the record, Amazon is not just forty times larger than Kelly's company. It is also not four hundred forty times larger than Kelly's company. Not Forty thousand times larger than Kelly's company. It's not four hundred thousand forty times larger than Kelly's little company, skipping a few increments along the way, the fact is that I could say- it is not forty million times larger than Kelly's company but that is pretty close to what the size difference is. For me, I admit today, it was a fools errand...

The following note to Amazon Content Review was originally sent on April 15, 2024, after Amazon terminated me "for good."

Dear Amazon KDP Account Review

I have not heard anything about this response last made on 5/16/2024. Have you received it? Thank you

I created another account at a friend's suggestion because I was advised it would work out now that there is no ongoing conflict between us. [The lawsuit and subsequent AAA arbitration has been settled and as you know Amazon's team of lawyers won a complete victory.] The book that drove me to creating a second account was a memoir which I needed published about my recently deceased sister. It was not anything that could be thought of as controversial.

In our resolved dispute, Amazon represented that it was not interfering and not planning to interfere with my relationship with third party publishers such as Draft2Digital. Because of the help I received to get this memoir book published, my siblings and other friends and relatives were able to enjoy the memories of our beloved family member. In addition to being my older sister, she served as a maternal presence for us both before and after the death of our mother.

Regrettably, she passed away on December 27th 2023. She would not die on Christmas for her own reasons. Instead, she delayed the inevitable for two more days for God to take her. It was the twenty-seventh of December when the nurse opened the windows up early that morning to let her spirit out as she was heading to the Lord. I was able to publish this book because I did so with my new account id of bwkelly@ptd.net.

I am not and never have been a plagiarist but, for a mostly non-fiction writer, it is tough to prove original work

I forgive Amazon for not believing that I had not copied the contents of any book.

I had sued Amazon to reclaim my rights and it took about a year to resolve the matter through AAA Arbitration. I hoped to have Amazon KDP reverse its termination decision which it had made. [Amazon claimed my book contents had portions that were freely available on the Internet but as noted, this was not true.]

Of course, as discussed above, we all know that facts in most good non-fiction books are available freely on the Internet. My plan was to be able to again create books and receive royalties from Amazon but the royalties were the least important notion. I had a good case but I was my own lawyer without a law degree and Amazon had the best lawyers. It was too much to expect that the AAA court of arbitration would see everything my way. In fact, unfortunately, as the verdict played out, they literally saw nothing my way.

So, unfortunately, I lost the case basically because I could not afford a lawyer. Despite not having to pay for a lawyer, the arbitration still cost me well over \$15,000 as Amazon insisted there be three arbitrators on the case which we both had to pay. Amazon paid the same amount to AAA as I did.

I had tried a number of small publishers to replace Amazon KDP after that, such as Draft2Digital (D2D), Xlibris, and Book Baby but none were as good as Amazon. Moreover, other than Draft2Digital, it cost hundreds of dollars for each book published.

Amazon clearly had the best offering. It cost nothing until a book was sold and then I would receive a royalty based on the sale price. I did not have to pay for publishing. Quite frankly, I miss that part of Amazon. It is great for authors

Draft2Digital had a similar financial arrangement to Amazon's for authors and I found them to be an acceptable replacement. However Amazon had a clause in its terms to which Draft2Digital had agreed. When Draft2Digital ended our print relationship, It cited that the Amazon terms stated that no terminated Amazon author (my status) could be a print client of D2D.


Draft2Digital still fears that Amazon can cancel their contract if they do not abide by all terms and so they want to be a good Amazon customer by adhering to the terms. They know they cannot afford being disconnected from Amazon. Since I had

been terminated by Amazon, D2D informed me that I had thus lost the opportunity to use them for my print service to create paperback books.

Draft2Digital's notification spelled out the reason as Amazons terms in their contract. They were forced to depublish and delist my titles and they informed me that they could no longer accept new print titles from me.

While I was looking for someone such as Amazon to publish, print, and market my books, a friend recommended that I simply create a new account with Amazon as B.W.Kelly and publish The Dear Dear Chronicles, the book I wrote for my sister. It worked and Amazon did a great job in the production of the book.

That is why it is so difficult for me to find myself in a terminated status again. It is a shame that there is not a way for even now for Amazon to choose to continue to at least market The Dear Dear Chronicles. Because of Amazon's termination of my account, my siblings, relatives, and friends now again have no place where they can purchase a Brian Kelly book, including The Dear Dear Chronicles.



After I bought a number of printed copies from Amazon from the B.W. Kelly account, as did several relatives, I also wrote a book about the Kansas City Chiefs. It was all original with no plagiarism but Amazon did not review it that way and they told me they were forced to block it.

I do forgive Amazon for thinking I am a plagiarizer but I am not. While I was making my arguments to convince Amazon that my work was original, I had more bad luck. My Internet Service Provider (ISP) who hosts my account had a systems problem and I could not send my prepared response to Amazon Content Review. It showed my intention to comply, to Amazon's demands as part of my account scrutiny.

In my response which could not be sent due to the system problem, I had written to the Account Review Team that I would comply with their wishes and do as they instructed in order to address my account issues. But my ISP's REPLY email function

would not work and thus, I could not reply. REPLY in my Web Mail account simply did not work. So Amazon gave up on waiting and eventually terminated my new account.

When the ISP fixed the problem, I was finally able to send my response to Amazon Account Review that I would comply to Amazon but their internal clock said my five days were up and about the same time, they terminated my new account. As I recall, it was the same day that the REPLY began to work.

On the first day that I began to write this particular entreaty, I appealed for the fourth time to Amazon Content Review and I also divulged that I had been terminated once before. Amazon appeared upset as they did not like this. In arbitration, the judges had resolved all of the issues so I thought I was OK.

Amazon KDP then informed me that they were deleting my work and they would no longer offer any of my books from any of my accounts for sale. In my return to Amazon as B.W. Kelly, I had about five books published. I had 262 books published several years prior as Brian W. Kelly (bkelly email).

My termination both times at Amazon was unfortunate and from my perspective, it was unwarranted. I did not copy from the Internet. My work was always original but I could not prove it though I tried.

When I sued in arbitration, because of my first termination, trying to get my account back and this time with the termination notice as received the day before I began this response, I was innocent both times.

However, I could not convince the Amazon Content Review Team that I had used facts from the Internet but that all of the writing in the manuscript was original. I never plagiarized anything in my manuscripts. I would take a lie detector on that.

New Perspective: What if Amazon KDP Was staffed by kinder, gentler souls?

Just suppose Amazon chose to permit me to come back and be reinstated as a KDP author. I certainly would like that. Moreover, I would be a different and an even better client.

For example, if Amazon wanted to block a book, I would not argue because working with Amazon KDP is a lot better than not working with Amazon KDP. With a new life with Amazon, I surely would not want to displease the content reviewers.

The second termination as of yesterday came about because I had composed a response to a book blocked by Amazon Content Review titled Great Moments in Kansas City Chiefs Football, 1960-2024.

Unfortunately, as noted, my email REPLY to the long address for Content Review would not work and it took more than a week for my ISP, Penteledata, to fix the problem.

Coincidental with my response stating that I would unpublish the book in question, I was terminated because Amazon believed I had not responded in time as to how I was going to handle my suspension. In this, I was a victim of circumstance. My goal was to be one of the best Amazon KDP customers of all time but I failed by circumstances. It surely was not my intention. I worked hard with Penteledata trying to resolve the REPLY issue.

My Amazon request is for a second chance.

I would like another chance. I would be pleased to be a model author for Amazon and together we can make a lot of royalties. If only Amazon KDP would give me another opportunity, the company would not regret it. I am a very good writer and I do not plagiarize my content.

My books are mostly fact based and unlike novels, I would expect all the facts in my books would be freely available on the Internet. The value I add, I argue, is my style of writing and the book formatting.

As previously noted, with my Brian W. Kelly account for over five years, I had written 262 books before being terminated several years ago. My dispute in this matter has been resolved for over six months now.

A fair action on Amazon's part would be to give me another chance or at least permit me to be published by third parties such as Draft2Digital. There is no reason to simply shut down my ability to publish books.

After several years of being estranged from Amazon, I would suggest that even if guilty which I am not, I have been punished enough and I look forward to working with Amazon KDP again if we can forgive each other.

I do forgive Amazon. I want this very much to happen because Amazon KDP is every authors best opportunity.

In the event that the Account Review Team cannot give me another opportunity because of the rules or some other good reason, I would ask for just one favor that would not cost Amazon anything.

In my recent arbitration which concluded with a complete victory for Amazons team of lawyers, I had asked for compensation and I had asked for Amazon to OK a Draft2Digital (D2D) reinstatement.

A look at the arbitration decision and you can see that Amazon won because their presentation said that it was always OK for D2D to have Brian Kelly as a print client. If Amazon simply tells D2D that it will not be hurt if they publish my books, that would

re-enable my career as an author.

Amazon's terms as previously noted caused Draft2Digital (D2D), a fine book publisher, who use Amazon services in the production of their paperback books, to drop my print account.

D2D is a great Amazon client. They had sent me a note that because I was terminated by Amazon that they (D2D) had to depublish and delist all of the paperback books (nine) that I had produced with them. They also said they could not accept any new print books from me. This has affected my family as now is not a good time in America to not be able to keep up with inflation

If I cannot be an Amazon KDP author, then I would ask again for Amazon to write D2D a short note telling them that they can resume publishing paperbacks for Brian Kelly. This would help me immensely and not cost Amazon even a dime.

This would put me back in the publishing business and it would help D2D to believe that Amazon would not punish them in any way for reinstating me as a print client.

As noted, Amazon's lawyers won this part of the arbitration against me by arguing (claiming) that they had no such policy and that D2D was never impeded by Amazon from serving Brian Kelly's publishing needs.

I have already shared the chief judges decision and rationale with the Operations Staff at D2D but that was not enough for them. They are still concerned about the possibility of being punished in some way by Amazon if they take action to reinstate me as a print client.

As noted, Amazon won the arbitration with great lawyers and I had no lawyer and obviously I had not convinced the arbitrators that my proof was substantial enough to win the case.

As the winner, I would ask Amazon KDP's Content Review Team or the proper area of Amazon to compose a letter such as the following and email it to Draft2Digital or send it USPS. Amazon has nothing to lose and I would have a new publishing life to gain if I can be reinstated.

Please send something such as the following to D2D's Operations Manager, Tara who is my contact for my attempts at D2D reinstatement, She can be reached by email at Draft2Digital Support <

support@draft2digital.com

I would ask that you respond to Tara with a note that states simply that Amazon KDP and Brian Kelly have settled their dispute and that Draft2Digital (D2D), from Amazon KDPs perspective, is free to resume their Print Publishing relationship with Brian Kelly.

This would help me immensely. Thank you for your consideration. It is most appreciated.

There is no reason for Amazon to keep punishing me no matter where I go to help my ability to publish books successfully.

Chapter 3 Author Solutions Requests to Amazon

This chapter contains a series of notes from Author Solutions, a company used by one of my other publishers, Xlibris. This began when my Xlibris rep told me that a book published by them was being sold by Amazon. However, I could not find it on Amazon when I looked.

Amazon prices are good so I asked them to see if they could get Amazon to distribute the book. I would have purchased some books from Amazon if the book were available. It took a few back and forth messages before Author Solutions gave up.

These notes, for example show that Amazon still inflicts pain on me, whether intentional or unintentional. Since I cannot talk to Amazon, I cannot discuss this issue with them so I hope they download this book and read my requests and the requests made by Author Solutions on my behalf.

As highlighted, this note is from Author Solutions regarding a specific book title The Greatest Man In Our Time by Brian W. Kelly published by Xlibris

Xlibris is a publisher that uses many distribution channels and they were hoping Amazon would distribute my recent book which I paid Xlibris to publish. This note is from Michelle Parsons of Author Solutions. This shows the effort Author Solutions undertook to help grant my request. Here are a number of the messages that surrounded this effort.
