While the oil and gas industry stands by the safety of the process that has been used for years throughout the country, the EPA is undertaking a \$1.9 million study to re-evaluate

The firm also continues to promote the idea suing gas companies might be a good idea with posts such as this one from last year (the substance of which is rebutted here by a wonderful example connected with one of the largest and most successful enterprises in Cartwright's own district).

So, who is Cartwright representing in his appeal to the EPA, which is an entirely superficial document that doesn't even make a specific request? It's obviously a show piece designed to reinforce the false ideas planted in his firms's own earlier lawsuit solicitation where he actually says fracking has been "exempt from government regulation."

What kind of fools did Matt Cartwright think his future constituents were when his firm issued that solicitation? Hydraulic fracturing and drilling are both subject to intense government regulation at the state level and Matt Cartwright 6

Matt Cartwright: Deliberately Ignorant



And, Dimock? Really, Matt? How many times does do the state and EPA have to prove the water is safe before you'll accept it? "EPA testing of water wells found no regulated pollutants exceeding federal limits," as one Bloomberg reporter correctly observed. How many lawsuits have to collapse for lack of evidence before you believe?

This is where things get really foolish, however. Congressman Matt Cartwright serves parts of Carbon, Lackawanna, Luzerne, Monroe, Northampton and Schuylkill Counties.



Crazy isn't it? Anyway, these six counties have received over \$2 million of money from natural gas drilling, despite the fact there is no drilling or fracking of any consequence occurring in any part of Matt Cartwright's district. If you thought that mattered, well, the Congressman says the April Fools joke is on you.

But, here's the rest of the story. Another specific project to be funded with natural gas development impact fees is the treatment of acid mine drainage from the Old Forge Borehole. The story is told in a superb Scranton Times article, excerpts of which follow:

Impact fees gathered from Marcellus Shale well operators will fund an effort to treat acid mine drainage from the Old Forge borehole.

At its board meeting Wednesday, the Commonwealth Finance Authority approved a \$1 million grant from the Marcellus Legacy Fund, made up of a portion of impact fees gathered under Act 13, the authority's deputy press secretary Lyndsay Frank said.

The award will go to Susquehanna Mining Solutions LLC, an entity created in 2011 and based in Hanover Twp., according to business filing documents from the Pennsylvania Department of State.

Chris Gillis, a local inventor affiliated with the corporation, said he plans to acquire land in Duryea Borough and build a treatment facility that will eventually be able to treat the entire volume of water flowing from the borehole into the Lackawanna River...

The Old Forge borehole was drilled in 1962. Every day, it dumps between 60 million and 100 million gallons into the Lackawanna River, providing an outlet for water that pools in a coal mine void large enough to hold a volume comparable to Lake Wallenpaupack.

The borehole is clearly visible on Google Earth. Upstream, the Lackawanna River looks unremarkable. Downstream. it's orange, leaving a noticeable streak in the Susquehanna downstream of the two rivers' confluence. The borehole is the largest point source of pollution to the Chesapeake Bay.

There's more here and here, but what's Matt Cartwright think about this? Well, a search of his website for the word "borehole" yielded no results. He's apparently too worried about non-existent groundwater contamination from fracking to pay attention to how it's cleaning up one of the worst cases of water contamination in the history of his district. John Chrin and redistricting

Laura Olson of the Morning Call spoke with John Chrin, who is running for Congress in PA, about the redistricting that went on in Pennsylvania in February 2018. This is her report from the Morning Call.

Republican John Chrin will continue his bid to challenge Democratic U.S. Rep. Matt Cartwright in District 8, despite being drawn out of the congressional district in which he had been campaigning since May.

Chrin, who bought a home in Palmer Township in November after launching his campaign in the 17th District, now lives in the new 7th District under the state Supreme Court's revised district map. Many people in PA are not happy with the mess the courts gave us as District Numbers are not something regular people are accustomed to having to relearn.

That congressional district (7th) includes Lehigh and Northampton counties and part of southern Monroe, and largely overlaps with the district that Republican U.S. Rep. Charlie Dent will be retiring from there at the end of the year.

By adding all of Northampton County into the 7th District, the city of Easton and several other parts of Northampton including Palmer Township — were removed from Cartwright's former 17th District.

Now called the 8th District, Cartwright's seat was consolidated into the state's northeast corner. It includes Wayne, Pike and Lackawanna counties, and parts of Luzerne and Monroe counties. Chrin's objective of course is to unseat Cartwright and give the seat back to the people of Pennsylvania.

An so, District 8, the new District 8, is where Chrin will continue his bid for Congress, he announced Tuesday morning.

"Whether the lines shift and the district is called the 17th or 8th are out of my control," Chrin said in a statement.

"District lines may change but people don't," Chrin continued. "In November, I will offer Northeast Pennsylvanians a choice between an out-of-touch Washington politician and a successful, self-made

businessman who can't be bought by special interests and is focused on bringing economic growth to the region."

Cartwright has represented the 17th District for three terms. He won by eight percentage points in 2016, while Republican Donald Trump topped Democrat Hillary Clinton there by 10 points. The new district boundaries shift the seat's geographic makeup, but appears to have a similar partisan breakdown, according to an analysis by the New York Times.

Chrin has made significant personal investments in the congressional race last year, loaning his campaign \$700,000, according to reports filed with the Federal Election Commission. His campaign spokesman, Brock McCleary, says Chrin intends to move into the new district.


Chrin's announcement on which district he'll pursue came as congressional candidates were able to begin circulating petitions Tuesday March 20, to get their names on the May 15 primary ballot.

That process was delayed by two weeks due to the legal fight over the state's congressional district map, which the state Supreme Court threw out last month. The justices had unveiled a new set of district boundaries just last week.

Chrin said he is looking forward to facing off against Democrat Matt Cartwright in the fall.

"Continue to do what I've done my entire life: live Pennsylvania values in my heart and in my actions, everything I do, to work hard, and the truth will come out, and I think when the people really see the difference in terms of the values in what Matt represents and what I represent," Chrin said.

Chrin lives in the Lehigh Valley where he is from, but he has only lived there for the past year to reestablish Pennsylvania residency in order to run in this race. Before then, he and his wife lived in New Jersey.

Chrin far outspent his opponents, even pumping an estimated \$700,000 of his own money into his campaign.

Today, May 20, 2018, is also Chrin's 55th birthday. After he gave his victory speech, the crowd erupted into a rendition of "Happy Birthday."

The costs have been so prohibitive that many Americans have forestalled doctor's visits with often grave consequences. We all know that despite the remedy that Matt Cartwright and Robert Casey Jr. will again offer you, they know that Obamacare is a disaster.

However, they are enriched by the Federal Government to have a healthcare plan independent of Obamacare. So, neither has to care about you. Congress is not subject to the same laws as the citizens thanks to long-time Congressmen such as Cartwright and Casey.

My solution to Obamacare begins with clarity and definitive purpose. We start with a one-line repeal. The Obamacare beast is then vanquished and has no legal right to ever reappear. Following the repeal, we envision a plethora of competing less expensive alternatives provided by the marketplace without current tyrannical government controls.

Chapter 12 #2 Illegal Immigration



There are two solutions in this one platform point to solve illegal immigration. The two points are as follows:

- 1. Resident Visa Plan
- 2. Pay to Go

In February 2004, the late Arizona Senator John McCain recognized via Border Patrol reports that nearly four million people crossed our borders "illegally" each year following the big Reagan amnesty in 1986. Nonetheless, the fraudulent press insists that the total count of illegal immigrants residing in the United States is stagnant at eleven million, a mathematical impossibility if Border Patrol figures are to be believed.

Using John McCain's estimates with a rate of 4 million per year since 1986, the year of the Reagan amnesty, (1986 through 2018 equals 33 years) Thirty three years times 4 million per year equals 132 million interlopers today living in America. A better estimate is that the number is more like 60 million but theoretically, it can be as high as 132 million.

And these millions of foreigners, (60 million) most using fake ID's, receive full welfare benefits while, contrary to popular mythology, very few actually work in agriculture.

You may know that in September, 2018, the generally accepted estimates of the "experts were called into question by a Yale University Study, put the population of illegal foreign nationals (aka undocumented immigrants) in the United States at approximately 11.3 million. However, a new study by Yale, using mathematical modeling on a range of demographic and immigration operations data, shows that the actual undocumented immigrant population is more than 22 million and perhaps as many as 30 million. Though that is more like it, it is still a lowball estimate based on the facts

There are in fact as many as 60 million and perhaps even more than that illegal foreign nationals living in the United States today. Nobody really knows but 60 million is a good number. While some individuals in this group may contribute to our society, on balance this is outweighed by the group's overall negative effect on US resources, whether they are drained by government assistance, lost employment opportunities for American citizens, or criminal offenses.

It is amazing how effective the fake-ID business is in turning illegal aliens into fake citizens who are thus enabled to enjoy American rights and privileges.

According to the 2011 GAO report entitled "Criminal Alien Statistics," the cost of crimes by illegal foreign nationals is \$8.1 billion per year, and that's without even considering the incomprehensibly larger emotional toll this takes on families whose priceless loved ones can never be replaced.

If elected, I, John Chrin will introduce two pieces of legislation that will solve this problem of illegal residents in the shadows once and for all. Besides many other benefits, it stands to save the U.S. over \$1 Trillion per year in addition to a major reduction in crime. The two solutions are known as *pay-to-go* and *the resident visa program*. Let's look at them now so that we all can understand how they solve the problem of illegal residents permanently.

Pay-to-Go

Most Americans are unaware that it costs taxpayers \$30,000 per year on the average, per illegal alien in America to provide them with welfare benefits that would make them pleased. Each illegal resident and their dependent children, who sign up for Pay to Go, on the way back to the home country, will receive a one-time \$20,000 stipend plus the individual expense back to the home country.

With a cost of \$30,000 per year to support unwelcome interlopers, the taxpayer savings begin year one and continue at \$30,000 per year per person forever. Not a bad deal for Americans and a great deal for aliens.

The program therefore quietly accommodates family reunification in the home country. A family of five for example, could do quite well back home after receiving \$100,000 in stipends from Uncle Sam. Reuniting families in their own countries is a good idea for them and for America. The savings in welfare for Pat-toGo means there is no cost in year one and in year 2 and every year hence, the savings equal \$30,000 for each person who "goes" back home, never to return.

Moreover, there is no settling issue as the returnee to the home country knows how to live there and does not create an issue for their home country of record. e

Resident Visa

Those illegal interlopers, who do not want to leave the US, have another option. They can sign up, be vetted, and eventually be approved for a Resident Visa. The visa will cost \$200.00 to cover vetting in year one and for well-behaved holders of the Resident Visa, it will be renewable every year thereafter for a \$100.00 renewal fee It is thus not permanent and there is no guarantee that a visa holder who misbehaves can stay in America.

To get a Resident Visa, a former interloper would agree to all stipulations after registering. At the end of the registration process, US officials would know where every former illegal interloper is living. The guessing about how many there actually are would be over and nobody would live in the

shadows. There are a lot of beneficial features to this temporary Visa.

Stipulations would include full initial vetting; onsite renewal vetting; keep existing jobs; new jobs for Americans first; no voting; no citizenship; no welfare and no freebies of any kind. Everybody who applies (registers) is not automatically approved. After vetting, those not approved for the resident visa program may use the Pay-to-Go program to aid in their relocation back to their home countries where they are known by all their friends.

As the program would by definition entail 100% participation from illegal residents, estimates are as high as \$500 billion per year cost savings in total for those who choose to go or for those who choose to stay using the nowelfare resident visa. Another \$500 billion will be reclaimed over time for the lost wages of Americans accepting lowerwage jobs. Additionally, if we can figure a way for countries to reclaim their criminals, there is another \$8.1 billion to be recovered.

Once the program is in effect, there would be no more illegal aliens in the country. Everybody would be legal. Resident visa holders would be legal and so there would be no shadows. There would be no need for DACA and no need for Sanctuary cities Let me repeat that. All issues with DACA would be over and Sanctuary Cities would be a thing of the past because there would be no shadows and no illegal interlopers.

Two additional programs are the part of my platform that I would now like to introduce in Chapters 12 and 13. Like the resident alien plans, no other candidate for public office

includes these great programs in their platform. You are going to love these.

These two new programs offer the promise of a positive effect on the health of the economy and both will contribute to improving life for American citizens of all ages to live well in this country. The first is about offering Social Security recipients increased benefits to make up for fraudulent cost of living increases based on an intentionally fraudulent consumer price index perpetrated upon seniors for the past thirty years. The second platform point is about wiping out all student debt and the second. These are presented in Chapter 13 and Chapter 14.

Chapter 13 #3 Boost Social Security Now

Democrats are obviously oblivious to the fact that the inflation rate for 2017 was really 11%. It was not 2%, but 11%.

No wonder seniors are struggling when their cost for purchases goes up 11% and their cost of living boost (COLA) to make up for that is a mere 2%. These are 2017 cost of living figures. How do I know that, and you don't?

By the way, if Obama had his way with the chained CPI, a contrivance he supported against his advisors' wishes, it would be even worse. Seniors all know that the former president gave zero cost increases to seniors five times during his presidency showing all Democrats' lack-ofconcern for seniors.

In 2014, the president pushed hard for advancing a surreptitious reduction of Social Security benefits by using the fraudulent chained-CPI mechanism. Obama's dubious market calculations would have cost retirees more than 2 percent of their incomes. Chained-CPI is a Democrat innovation. Yet, today all Democrats are blaming the chained CPI on Republicans. That of course is a lie but try to get a Democrat to believe that it is not true.

There are several ways senior Americans can investigate how much government lies cost them each year. The government purposely underestimates the cost of living using CPI-W or chained CPI to deprive the elderly of a commensurate actual increase in earned benefits. One such method for you to use to know your actual personal loss to

government fraud each year is to subscribe to the Chapwood index or you may explore Shadowstats.com. There is proofa-plenty.

Seniors unfortunately are running out of whatever financial cushion they may ever have had, and their plight today is dire. I encourage you all to research the degree to which government deceptions are resulting in these surreptitious deprivations.

After decades of Americans being saturated by our mainstream propaganda rags, it is refreshing to finally see the truth in print. The Chapwood Index reflects the true cost-of-living increase in America. It is updated and released twice a year. There the ruses or mis-directions of the government are not included in its pages. Instead, it truthfully reports the unadjusted actual cost and price fluctuation of the top 500 items on which Americans spend their after-tax dollars in the 50 largest cities in the nation.

It exposes why middle-class Americans—salaried workers who are given routine pay hikes and retirees who depend on annual increases in their corporate pension and / or Social Security payments (SSR)—cannot maintain their standard of living. Plainly and simply, the Index shows that their income can't keep up with their expenses and it explains why they increasingly have to turn to the government for entitlements for supplementation. It's either that or the proverbial poorhouse.

Mainstream Democrats such as Nancy Pelosi, Matt Cartwright, and Bob Casey Jr. exacerbate the situation by allowing the use of even more inequitable methods such as the new chained CPI. These mutations to the real cost of living figures help assure that seniors can languish in poverty as soon as possible.

The problem of lacking transparency on true costs (true inflation) occurs because salary and benefit increases are pegged to the fraudulent Consumer Price Index (CPI), which for more than a century has purported to reflect the fluctuation in prices for a typical "basket of goods" in American cities — but which actually hasn't done so for the last 30 years.

The middle class has seen its purchasing power decline dramatically in the last three decades, forcing more and more people to seek entitlements when their savings are gone. And as long as pay raises and benefit increases are tied to a false CPI, this trend will continue.

In the past, nobody was anxious to throw the proverbial grandma under the bus. Now, believe it or not, hordes of constituencies are lining up to be the first to fleece what should belong to her, into the eternal abyss, never to be seen again. The list of offenders includes: Congress, government officials, professors in academia, the "greatest" economic advisors the world has ever known, and dejected stand-alone economists who failed to gain tenure at a university.

This group of elite misfits have formed a diabolical consortium to cheat seniors out of their due cost of living increases promised from the very day the SSR act was passed in 1935 by Franklin Delano Roosevelt. Roosevelt promised benefits would be delivered in constant dollars but Democrats since Roosevelt have lied to the public.

As the mainstream Democrats kowtow to cultural elites and financial institutions, turning their backs on the workers and middle-class that defined their constituency for much of the 20th century, it is up to us to pick up the slack and fight for the rights of everyday Americans.

John Chrin is on the side of seniors in this battle. Matt Cartwright is on the side of the elites which includes lawyers such as his former law firm. Ask Chrin's mom if Social Security is important. She knows. Lou Barletta, who is running against Senator Bob Casey Jr. (a senator not rooting for seniors), is also a mainstay on the Pennsylvania prosenior team.

It is important to repeat that when SSR was enacted, the president (Roosevelt) promised full dollar value throughout the years in order to ensure its passage in 1933. We cannot let this be undermined by the likes of Congressman Cartwright, Senator Casey and his allies under the command of Chuck Schumer and Nancy Pelosi.

Many Americans are concerned that the Social Security program itself may not be able to sustain itself while others see the government cheating on the cost of living increases (CPI) thereby predetermining a life of squalor for seniors.

All successful societies throughout the ages, have maintained respect and dignity for their elders. Not only is cheating seniors a moral failure, it is a sign of a civilization entering an era of decay.

While seniors are losing their homes and many, for want of bread and milk, are on the verge of heading to the proverbial poorhouse or worse—the clutches of the Grim Reaper,

Congress in 2018 pretended to care, giving a 2% raise. But then as unreported by the Democrat controlled media, they quickly snatched it right back in the dead of night via a Medicare Part B premium increase. This additional Medicare Part B charge for necessary health services for seniors was excluded from the cost of living calculations. How could Congress have missed that? Ask Matt Cartwright. It was intentional.

Thus, to pay Medicare part B, seniors have been forced to use their "generous" 2% raises, rather than to offset the costs brought forth from inflation in 2017 for which the 2% was intended. Since the real inflationary cost increases were closer to 11% according to the index, that means that instead of 9% that seniors were to endure, they accrued a full load of 11% in price increases. It's easy to understand why this constant drainage of resources is unsustainable for a senior citizen. More and more are forced to go to welfare or give up as their life-long homes are foreclosed.

How did we reach this point?

Early in the administration of disgraced former President Bill Clinton, an economist named Michael Boskin, along with Alan Greenspan, Chairman of the Board of Governors of the Federal Reserve System, devised a scheme that would allow for market basket "substitutions" to artificially lower the cost of living and result in lower payments to our oldest Americans.

These guys found value in having senior citizens help save big government money. Prior to their involvement, the

consumer price index (CPI) was measured using the cost of a fixed basket of goods, a fairly simple and straightforward concept.

The identical basket of goods would be priced at prevailing market costs for each period, and the period-to-period change in the cost of that market basket represented the rate of inflation in terms of maintaining a constant standard of living. That was self-evidently fair and reasonable, and predictably resulted in seniors receiving annual COLA increases in tandem with the prices of goods actually increasing.

But Boskin and Alan Greenspan argued that when one item in the basket, for instance steak, became too expensive, the consumer would naturally substitute an affordable protein item such as hamburger for the steak, and that the inflation measure should reflect the costs tied to buying hamburger rather than the steak.

Eventually, it became OK for the bureaucrats to replace hamburger with less expensive tuna and eventually because the protein value was the same, cat tuna replaced regular tuna in the market basket.

The Bureaucrats like to tell observers that seniors did not have to eat the cat tuna, but their basket costs would be reflected the same if they did.

In simple terms, the government began to play tricks with Social Security annual inflation adjustments. It was intentional. To further obscure the true cost of living, other items were selectively removed from the basket when the prices were high and then reinserted when the prices were

low again. The objective was to save the government money not to make sure that things were fair for elderly Americans.

Many people have been familiar with this ruse. For example, an economic commentator named Barry Ritholtz joked that Greenspan's core inflation metric can more accurately be described as "inflation ex-inflation," meaning inflation after all of the inflation has been excluded.

This demonstrates that the deception of seniors has been intentional, and it continues with a new notion called the chained CPI that will cost seniors even more. We need Chrin, Barletta, and Trump to get this back on track.

The fact is that government has deceitfully stolen directly from the pockets of our beloved seniors by denying them a fair cost of living increase just to stay even. Some have even suggested that the government believes a natural limit exists so they won't get caught in their ruse. They think they will get no criticism because over time, many of the complainants will be silenced by their deaths when they can no longer afford to pay up. Charming thought?

Walter J. Williams, an American blessing who operates the Shadowstats site has demonstrated that seniors have been stiffed by much more than just 125% and in fact should be receiving more than 4 times what their dollars were worth in 1980. That's \$450 instead of \$100.00.

Any senior would love to have even a small proportion of that loss back. Government lies cost seniors \$350.00 on the hundred since 1980. But nobody will ever see that and great representatives, other than John Chrin and Lou Barletta

from PA will not even tell Americans what is actually happening.

I hope I have convinced you all that seniors have been ripped off and are being ripped off financially all the time by their own government. Congress is the real culprit.

Chapter 14 #4 Eliminate All Student Debt!!!



Student debt is huge

In 2018, the total amount of student debt outstanding was \$1.48 Trillion. More and more young adults simply cannot repay their loans; so they are forced to default. Most are looking for relief but do not want to put the rest of America on the hook for an education that went bad for them. Universities and colleges take no blame, though most of us see them as the real perpetrators.

If Academia admitted they lied to the freshman, then maybe everybody today owing the national government for a student-loan package that committed kids to pay and pay and pay and pay and gain nothing, would be asking Academia to pony up a few bucks to solve the debt crisis. If anybody is at fault besides the 17-year olds who took on the debt, it is those that sold them on going into debt—the colleges and universities of America.

Many of our friends have asked: "Why do our young people no longer matter?" Do they matter? To the Matt Cartwright and Bob Casey Jr. Congress, they do not matter at all.

We Americans live in an age when everybody seems to have a reason to pick on millennials. It happens this group owes most of the student debt in America. I am sure your average Bank Officer would not loan a "spoiled" millennial "ingrate" as much as a dollar today for a cup of coffee.

However, the same millennial just a few years previous, was able to get a hundred-thousand-dollar loan or more at a college or university even though their young face gave away the fact that the debtor had yet to finish with puberty.

have the will to participate in the loan game at all. Some even drop out of life.

I have proposed that John Chrin and Lou Barletta offer legislation when first elected to make sure we solve this nasty American problem. There have been many other debt reliefs in our history but none that could deliver such an immediate positive punch to so many actual Americans all at once.

The upside of wiping out all student debt immediately, would be overwhelming. There would be a joint humanitarian return and a major economic return far greater than any bailout in history. Let's consider it. OK? It is not unprecedented. Don't rule it out OK?

A Bailout is a Bailout?

"The Special Inspector General for TARP's summary of the bailout says that the total commitment of government is \$16.8 trillion dollars with \$4.6 trillion already paid out." FYI, that is three times the total amount of student debt owed today.

[The same banks are now larger and still "too big to fail." But the indebted students are small potatoes, not significant enough to care about. So, their loans must be repaid.]

"But it isn't just the government bailout money that tells the story of the bailout. This is a story about lies, cheating, and a multi-faceted corruption, which was often criminal."

Like most elements of his presidency, Obama made the situation worse when he commandeered the student loan program from Sallie Mae and other lenders. The government now pulls in more than \$50 billion a year from charging usury level interest rates to student borrowers. The Obama Student Loan Company charges 6.8% as student interest rates.

The CBO estimates that the interest rate on these loans should quickly be reduced from 6.8 percent to 5.3 percent if Obama had not earmarked the profit from the backs of students to subsidize Obamacare.

Not only were millennials duped into huge college loans when they were so young that Clearasil was one of their major expenses, they were duped into believing Obama was in their corner.

Despite what a number of my conservative friends believe, your author believes these student victims deserve a break. Many are now adults. They would be unleashed into a world of productivity if no longer burdened with this massive debt. Many of us know first-hand the consequences of this debt burden. Though millennials may not be the most gracious in asking for help, they are Americans, not DACA immigrants, and they need our help now. Even if your child got through himself or herself, without any help, could you dare say no?

Do you want these young people to be poor all of their lives? Are you mad at them because they cannot pay back their loan but not be upset with others who use the bankruptcy courts or the welfare system to handle their debt? Think about the answer, please?

We must solve this scourge on our country so that this generation can produce other generations of reasonably wealthy regular Americans.

I have friends who say "my Johnnie and my Elsie had to pay it all off and they did...those lazy louts should just cough it up!" As a country, the US has not ever had to vote to permit the poor to starve because somebody paid something more or less than somebody else. We should not start now.

Just remember that the children of Americans, our children are not MS-13 members in disguise; they are our kids— American kids. They were snookered to join academia for what they were deceived into believing was an indispensable college degree by depraved loan sharks. Let's give them a full chance to recover.

Right now, we need a mere 10% of that number to pay for the write-off of student debt without hurting taxpayers and without putting any banks under. The savings over three years, for example from the resident visa program alone pays off the entire student debt that exists today. Why support illegal aliens when we can help Americans?

Nobody gets a loan unless the college or university agrees to take all of the risk of the loan. If the student is successful, she or he will pay very reasonable amounts on a monthly basis. If the student is jobless, since the university vouched for the student, the school will owe all of the debt.

Academic institutions are smart. They will stop lending quickly to students with very little prospects of being able to pay the loan back. If students do not maintain acceptable averages, they will be expelled, and the university will pay their balance. If the same student wants to go to college in the future, it will be cash only. What do you think?

A Rigged System

You and I are confident that President Trump would reenfranchise America's youngest generation of adults. by eradicating student debt and paying the balance via savings no longer spent subsidizing illegal immigrants.

In his own words, regarding recent graduates: "They go, and they work, and they take loans, and they're borrowed up, and they can't breathe, and they get through college and the worst thing is, they go through that whole process and they don't have any job." Trump has it right. He sees how this rigged system has snuffed out the optimism of a bright generation that now gives way to cynicism and despair.

I am expecting that John Chrin and Lou Barletta already know how important this is. When Chrin replaces Cartwright and becomes our Representative and Barletta replaces Casey and becomes our US Senator, I would expect that they would help enact the legislation that eradicates all Student Debt, effective immediately.
