# The Electoral College 4 Dummmies?

Would it be better to simply count the popular vote?

In this book, you will learn about the purpose of the Electoral College and be able to come to your own conclusions about whether the Founders were all wet in the late 1700's and we now need to revert back to the popular vote. In 2016, Hillary Clinton won the Popular vote yet Donald Trump won the presidency. Therefore, many of the political left are crying foul. In 2000, when George Bush was elected president without winning the popular vote the same cry was heard.

Neither of these were as bad as in 1824, when John Quincy Adams was elected president despite not winning either the popular vote or the electoral vote. How could this be? Andrew Jackson was the clear winner in both categories. Jackson's popular vote total was 38,000 more than Adams. Moreover, Jackson beat Adams in the electoral vote 99 to 84. Despite being victorious, Jackson did no win the presidency. Why?

Andrew Jackson did not reach the majority 131 votes needed in the Electoral College to be declared president. Neither candidate did. So, what happened? The decision was made by the House of Representatives. It was the House—the People's Representatives, which voted Adams into the White House.

There were only two other stories like these. In 1876, Rutherford B. Hayes won the election by a margin of just one electoral vote; but he lost the popular vote by more than 250,000 ballots to Samuel J. Tilden. In 1888, Benjamin Harrison received 233 electoral votes to Grover Cleveland's 168, winning the presidency. Harrison lost the popular vote by more than 90,000 votes.

Why is this? When U.S. citizens go to the polls to "elect" a president, they are in fact voting for a particular slate of electors, though they vote for a properly named presidential candidate. In almost every state, the candidate who wins the most votes (that is, a plurality) in the state receives all the state's electoral votes. These are electoral votes based on the popular votes.

Why is this? You bought this book to find out. Is it a good or is it a bad idea? Is there any rhyme or reason to it? Were the Founders out on a bender the night before they made this decision or was the Electoral College a stroke of genius?

This is your best book to discover the answer and for understanding the current system and other possible systems to determine the presidency fairly.

Just because powerful people choose to ignore our rights and freedoms does not mean we must endure tyranny. The first step of course is to understand the most basic written precepts in the Constitution. Understanding the role of the Electoral College in our Constitution is of prime importance. Gregg Phillips is a founder of VoteStand (an APP for finding and reporting voter fraud), His Twitter profile notes that The Cause, Time for a Hero, Voters Trust & Winning Our Future PAC are big items as they should be. He tweeted some interesting observations and analyses:

"We have verified more than three million votes cast by noncitizens."

Too bad!


Phillips has a few more observations:

A reversal of the results in those states could, in theory, tip the election to Hillary Clinton.

Does an apparently sincere concession with an apparently sincere wish for the future for President-elect Trump mean anything?

Does the official Constitutional final vote count matter?

Although the election was held way back on November 8, and the electors had been scheduled to vote for Trump on December 19, there were still states counting votes.

Many votes are of the absentee and provisional variety while some other states have yet to declare their tallies certified and official. As of Saturday (Nov. 25), Clinton was leading in the popular vote, 64.6 million to Trump's 62.4 million. Trump overwhelmingly won the Electoral College and is for all intents and purposes, the President-elect. It's not going to change.

I believe sincerely that if we asked all the people in the flyover states whether they would prefer to sit home on election day and let the general election tabulators count just California and New York, they would tell you where to go and quickly. Please know that I have great respect for the Founders, the Revolution, and the Constitution. I ask you to excuse my crassness in the above questioning of the Founders' motivations.

Unexceptional normal human beings might be more concerned about their own businesses than business and commerce in general. If given enforcement power, much like today's "innocently" corrupt American officials, today's politicos would be more prone to enforce that which helps their own standing, rather than that of their fellow man.

And, yes, the Founders were important men but they were exceptional men in their times. They cared about goodness and

It is good for Americans to ponder the motivations of the Founders. This gives us all a clearer understanding of why those brave men who came before us risked their blood, treasure and sacred honor to create the greatest nation on Earth.

# Maybe they were sent by God.

The Founding Fathers were a revolutionary group, diverse in their professions and yet unified in their goal: American liberty. Of course, not just the common man would receive liberty in the end but the Founders also had been subject to the tyranny of the British, and they too longed to be free.

They understood that not just the leaders but also the citizens should have a say in their government and that a government only derives its legitimate power from the consent of the governed.

When Thomas Jefferson wrote the Declaration of Independence, his timeless, eloquent words of freedom sent political shock waves around the world that continue to reverberate in the minds of revolutionaries everywhere. These are the words of a God-fearing man:

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. — That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and

organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness."

Most of the Founders were god-fearing men. However, some notable exceptions included Thomas Paine and Ethan Allen. They may have even been hostile to evangelical Christianity. However, they were provocative agents of the Revolution. Men like Paine and Allen were not intellectual architects of the Constitution but they believed in America. Thomas Paine for example, did not arrive in this country until 1774 and he only stayed a short time.

Looking at the normal list of Founders and patriots, we would find others, such as George Washington, Patrick Henry, Samuel Adams, John Jay, James Madison, John Witherspoon, Alexander Hamilton, John Adams, and even Thomas Jefferson. These men were influenced by goodness and by God.

Their formal writings, including their personal correspondence, biographies, and public statements, are loaded with salient quotations showing that these thinkers had political philosophies deeply influenced by Christianity.

It is this lesser known aspect of the Constitution that is the focus of this chapter. Jefferson often spoke of the purpose of the Constitution as a means by which to "fortify us against the degeneracy of one government, and the concentration of all its powers in the hands of the one, the few, the well-born, or the many." He assumed that informed citizens could and would make good decisions for themselves and their country.

"I have so much confidence in the good sense of man, and his qualifications for self-government, that I am never afraid of the issue where reason is left free to exert her force."

What did Jefferson mean by "one" government? He meant a government in which power was not divided. It was a government concentrated in one body, one group, or one

person. Jefferson believed in government of the people, for the people, and by the people.

Jefferson, a farmer by trade, but clearly an able intellectual and eloquent statesman, had great faith in the goodness and wisdom of people who worked the soil – farmers and planters like himself. "State a problem to a ploughman and a professor," he said, and "the former will decide it often better than the latter."

He would find many more reasons to believe this if he were to interview today's coffee-breath professors at American universities. Jefferson worried about a government with too much power. He was OK with a government lacking power. He believed the power should be vested in the people.

### Adams expounded on this idea:

"No simple form of government can possibly secure men against the violence of power. ... Monarchy [turns into] despotism, aristocracy [into] oligarchy, and democracy will soon degenerate into an anarchy, such an anarchy that every man will do what is right in his own eyes [an allusion to Judges 21:25], and no man's life or property or reputation or liberty will be secure and every one of these will soon mold itself into a system of subordination of all the moral virtues and intellectual abilities, all the powers of wealth, beauty, wit, and science, to the wanton pleasures, the capricious will, and the execrable cruelty of one or a very few." Amen!

These are a part of the background thought for why we are a constitutional Republic, and not a pure democracy. The Constitution is a guiding light from which our elected leaders are not permitted to stray. For a better look at the Constitution, I unabashedly recommend my book, *The Constitution 4 Dummmies* available on Amazon and Kindle.

As we look at the Founders and the Constitution, remember again that the Electoral College is a fundamental principle defined in the Constitution by the Founders.

# Chapter 5 The Founding of the Electoral College

#### Founders concerned about the common man

The Founders who attended the Constitutional Convention in Philadelphia devised the Electoral College as a fair way to determine how the president of the United States would be elected. They were not demented as many Democrats today would have you believe. They were very concerned about the common man?

One thing is for sure, there were no Democrats or Republicans or Greens or Libertarians or any political Parties permitted in America at the time of the first presidents. The founders were profoundly unselfish beings looking after the good of America and their fellow man. Though they had their own mercantile interests; they were altruistic in their work for America. The more we read about the Founders, and the more we see the risks they took for a just moral cause, the more we can safely suggest they were good men.

#### The Constitutional Convention

The Convention met between May and September of 1787 to address the problems of the weak central government that was the hallmark of the Articles of Confederation. The Arricles of Confederation may have initially formed the "Union." However, it was not as perfect as a definition of government asit could be. Thus, when the Constitution was built, in the preamble, its purpose was form a "more perfect union."

The United States Constitution emerged from this convention. It established a federal government with more specific powers, than the "Articles," including those related to conducting relations with foreign governments.

The form of government was called a Constitutional Republic. The constitutional part meant that relied on a Constitution (A written set of rules), not the whim of the leadership. The Republic part means that the people as individuals hold the power—not the government or the governed as a group. The US therefore is technically not a democracy. Minority interests are part and parcel of the Constitution.

Let's first look at some thoughts on a Republic.

It is that form of government in which the powers of sovereignty are vested in the people and are exercised by the people, either directly, or through representatives chosen by the people, to whom those powers are specially delegated.

The word "people" as used above may be either plural or singular. In a Republic, the group only has advisory powers; the sovereign individual is free to reject the majority group-think. The USA does have one exception to this: if 100% of a jury convicts, then the individual loses sovereignty and is subject to group-think as in a democracy.

Let's now look at some thoughts on a Democracy.

It is that form of government in which the sovereign power resides in and is exercised by the whole body of free citizens as a group, directly or indirectly through a system of representation, as distinguished from a monarchy, aristocracy, or oligarchy.

It is worthy of note that in a pure democracy, 51% beats 49%. In other words, the minority has no rights. The minority only

has those privileges granted specifically by the dictatorship of the majority.

Let's look at a simple way to contrast a Republic with a democracy.

A Republic and a democracy are identical in every aspect except one. In a Republic, the sovereignty is in each individual person. In a Democracy, the sovereignty is in the group. In a Republic therefore, the minority side has rights. In a democracy, only the majority side has rights.

# The Improved Federal System v the Articles

Under the reformed federal system, many of the responsibilities for foreign affairs fell under the authority of an executive branch, as defined within the Constitution.

There were however, important powers, such as treaty ratification that remained the responsibility of the legislative branch.

When the necessary number of state ratifications took place, the Constitution became the official written definition of the United States Government. It came into effect in 1789 and has served as the basis of the United States Government ever since. It has been modified 27 times via twenty-seven separately ratified Amendments.

# Are the people as a whole smart enough to directly elect a president?

Many Constitutional expert sources attest that the Framers were wary of giving the people the power to directly elect the President — some felt the citizenry would be too beholden to local interests, and too easily duped by promises or shenanigans. Another argument against the popular vote was

that in a national election, in a time of oil lamps and quill pens, it was just impractical to get votes from every person.

There were lots of proposals as there were lots of smart people thinking about the best and fairest way to select a US president. Some would have given the power to the Congress, but this did not sit well with those who wanted to see true separation of the branches of the new government.

Others felt it would be OK if the state legislatures decided. After all, state representatives are elected by the people. Opponents of using state representatives thought this would make the new president too beholden to state interests. The Electoral College, was proposed by James Wilson. It was the compromise that the Constitutional Convention reached. When you take the time to understand it, it makes a lot of sense.

### Proportional representation just like the US House

Though it was not exactly easy to figure out when Wilson proposed it, the Electoral College has evolved into something whose proportional representation numbers are reasonably easy to understand. Each state receives a number of votes in the Electoral College equal to its total representation in both Houses of Congress.

Let's look at a few examples to get this notion down solid: California, which has 53 representatives in the US House of Representatives based on its population and two in the Senate, casts 55 votes in the Electoral College. Pennsylvania, which has 18 representatives in the House and two in the Senate, casts 20 votes in the Electoral College. Rhode Island, which has 2 representatives in the House and two in the Senate, casts 4 votes in the Electoral College.

The big exception to the number of electoral votes is Washington D.C. The District of Columbia has one representative in the House. The House Representative has no vote. There are no senators elected from Washington DC.

By a Constitutional Amendment # 23, ratified by the states, Washington, D.C., was given three electoral votes for president. Until the 23rd Amendment of the United States Constitution was ratified in 1961, Washington, D.C., residents did not have the right to vote in presidential elections, being governed, as per the Constitution, solely by Congress.

If there were not so much concern from the Founders of collusion among big shots in government in the formation of informal "big shot" "hoity toity" elite establishment clubs, the most logical choice would be for those duly elected by the people in each state to the State House and the State Senate to also default to be the electors for that state.

Another easy allocation method would have been to not have electors and thus have no vote at all. In this scenario, the apportioned number such as 55 for California, 20 for Pennsylvania, 4 for Rhode Island, and 3 for Washington DC would be used. They could simply be added up.

This would make it easier as electors would not have to be "elected" and there would not have to be an election of the president by electors. The apportioned total would count as a ballot cast for the state winner. The total votes for all state electors would determine who would be President.

The Founders wanted the electors to be people rather than a direct number as it gave the Republic one last opportunity to stop a scoundrel from becoming president. Let's say that some good cause was determined and it was universally accepted that the high electoral vote achiever was a thief or scoundrel or both and other obvious proven-true bad things.

When the electors would meet (In 2016, the date was December 19), they could vote a different person than who the people in their states selected. However, other than when there is a major obvious issue of detrimental circumstance to the country, electors are sworn to vote for the winner of the state.

There is more to it.

Each formal US census, conducted by law every ten years, determines how many representatives each state gets. Thus, it follows that after each census, the number of electors in the Electoral College for each state is also recalculated. Therefore, when the general election is held, the people of California decide what to do with their 55 electoral votes. In other words, they select their electors according to their own rules; not the rules of a central government. Every other state makes like decisions.

Let's move to the current presidential election now for more realism. In this past election since majority wins, the State of California decided to give its 55 votes to Hillary Clinton. Should the Trump people have complained about the potential for fraud in such a large majority.

There are reasons why the popular vote is a bad idea? First, it is because our form of government is Republic, not democracy and so, the minority has a voice, not just the majority.

Here is another reason. Let's say everybody from California could make it to the polls and they all voted for candidate X. Candidate X would receive about 18 million popular votes and 55 electoral votes. Now, in the other forty-nine states, suppose the polls were not open long enough for all voters to vote and so, let's say only 100 were able to vote and they all voted for candidate Y. Forty nine states times 100 equals 49,000.

Thus the popular vote would be 38 million v 49,000 and candidate X would win a landslide victory over candidate Y. Is

this fair when the total population of the states that could not vote in this scenario is 241,000,000 minus California (38,000,000). So, the 38 million California residents would preempt the 203 million other US residents.

If you are from California in this scenario, you are happy. If you are from any of the other 49 states, your state's population along with all the other states of 203,000,000 gets beaten by just one state with just 38,000,000 in population.

So, what the Founders did was took every state's total population and even if only one person in that state votes or just 100 people vote, their voter population determines how much their state is worth in terms of determining the president.

So, let's say there are no electors. Instead, the population in each state is the determinant. The popular vote equivalent of the Electoral College would be that if 1 person votes in California, all 38 million registered population adds to the count for candidate A. If 1 person in Pennsylvania votes, all 9 million registered population add to the count for candidate B. If 1 person in Michigan votes, all 7 million registered population add to the count for candidate B. If 1 person in Florida votes, all 13 million population add to the count for candidate B.

If there were just these four states, Candidate A would win 38,000,000 v 29,000,000

Now if we make it 5 states and we add Texas' number of 15 million registered for candidate B, then B wins by 44,000,000 to 38,000,000

This system protects the viability of all states and weighs them equally regardless of whether the registered voters in the state cast a ballot or not.

The Electoral College works almost exactly like this except for one thing. It proportionally reduces these large numbers to Only two states, Nebraska and Maine, do not follow the winner-takes-all rule. In Maine, each Party's state convention nominates four electors, one from each congressional district and two at large. In Nebraska, there are three congressional districts, meaning two votes go to a statewide winner and the three districts each award one electoral vote.

The total population of the US is thus divided up by state so that there is a total of 538 electors in the "Electoral College." It works the same way proportionally as if the big numbers such as 38 million for California and 15 million for Texas were used.

A majority of 270 electoral votes is required to elect the President. Your state's entitled allotment of electors equals the number of members in its Congressional delegation: one for each member in the House of Representatives plus two for your two Senators.

What really happened in California in 2016?

On the day we took our sample, Hillary Clinton had already received 7,362,490 votes. Donald Trump had received 3,916,209. Gary Johnson and Jill Stein received an inconsequential number of electoral ballots. So we won't even count them.

Hillary Clinton whooped Donald Trump by about 3.5 million votes. They say there are still over 3 million ballots to count in California. The margin of victory in this state is not inconsequential. Many Americans in the rest of the states do not like the idea that California, which has a huge illegal foreign national population, would be the determining state for the

presidency of the country. For the other 49, with Governor Jerry Brown telling residents legal and illegal to vote, there are a lot of suspicions.

In fact, because of California, those who suggest the Electoral College is all claptrap must be OK with letting California determine who the President of the US should be. The count when this was written placed Hillary Clinton ahead by 2 million in the popular vote. Simply because she and Donald Trump decided to abide by the Constitution, her supporters say she is not President-elect.

Let's look at the agreed upon method to determine the World Series. In the 2016 World Series, The Chicago Cubs pulled off a thrilling win in 10 innings over the Cleveland Indians to end their 108-year World Series title drought. The Series was tied three games to three. To Hillary supporters, however, the Indians were ahead 20 to 19 because the Indians had scored twenty-runs in six games to nineteen runs for the Cubs.

The final game was won 8 to 7 by the Cubs making the run total equal at 27. Yet the World Series was awarded to the Cubs because they had won seven games. The run total did not matter. Only the agreed upon method of games won mattered. The same goes for the 2016 presidential election. The popular vote total did not matter. Only the agreed upon method of electoral votes mattered.

Victories and losses in all endeavors are determined according to the rules and the rules do not get changed after the games or the series of games are played. The Cleveland Indians Fans, if they used Hillary supporter logic, would have been asking for a tie-breaker game to see who would win the World Series on the highest total runs. Of course there is one big problem with that logic. The teams had agreed and the rules were thus set that the winner of the best of seven series would win the World Series. And, so the Cubs ended their 108-year drought and were declared the victors according to the rules of engagement.

Let's use one more analogy. Just suppose West Virginia was one of our largest states and they came in proportionately favoring Donald Trump. Remember Donald Trump was not in favor of extinguishing the coal fires across the nation. Trump wanted West Virginians to be able to have high paying coal jobs. This would be the same as California favoring Hillary Clinton because she believes lawless immigration should be made the law of the land.

Using the West Virginia actual numbers times one hundred, what if the Trump numbers X (times) 100 came in at 48,619,800? What if the Hillary numbers came in at 18,745,700? These are in fact the exact WV proportions.

This would mean that approximately 30 million additional voters would have voted for Trump in West Virginia. If Trump lost the election in the Electoral College, and won the popular vote because of his huge majority in West Virginia, would this be a good enough reason to let West Virginia determine the presidency?

Should Trump in such a circumstance in which he won the popular vote but not the electoral vote, be declared Presidentelect even though it was against the rules. Or should Hillary be given the victory since her tally was within the rules?

If it is not a good reason for West Virginia in the hypothetical, then it is not a good reason for California in the actual realm. The 3.5 million majority in California is not a good enough reason to permit California to determine exclusively the presidency of the United States of America. That's why the popular vote is not used.

By the way, the population of California is moving out. The state population is thus declining. People are moving to other states. Many are heading out to Texas, which is much more

business friendly and the Texas economy is doing very well and taxes are low.

So, a high population state one day might be substantially lower in population thirty years or so down the road. The population of Texas is expected to double by 2050, says a new report released by the Office of the State Demographer. I suspect that Californians would not want Texas to be the determining factor in determining national elections.

If you are still not sure that this system is fair, please read the email at the end of chapter 1, one more time.

#### Who created the states

Please check out the name of our country. Our full name is the United States of America. It is not the Solitary or Individual States of America. Each of the states has its own local government and it is these local governments called states that together form the country we love.

The colonies already had defined the geographies of the 13 original states. The national government did not create the states. We are not the result of a proportioned federal government in which various geographical pieces have been randomly broken off the full country into geographical shares. Each state instead, is a sovereign entity. However, by agreeing to the Constitution, each state also became a part of a union of states which formed the national government.

How do electors get selected for the Electoral College?

We already know how many votes each state gets in the Electoral College. None of this really matters if those electoral votes are not cast. But, by whom?

On Election Day, it is the voters in each state who select their state's Electors by simply casting their ballots for President. Who are the electors by name?

People in the states who vote for the president are not typically tuned in to the fact that their state legislature or perhaps another official state body, has already selected which people in the state will serve as the actual electors.

There is no separate vote by the people for the electors. When the electors vote (In 2016, the date is December 19), in 50 separate elections in 50 states, they pledge to vote for the candidate that the people in their state have selected in the general election.

Depending on the laws of each state; they may be state elected officials, state Party leaders, or people in the state who have a personal or political affiliation with their Party's presidential candidate. They pledge, based on a major penalty to vote for the candidate in the Electoral College who won the state's electoral votes. If they go rogue, there are unpleasant consequences

# Chapter 6 The Constitutional Convention Considered Multiple Electoral Options

### More ways than one to skin a cat

The delegates at the Constitutional Convention (May to September 1787) considered several possible methods for selecting a president. Let's look at these now more formally than in Chapter 5. Then, we will show the end result of their work as reflected within the Constitution itself.

**Idea One** at the convention was to have the US Congress, a body duly elected by the people of the states to choose the president. This idea was rejected.

Some felt that making such a choice would be too divisive an issue and leave too many hard feelings in the Congress. Others felt that such a procedure would invite unseemly political bargaining, corruption, and perhaps even interference from foreign powers. Still others felt that such an arrangement would upset the balance of power between the legislative and executive branches of the federal government. In essence, idea 1 would permit the Congress to determine the Executive Branch.

**Idea Two** was to have the State lawmakers select the president. This idea was also rejected.

There were fears that a president would be so beholden to the state legislatures that it might permit them to erode federal authority and thus undermine the whole idea of a federation of states.

**Idea Three** was to have the president elected by a direct popular vote. Just count the votes. The Hillary Clinton campaign along with major donors, who watched her popular vote total grow to over two million more than Donald Trump's numbers began to espouse this notion in November 2016.

There are two reasons in 2016 for this to have happened.

- 1. There was a remote possibility that the supporters could create a groundswell of support for the idea and be able to do something before the new administration was finalized in the Electoral College.
- 2. They would be able to plant the seeds of doubt into the minds of Americans in an attempt to delegitimize the Trump Presidency, making it easier for a Democrat to win next time 011f

The Founders rejected idea 3, known as direct election. The reason was not that the Framers of the Constitution doubted public intelligence but rather because they feared that without sufficient information about candidates from outside their own state, people would naturally vote for a "favorite son," from their own state or region.

It helps to remember that there were no political Parties when the country was formed and therefore there was no primary election to make the candidate pool manageable.

At worst in this scenario, no president would emerge with a popular majority sufficient to govern the whole country. At best, the choice of president would always be decided by the largest, most populous States with little regard for the smaller ones.

An **Idea Four** was also examined. With this, a so-called "Committee of Eleven" in the Constitutional Convention proposed an indirect election of the president through a College of Electors.

The description of how this would work, considering there were no political Parties is as follows: The function of the College of Electors in choosing the president could be likened to that in the Roman Catholic Church when the College of Cardinals select a new Pope.

The Electoral College original idea was for the most knowledgeable and informed individuals from each State to select the president based solely on merit and without regard to state of origin or political Party.

Looking back at its original structure, the Electoral College can be traced to the Centurial Assembly system of the Roman Republic. Under that system, the adult male citizens of Rome were divided, according to their wealth, into groups of 100 (aptly called Centuries).

Each group of 100 was entitled to cast only one vote either in favor or against proposals submitted to them by the Roman Senate. In the Electoral College system, the original 13 States serve as the Centurial groups (though they are not, of course, based on wealth). The number of votes per state would be determined by the size of each State's Congressional delegation. Still, the two systems are similar in design and share many of the same advantages and disadvantages.

The similarities between the Electoral College and classical institutions are not accidental. Many of the Founding Fathers were well schooled in historical matters including ancient history, ancient governments and their lessons.

# The Constitution defines the Electoral College

Article I Section I of the Constitution defines the Legislative Branch as follows:

All legislative powers herein granted shall be vested in a Congress of the **United States**, which shall consist of a Senate and House of Representatives.

The notion of the Electoral college when put to paper appeared in Article II of the US Constitution. The Founders and others of their day wrote in a style that is less easy to read. Many comfortable with the prose style of today would not find the 18<sup>th</sup> century style appropriate prose today. So, when reading the Constitution, you may have to read again and again to get the exact gist. Article II reads exactly as follows:

#### Article. II. Executive Power

#### Section 1.

The executive Power shall be vested in a President of the United States of America. He shall hold his Office during the Term of four Years, and, together with the Vice President, chosen for the same Term, be elected, as follows:

Each State shall appoint, in such Manner as the Legislature thereof may direct, a Number of Electors, equal to the whole Number of Senators and Representatives to which the State may be entitled in the Congress: but no Senator or Representative, or Person holding an Office of Trust or Profit under the United States, shall be appointed an Elector.

The Electors shall meet in their respective States, and vote by Ballot for two Persons, of whom one at least shall not be an Inhabitant of the same State with themselves. And they shall make a List of all the Persons voted for, and of the Number of Votes for each; which List they shall sign and certify, and transmit sealed to the Seat of the Government of the United States, directed to the President of the Senate. The

President of the Senate shall, in the Presence of the Senate and House of Representatives, open all the Certificates, and the Votes shall then be counted.

The Person having the greatest Number of Votes shall be the President, if such Number be a Majority of the whole Number of Electors appointed; and if there be more than one who have such Majority, and have an equal Number of Votes, then the House of Representatives shall immediately chuse [choose] by Ballot one of them for President; and if no Person have a Majority, then from the five highest on the List the said House shall in like Manner choose the President.

But in choosing the President, the Votes shall be taken by States, the Representation from each State having one Vote; A quorum for this purpose shall consist of a Member or Members from two thirds of the States, and a Majority of all the States shall be necessary to a Choice. In every Case, after the Choice of the President, the Person having the greatest Number of Votes of the Electors shall be the Vice President. But if there should remain two or more who have equal Votes, the Senate shall choose from them by Ballot the Vice President.

The Congress may determine the Time of choosing the Electors, and the Day on which they shall give their Votes; which Day shall be the same throughout the United States.

No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any Person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States.

In Case of the Removal of the President from Office, or of his Death, Resignation, or Inability to discharge the Powers and Duties of the said Office, the Same shall devolve on the Vice President, and the Congress may by Law provide for the Case of Removal, Death, Resignation or Inability, both of the President and Vice President, declaring what Officer shall then act as President, and such Officer shall act

accordingly, until the Disability be removed, or a President shall be elected.

The President shall, at stated Times, receive for his Services, a Compensation, which shall neither be increased nor diminished during the Period for which he shall have been elected, and he shall not receive within that Period any other Emolument from the United States, or any of them.

Before he enter on the Execution of his Office, he shall take the following Oath or Affirmation:--"I do solemnly swear (or affirm) that I will faithfully execute the Office of President of the United States, and will to the best of my Ability, preserve, protect and defend the Constitution of the United States."

#### [Explanation of Article II Section I:

The purpose of Article II is to establish the second of the three branches of government, the Executive Branch. The Legislative Branch (House & Senate) is defined in Article I.

Article II Section 1 establishes the office of the President and the Vice-President. It sets their terms to be four years for each of them.

Presidents are not elected by the people per se. Instead, there is this notion called the Electoral College, and they elect the President. The people have a big say in the matter as they vote for Electoral College delegates who then vote for the President per their state's laws.

Each state has one vote in the "Electoral College" for each member of Congress. By voting for a candidate, the people are in effect voting for electors who will vote for that candidate. There are typically no separate elections for electors.

Originally, the President was the person with the most votes and the Vice-President was the person with the second most, though this was later changed to recognize that a Democrat President should have a Democrat Vice President and a Republican President should have a Republican Vice president.

This was not always the case. Once political Parties were permitted, the 12th Amendment assured that the President and Vice President would always be of the same political Party.

By 1792, opposition to the policies of the Federalist Party was growing. Led by Secretary of State Thomas Jefferson (1743– 1826), critics of the Federalists banded together to form the Republican Party. They were also called Democratic-Republicans or Jeffersonian Republicans. It is not the same Republican Party from which Abraham Lincoln was elected President

The election of 1796 was the first in which voters could choose between competing political Parties. It was also the first test of whether the nation could transfer power through a contested election.

The Federalists chose Vice President John Adams as their presidential candidate, and the Republicans, aka Democratic-Republicans selected Thomas Jefferson.

When John Adams became President, he was a member of the now long-gone Federalist Party. He was running against other Federalists as well as Democratic Republicans.

Under the electoral system at the time, each presidential elector was to vote twice, with the candidate who received the most votes becoming president and the candidate who came in second becoming vice president. Thomas Pinckney was a leading Federalist challenger to John Adams. There was no notion of a running mate.

The election was filled with shenanigans. Alexander Hamilton, for example, did not want John Adams as President. So, he convinced some southern electors to drop Adams's name from their ballots, while still voting for Pinckney. It was Hamilton's

hope that Pinckney would receive more votes than Adams and be elected president.

When New Englanders learned of this plan, they dropped Pinckney from their ballots, ensuring that Adams won the election. When the final votes were tallied, Adams received 71 votes, only 3 more than Jefferson. As a result, Jefferson became vice president with 68 votes. Pinckney was o-u-t. He had received fifty-nine elector votes

Aaron Burr, had been Jefferson's choice for VP. in the election of 1796.

Despite being from different Parties, Adams and Jefferson were thereby elected as the President and Vice-President respectively for four years. After Adams, the next highest vote getter was Thomas Jefferson.

# Why did we need the 12th Amendment?

The twelfth Amendment was brought forth, passed and ratified by the states so that both the President and Vice-President heretofore would be from the same political Party even if it were the Rathskellar Party or the Liquor Party! There are other provisions including a clarification of the Electoral College.

In Article II, Section I, other minimum requirements were established, such as a 35-year minimum age. Presidents must also be natural-born citizens of the United States. The President is to be paid a salary, which cannot change, up or down, for the term in which he is in office.

The Twelfth Amendment to the United States Constitution outlines the necessary procedure for electing the President and Vice President. The Twelfth Amendment replaced Article II, Section 1, and Clause 3, which offered the original procedure by which the Electoral College was created and how it subsequently functioned.

Further clarification of the 12th Amendment: The 12th Amendment stipulates that members of the Electoral College will vote for President and Vice President separately. If no presidential candidate gets a majority of the electoral votes, the House picks the new president from the top 3 recipients of electoral votes. If no Vice-Presidential candidate gets a majority, the Senate picks the new VP from the top 2. The exact text of the 12th Amendment is contained below:

#### The 12th amendment

AMENDMENT XII of the Constitution of the United States of America

Passed by Congress December 9, 1803. Ratified June 15, 1804.

Note: A portion of Article II, section 1 of the Constitution was superseded by the 12th amendment.

The Electors shall meet in their respective states, and vote by ballot for President and Vice-President, one of whom, at least, shall not be an inhabitant of the same state with themselves; they shall name in their ballots the person voted for as President, and in distinct ballots the person voted for as Vice-President, and they shall make distinct lists of all persons voted for as President, and all persons voted for as Vice-President and of the number of votes for each, which lists they shall sign and certify, and transmit sealed to the seat of the government of the United States, directed to the President of the Senate.

The President of the Senate shall, in the presence of the Senate and House of Representatives, open all the certificates and the votes shall then be counted.

The person having the greatest Number of votes for President, shall be the President, if such number be a majority of the whole number of Electors appointed; and if no person have such majority, then from the persons having the highest numbers not exceeding three on the list of those voted for as President, the House of Representatives shall choose immediately, by ballot, the President. But in choosing the President, the votes shall be taken by states, the representation from each state having one vote; a quorum for this purpose shall consist of a member or members from two-thirds of the states, and a majority of all the states shall be necessary to a choice. And if the House of Representatives shall not choose a President whenever the right of choice shall devolve upon them, before the fourth day of March next following, then the Vice-President shall act as President, as in the case of the death or other constitutional disability of the President.[Note 1]

The person having the greatest number of votes as Vice-President, shall be the Vice-President, if such number be a majority of the whole number of Electors appointed, and if no person have a majority, then from the two highest numbers on the list, the Senate shall choose the Vice-President; a quorum for the purpose shall consist of two-thirds of the whole number of Senators, and a majority of the whole number shall be necessary to a choice. But no person constitutionally ineligible to the office of President shall be eligible to that of Vice-President of the United States.[1]

The Electors shall meet in their respective states and vote by ballot for President and Vice-President, one of whom, at least, shall not be an inhabitant of the same state with themselves; they shall name in their ballots the person voted for as President, and in distinct ballots the person voted for as Vice-President, and they shall make distinct lists of all persons voted for as President, and of all persons voted for as Vice-President, and of the number of votes for each, which lists they shall sign and certify, and transmit sealed to the seat of the government of the United States, directed to the President of the Senate; -- the President of the Senate shall, in the presence of the Senate and House of Representatives, open all the certificates and the votes shall then be counted; -- The person having the greatest number of votes for President, shall be the President, if such number be a majority of the whole number of Electors appointed; and if no person have such majority, then from the persons having the highest numbers not exceeding three on the list of those voted for as President, the House of Representatives shall

choose immediately, by ballot, the President. But in choosing the President, the votes shall be taken by states, the representation from each state having one vote; a quorum for this purpose shall consist of a member or members from two-thirds of the states, and a majority of all the states shall be necessary to a choice.

[And if the House of Representatives shall not choose a President whenever the right of choice shall devolve upon them, before the fourth day of March next following, then the Vice-President shall act as President, as in case of the death or other constitutional disability of the President.

--\* The person having the greatest number of votes as Vice-President, shall be the Vice-President, if such number be a majority of the whole number of Electors appointed, and if no person have a majority, then from the two highest numbers on the list, the Senate shall choose the Vice-President; a quorum for the purpose shall consist of two-thirds of the whole number of Senators, and a majority of the whole number shall be necessary to a choice. But no person constitutionally ineligible to the office of President shall be eligible to that of Vice-President of the United States.

\*Later Superseded by section 3 of the 20th amendment as follows:

#### 20th Amendment

#### Section 3.

If, at the time fixed for the beginning of the term of the President, the President elect shall have died, the Vice President elect shall become President. If a President shall not have been chosen before the time fixed for the beginning of his term, or if the President elect shall have failed to qualify, then the Vice President elect shall act as President until a President shall have qualified; and the Congress may by law provide for the case wherein neither a President elect nor a Vice President shall have qualified, declaring who shall then act as President, or the manner in which one who is to act shall be selected, and such person shall act accordingly until a President or Vice President shall have qualified.

# Explanation of 20th amendment

Before there were no airplanes, fast cars and fast railroads time was needed for new members and the new president to settle their affairs at home before traveling to Washington to join Congress,

March 4 was initially chosen as the date both a new president and Congress would take office. However, as transportation and communications improved, this meant that the departing Congress and president would remain in office for an unnecessarily long time following the November elections.

By moving the beginning of the president's new term from March 4 to January 20 (and in the case of Congress, to January 3), proponents of Amendment XX hoped to put an end to the "lame duck syndrome (where those who were not reelected had little power to push through their policies), while at the same time allowing for a speedier transition for the new administration and legislators. The amendment was ratified on January 23, 1933.

Amendment XX also provides for succession plans if the newly elected president or vice president is unable to assume his or her position. If the president is not able to hold office, the vice president will act as president.

Amendment XX also gives Congress the power to pass legislation outlining a more detailed succession plan if the vice president is also not able to carry out the presidential duties until a new president and vice president are qualified.

# Chapter 7 The USA is a Constitutional Republic!

# A representative democracy

We introduced the notion of a Republic as defined by the Constitution in Chapter 3. In this chapter, we expound on this notion.

The Constitution prescribes that the US is a representative democracy, which as you will see, along with having an elected chief executive, a voice for the minority, and a Constitution also makes the US a Republic. The pledge of allegiance notes the words: "...and to the Republic for which it stands," for our country is both a constitutional representative democracy and a Republic.

When we think of the very important notion that "America is a representative democracy," watching the "not-so-committed representatives" from both Parties who occupy our central government, it is a sane question to ask if this is really true.

The song, "Is that all there is?" comes to mind. Our generations are nothing like our parents and nothing like our Founders. We have reason to be ashamed of our government today, but we can be proud of our nation as of November 2016 as we did our best to get our country back on the right track.

Before this major glimmer of hope, our country was so far off the Founders' mark that even appropriate shame was no longer politically correct.

The faux battle of the Electoral College as the vehicle, which denied Hillary Clinton the presidency has been well refuted already in this book. As a master gamesperson, Mrs. Clinton knew when she went for the high stakes, such as the presidency, there would be rules in the contest to determine the winner. There is lots of confusion about whether the US is a democracy or a Republic. Let me solve the problem right here and now. It is both.

A representative democracy is the foundation of America. However, what makes America—America—is that we are also a Republic, the finest form of government ever brought forth from mankind.

We also have a set of laws, beginning with our Constitution, the primary law of the land. These laws govern all people and all politicians in perpetuity—as long as we hold politicians (aka representatives) accountable.

The simple definition of a Republic (from Latin -- res publica, meaning is as follows: a state in which supreme power is held by the people and their elected representatives, and which has an elected or nominated president rather than a monarch.

In practice in a Republic, the government is ruled by elected leaders who officiate according to law. The basic law in our country is the Constitution. Unlike a democracy, a Republic is not based on majority rule. The law of the land, a Constitution gives the minority a voice. Even a majority cannot supersede a constitutional principal, such as The Electoral College.

Our biggest and most important laws within the US Constitution are written so that the government cannot hurt the people (US) or impose its will upon US. It is not a trivial statement to say that "the people rule."

Our country was founded by some very smart people and they knew that without constraints on any government, which could potentially go wild and bad, the people would not be able to win. Even if the people are in the minority, if the majority is on the other side of the Constitution, the minority wins. That's why we have the Courts System to protect the rights of aggrieved minorities.

The constraints in the Constitution are implicit in that all the rights are owned by the people, and only those rights explicitly given to government are for the government.

Rather than create their own term, today's Democrats have decided to coopt the term "alt-right" pejoratively. They more than imply that if you support Donald Trump, you're a white supremacist. Case closed. I suppose if you are alt-left, then you are anti-white, and pro-everything else.

Kieffer suggests that a strong offense is the best defense when fighting bullies. Her offensive move is to turn Hillary's words against her. She calls them the alternative-left "alt-left." They are the fallen angels from the one-time pragmatic Democratic ideals of John F. Kennedy and they have now embraced a radical "power at any cost" fringe philosophy of Saul Alinsky

and Bill Ayers. It works for me because it is true and very insightful.

The whole notion of the disrespect for the Constitution's Electoral College, and the validity of the votes in just states that Trump won, and not in those where Hillary had a slight margin is a manifestation of the alt-left in full regalia. U.S. Attorney General Loretta Lynch threatened to prosecute anyone who dared say anything that could be in any way construed as anti-Muslim—despite Farook and Malik being radicalized jihadist Muslims.
- 4.) Crushing Bakeries and Pizzerias: Alt-left protesters put a bakery out of business when the owner practiced her 1st Amendment right to free speech.
- 5.) No ID to Vote: Democrats do not want to know who is voting. Could politicians want to hide their attempts to buy votes from illegal immigrants?
- 6.) Double Standards: A Marine gets court-martialed for taking six pictures for his mom in a submarine but HRC has no charges filed for far more serious security violations

# Chapter 8 Legitimate Immigration Was Necessary

# Is immigration still necessary?

Americans are all pro-immigration to the extent of our laws and our needs as a country. If Americans were not pro-immigration for example, Columbus and his shipmates and their families more than likely would have withered away from disease or cold winters or they would have lost their battles with Native Americans.

All fifty states; at least the mainland forty-eight, would probably now have Native American names, and they would be run by the same financial wizards who run today's highly successful casinos.

After the USA was in operation as a country with a Constitution for just several years, its population was approaching 4 million people. This is just a million more people than the annual flow of illegal immigrants from south of the border.

On March 26, 1790, just more than 225 years ago, the second session of the first Congress (operating under the Constitution with a House and a Senate) approved the new nation's initial effort to create the rules under which foreign-born persons could become U.S. citizens.

From this point on, our borders were not open per se, and we had laws (rules) for how those wishing to be Americans could come to visit or to become Americans. All Americans after this point, who immigrated, were to follow the laws of the land. The Constitution was the supreme law of the land followed by federal laws, the state laws and then local laws. Today, our most recent past president along with Congress have decided not to enforce many of the laws that are on the books.

The Naturalization Act of 1790 specified that "any alien, being a free white person," could apply for citizenship, so long as he or she lived in the United States for at least two years, and in the state where the application was filed for at least a year. It took the US a while to do the right thing for former slaves. But, eventually, over 150 years ago, we got it right.

The new law also provided that "children of citizens of the United States that may be born ... out of the limits of the United States shall be considered as natural born citizens." Over the next thirty to seventy years, the Congress cleaned up the immigration laws so that all original residents of America, whether African or Native American were Americans – including former slaves.

In effect, the law originally left out indentured servants, slaves, and most women. But, it was improved. Just like Windows 10.0 was introduced over 30 years after Windows 1. Our immigration laws improved via from version 1 to the current version via thoughtful iterations.

These laws also mandated that one must "absolutely and entirely renounce and abjure all allegiance and fidelity to every foreign Prince, Potentate, State or Sovereignty." Though these terms were seen as quite generous, still the law denied the right to naturalize to "persons whose fathers have never been resident in the United States."

Immigration law was becoming more important and the laws have been changed several times since 1790. For example, in 1795, as anti-immigrant feeling began to grow, the necessary period of residence to become a citizen was increased from two

to five years. Sometimes the US has needed immigrants and sometimes not. In all cases, it should not be the immigrant's decision, it is the decision of the citizens of the United States. Immigration law became more firm as the nation aged and the leaders concern was focused on Americans and American interests.

Enter special interests, who like to bypass laws and have their friendly "owned" politicians let them get away with whatever. Regarding immigration, you already know that there are two major special interests. The first special interest is the Democratic Party, which operates as if all illegal foreign nationals should immediately be made citizens.

Smart Democrat politicos favor this because they feel the Democrat Party would never lose another election. That is a great motivator to bring all foreigners in immediately and make them all citizens of this nation.

Democrats no longer care about the families of citizens that built America and the families of citizens that have lived for a hundred or more years in America. That is why many Democrats said good-by to the Party of the fringe in this past election.

And, so, even though they have taken American jobs and driven down the average weekly wage, your Democratic Representatives in Congress still advocate amnesty and citizenship for them, promising less prosperity for all American citizens. They become "special" people. They see themselves as a cut above mere mortal men.

The social life in DC is lots better than most home towns, and our devoted representatives get to rub elbows with the hoity-toity, and the progressive Marxist communists that do not exist in their home areas. They get corrupted quickly and they seem to enjoy it. Shame on them.


My tell-all book on the Constitution called *The Constitution 4* Dummmies, is written so that we can all know the truth even when the corrupt media lies to our faces.

The Federalist Papers are a series of 85 articles and essays, written by Founders Alexander Hamilton, James Madison, and John Jay. The essays originally appeared anonymously in New York newspapers in 1787 and 1788 under the pen name "**Publius**.", a sixth century Roman patriot, general, and statesman.

The purpose of the Federalist authors was to convince the people that the best course of action was to ratify the US Constitution. There were also anti-federalist position essays available during the same time period. These are also available on the internet for free.

The Federalist Papers were original submissions to several New York newspapers so they would be read by the masses and the idea was that the masses would support the Consitution. Reading the Federalist Papers today is a must for every US citizen.

## The Electoral College Federalist # 68 Summary

**Federalist Number 68** is the sixty-eighth essay of The Federalist Papers. It was more than likely written by Alexander Hamilton,

though like all the Federalist Papers it was signed, Publius. It was submitted on March 12, 1788.

Entitled "The Mode of Electing the President," this essay describes Hamilton's view of the process for selecting the Chief Executive of the United States of America.

Hamilton was a prolific writer and wrote most of the Federalist Papers. His objective as noted previously was to convince the people of New York of the merits of the proposed US Constitution.

# 68 is the second in a series of eleven essays discussing the powers and limitations of the Executive Branch but it is the only essay to describe the method of selecting a president using the Electoral College.

#### Constitutional debates

The Constitutional Convention was a series of one debate after another. The method of selecting the president was no exception.

The objective was to find a way that would be agreeable to the bodies represented at the convention. Different plans were proposed, including:

The Virginia Plan: from Virginia Governor Edmund Randolph; which called for the selection of the Executive from the National Legislature.

Elbridge Gerry proposed selection by the state executives (governors).

The New Jersey plan was very similar to the Randolph/Virginia plan, but called instead for the possibility of a plural executive.

Hamilton initially supported a lifetime appointment for an executive, but he backed off.

James Wilson proposed a novel idea of direct election by the people, but he gained no support and for a while, it decided that the president would simply be elected by Congress, a body that had proportional state representation based on population.

When the Constitution was just about finished and in draft form, the idea of how the President should be elected came up again. Gouverneur Morris brought the debate back up and decided he too wanted the people to choose the president. James Madison agreed that the election of the people at large was the best way to go about electing the president. Madison did not rush to back the proposal however. He knew that the less populous slave states would not be influential under such a system, and so he backed the notion of an Electoral College.

## Hamilton and the Electoral College

Federalist No. 68 is thus the continuation of Hamilton's analysis of the presidency, in this case the concern was with the mode of selecting the United States President. In the essay, Alexander Hamilton argues for our modern notion of the Electoral College, though he added a provision for a tie. His take in this case would be that the determination would be made in the House of Representatives. The members would vote on the election of the president.

In arguing for the use of the Electoral College, Hamilton focuses on a few arguments dealing with the use of the Electoral College instead of direct election. First, in explaining the role of the general populace in the election of the president, Hamilton justifies that the, "sense of the people", through the election of

the electors to the Electoral College, should be a part of the process. The final say, however, should lies with the electors, who Hamilton notes are,

"Men most capable of analyzing the qualities adapted to the station and acting under circumstances favorable to deliberation, and to a judicious combination of all the reasons and inducements which were proper to govern their choice."

Therefore, the direct election of the president would be left up to those who have been selected by the voters to become the electors.

Why did Hamilton want an indirect election?

This indirect election is justified by Hamilton because while a Republic is still served, the system allows for only a certain type of person to be elected president, preventing individuals who are unfit for a variety of reasons to be in the position of chief executive of the country.

This is reflected in his later fears about the types of people who could potentially become president. He worries that corrupted individuals could slip into the mix—particularly those who are either more directly associated with a foreign state, or individuals. He was also worried about individuals who do not have the capacity to run the country.

The former is covered by Article II, Section 1, v of the United States Constitution, while the latter is covered by Hamilton in Federalist 68. In his essay, he notes that the person who will become president will have to be a person who possesses the faculties necessary to be a president, stating that,

"Talents for low intrigue, and the little arts of popularity, may alone suffice to elevate a man to the first honors in a single State; but it will require other talents, and a different kind of merit, to establish him in the esteem and confidence of the whole Union, or of so considerable a

portion of it as would be necessary to make him a successful candidate for the distinguished office of President of the United States"

Hamilton, while discussing the safeguards, argues that he is not concerned with the possibility of an unfit individual becoming president, instead he says,

It will not be too strong to say, that there will be a constant probability of seeing the station filled by characters pre-eminent for ability and virtue.

#### Rules on the electors

This is Hamilton's list of specific rules for the electors. They include the following:

- The electors meet only within their own specific states to select the president.
- No individuals who have "too great devotion of the President in office"
- No individuals who currently hold elected positions within the government may serve as electors.

## Selection of the vice-president

Hamilton also spent time wiring up his notion of selection for the vice president. He saw them following the same pattern as for the president, through selection by the Electoral College. He saw the US Senate as the tie breaker in an Electoral College Tie.

In #68, he also answers criticism that the Senate should have been given the power to select the vice president instead of the Electoral College.

Hamilton notes that there are two major arguments against that point: first, that the vice president's power as President of the Senate would mean that the tiebreaker of the Senate would be beholden to the Senate for his power, and therefore would be unable to make the necessary decisions as a tiebreaker without fear of removal or reprisal -- second, that the possibility of the vice president becoming president means that this individual should be elected by the people and the Electoral College, because all of the powers vested in the president could fall into the hands of the vice president.

Once you get back into these writings of the Founders, you will fully understand that they are the glue that keeps Americans free. They can help provide US all with liberty and freedom and justice forever and ever and ever... as long as we pay attention.

In this book on the Electoral College, please remember that the Founders gave a lot of thought as to how to elect a president with the least amount of potential chicanery.

Those of US, who read the Federalist Papers, though it is a somewhat arduous journey, know we have accomplished a lot. These papers—eighty-five articles written by Alexander Hamilton, John Jay, and James Madison, available for free on the Internet, quickly show US all that the Founders were very concerned that the bad aspects of any other foreign government would not become part of the new American Democratic Republic. Today's administration in Washington and some others would give the founders pause for sure.

The Founders were aware of politicians and all of their negatives; but since they never put the notion of welfare, food stamps, and cell phones in the founding documents, they did not believe that the people would permit the Republic to be tainted by notions like socialism, progressivism, Marxism, or communism.

After enduring tyranny from England and other monarchies, Americans fought for and won the revolution against England et al for the cause of liberty and freedom. So that liberty and freedom would continue as long as possible and perhaps, forever, the Founders built The Constitution.

Here we are 225 plus years later looking for hope and change rather than looking to the spirits of our Founders to rebuild our fallen country. Hope will deliver nothing when action by well spirited citizens is required but discouraged.

I have found so many people, including myself, who at one time have forgotten the many sacrifices of the revolutionaries and the gifts of freedom and liberty that were bestowed on all of US at the time of the revolutionary victory. All of these gifts have been emblazoned forever in our Constitution.

We Americans have been so blessed that we have not reminded ourselves enough over the years of our great heritage. Fourth of July celebrations are picnics, and though our parents have tried, the work of our Founders and the great Constitution they built as the basis for all our laws, is often lost in the celebration. Next boom you hear on the 4th, remember why and thank God for such brave men.

Neither freedom nor liberty come cheap so the next time an engaging politician offers you something for nothing, and in your heart, you know it is wrong; stick to your guns. Remember the words of Ben Franklin, a favorite US and Pennsylvania patriot:

"Those who desire to give up freedom in order to gain security will not have, nor do they deserve, either one." Amen!

## Chapter 11 The Electoral College as Proposed by Federalist Paper # 68.

## The Electoral College

It is appropriate to see again what the Founders had to say about the Federalist papers. The essay used to describe the Electoral College is Federalist Paper # 68.

This paper is reproduced in its entirety beginning on the next page:

## The Federalist No. 68 The Mode of Electing the President

Independent Journal Wednesday, March 12, 1788 [Alexander Hamilton]

To the People of the State of New York:

THE mode of appointment of the Chief Magistrate of the United States is almost the only part of the system, of any consequence, which has escaped without severe censure, or which has received the slightest mark of approbation from its opponents. The most plausible of these, who has appeared in print, has even deigned to admit that the election of the President is pretty well guarded. 1 I venture somewhat further, and hesitate not to affirm, that if the manner of it be not perfect, it is at least excellent. It unites in an eminent degree all the advantages, the union of which was to be wished for.E1

It was desirable that the sense of the people should operate in the choice of the person to whom so important a trust was to be confided. This end will be answered by committing the right of making it, not to any pre-established body, but to men chosen by the people for the special purpose, and at the particular conjuncture.

It was equally desirable, that the immediate election should be made by men most capable of analyzing the qualities adapted to the station, and acting under circumstances favorable to deliberation, and to a judicious combination of all the reasons and inducements which were proper to govern their choice. A small number of persons, selected by their fellow-citizens from the general mass, will be most likely to possess the information and discernment requisite to such complicated investigations.

It was also peculiarly desirable to afford as little opportunity as possible to tumult and disorder. This evil was not least to be dreaded in the election of a magistrate, who was to have so important an agency in the administration of the government as the President of the United States. But the precautions which have been so happily concerted in the system under consideration, promise an effectual security against this mischief. The choice of several, to form an intermediate body of electors, will be much less apt to convulse the community with any extraordinary or violent movements, than the choice of one who was himself to be the final object of the public wishes.

And as the electors, chosen in each State, are to assemble and vote in the State in which they are chosen, this detached and divided situation will expose them much less to heats and ferments, which might be communicated from them to the people, than if they were all to be convened at one time, in one place.

Nothing was more to be desired than that every practicable obstacle should be opposed to cabal, intrigue, and corruption. These most deadly adversaries of republican government might naturally have been expected to make their approaches from more than one quarter, but chiefly from the desire in foreign powers to gain an improper ascendant in our councils.

How could they better gratify this, than by raising a creature of their own to the chief magistracy of the Union? But the convention have guarded against all danger of this sort, with the most provident and judicious attention. They have not made the appointment of the President to depend on any preexisting bodies of men, who might be tampered with beforehand to prostitute their votes; but they have referred it in the first instance to an immediate act of the people of America, to be exerted in the choice of persons for the temporary and sole purpose of making the appointment.

And they have excluded from eligibility to this trust, all those who from situation might be suspected of too great devotion to the President in office. No senator, representative, or other person holding a place of trust or profit under the United States, can be of the numbers of the electors.

Thus without corrupting the body of the people, the immediate agents in the election will at least enter upon the task free from any sinister bias. Their transient existence, and their detached situation, already taken notice of, afford a satisfactory prospect of their continuing so, to the conclusion of it.

The business of corruption, when it is to embrace so considerable a number of men, requires time as well as means. Nor would it be found easy suddenly to embark them, dispersed as they would be over thirteen States, in any combinations founded upon motives, which though they could not properly be denominated corrupt, might yet be of a nature to mislead them from their duty.

Another and no less important desideratum was, that the Executive should be independent for his continuance in office on all but the people themselves. He might otherwise be tempted to sacrifice his duty to his complaisance for those whose favor was necessary to the duration of his official consequence. This advantage will also be secured, by making his re-election to depend on a special body of representatives, deputed by the society for the single purpose of making the important choice.

All these advantages will happily combine in the plan devised by the convention; which is, that the people of each State shall choose a number of persons as electors, equal to the number of senators and representatives of such State in the national government, who shall assemble within the State, and vote for some fit person as President. Their votes, thus given, are to be transmitted to the seat of the national government, and the person who may happen to have a majority of the whole number of votes will be the President. But as a majority of the votes might not always happen to centre in one man, and as it might be unsafe to permit less than a majority to be conclusive, it is provided that, in such a contingency, the House of Representatives shall select out of the candidates who shall have the five highest number of votes, the man who in their opinion may be best qualified for the office.

The process of election affords a moral certainty, that the office of President will never fall to the lot of any man who is not in an eminent degree endowed with the requisite qualifications. Talents for low intrigue, and the little arts of popularity, may alone suffice to elevate a man to the first honors in a single State; but it will require other talents, and a different kind of merit, to establish him in the esteem and confidence of the whole Union, or of so considerable a portion of it as would be necessary to make him a successful candidate for the distinguished office of President of the United States.

It will not be too strong to say, that there will be a constant probability of seeing the station filled by characters pre-eminent for ability and virtue. And this will be thought no inconsiderable recommendation of the Constitution, by those who are able to estimate the share which the executive in every government must necessarily have in its good or ill administration. Though we cannot acquiesce in the political heresy of the poet who says:

"For forms of government let fools contest --That which is best administered is best," --yet we may safely pronounce, that the true test of a good government is its aptitude and tendency to produce a good administration.

The Vice-President is to be chosen in the same manner with the President; with this difference, that the Senate is to do, in

respect to the former, what is to be done by the House of Representatives, in respect to the latter.

The appointment of an extraordinary person, as Vice-President, has been objected to as superfluous, if not mischievous. It has been alleged, that it would have been preferable to have authorized the Senate to elect out of their own body an officer answering that description. But two considerations seem to justify the ideas of the convention in this respect. One is, that to secure at all times the possibility of a definite resolution of the body, it is necessary that the President should have only a casting vote.

And to take the senator of any State from his seat as senator, to place him in that of President of the Senate, would be to exchange, in regard to the State from which he came, a constant for a contingent vote. The other consideration is, that as the Vice-President may occasionally become a substitute for the President, in the supreme executive magistracy, all the reasons which recommend the mode of election prescribed for the one, apply with great if not with equal force to the manner of appointing the other. It is remarkable that in this, as in most other instances, the objection which is made would lie against the constitution of this State.

We have a Lieutenant-Governor, chosen by the people at large, who presides in the Senate, and is the constitutional substitute for the Governor, in casualties similar to those which would authorize the Vice-President to exercise the authorities and discharge the duties of the President.

## Appendix A: The Declaration of Rights and Grievances

At the First Continental Congress, the delegates drafted several documents, and several drafts of documents, one of which was the Declaration of Rights and Grievances. This was a statement of American complaints. It was sent to King George III, to whom, at the time, many of the delegates remained loyal. It was not sent to Parliament since the delegates did not have the same level of loyalty to this body. Quite frankly, the document implored King George III to step in and rescue the colonies from the English Parliament.

The radical delegates were critical of this particular declaration because it continued to concede the right of Parliament to regulate colonial trade, a view that was losing favor in the mid-1770s. Many suggest that the actual cause of the American Revolution is found in this major historical document.

Articles of Association stated that if the Intolerable Acts were not repealed by December 1, 1774, a boycott of British goods would begin in the colonies.

## Appendix C The Declaration of Independence

On July 4, 1776, the Second Continental Congress, announced that the thirteen American colonies, then at war with Great Britain, regarded themselves as 13 newly independent sovereign states, and no longer a part of the British Empire.

## Appendix D The Articles of Confederation

The Articles of Confederation was an agreement among the 13 founding states that established the United States of America as a confederation of sovereign states and served as its first Constitution.

The Articles were used as the fundamental law of the US until the Constitution was ratified.

## Appendix E The US Constitution America

The Constitution of the United States is the supreme law of the United States of America. The Constitution, originally consisted of seven articles, which delineate the national form of government.

# Appendix F The Bill of Rights & Other Constitutional Amendments
