

Preface:

The first two items were about energy and the third was about the President being annoyed that some American corporations were not repatriating their earnings in foreign countries. In other words, the US was not getting the tax revenue. So, the only apparently meaningful thing in the president's speech on Jobs was actually about something else. Obama never cared about jobs. It's the only answer as to why!

The next point in his speech on "Jobs" was to "encourage American innovation." On the surface one could see how this could help the Jobs situation. The funny thing about the comment is that Americans have always been innovative. Look at the list of inventors and inventions of Americans from electricity to the iPad. In the write-up of the State of the Union, as a clarifying point the part about encouraging American innovation had a subtle subtitle (focus on clean energy).

Michael Moore, the well-known progressive filmmaker and liberal thinker loves using a basketball analogy to describe President Obama. Moore says that many times President Obama "fakes right and goes left." In other words, this artful speaker is often all words and no action or different action. Once he's convinced the folks that he is doing one thing, they relax and then right before their eyes he pulls the fake and goes left. He often gets away with it because nobody would expect him to be so obvious. He is the master of the unexpected. For example, most of us expected him to want to be a good president.

During the State of the Union, it was another presidential head fake. It turns out that there were few bullets of substance on jobs— mostly just lip service. His Jobs message was an energy message as the President at the time was quite desirous of having the Senate pass the Jobs killing Cap and Trade bill that had already passed the House. It is hard to be for Cap and Trade and increased Jobs! at the same time but Obama still thinks he is ambidextrous.

His second head fake was when he offered these two bones to Congress. Note again these are energy issues, not Jobs issues:

- ✓ Building nuclear power plants
- ✓ Exploring off-shore areas for oil and gas

If the President was interested in building nuclear power plants or exploring off-shore areas for oil and gas, we would have been doing this for the last eight year. But remember, he fakes right and goes left. Sorry folks, but on the Jobs thing, he was just kidding. Before we go back to the 2010 State of the Union, the defining speech of the Obama presidency, let's just see how well Mr. Obama has done on jobs.

Jobs! Jobs! Jobs! from inauguration to 2016

The President could not have liked Investor's Business Daily's report on jobs from March 2016. It brings us right up to date on success with Jobs so let's go over it now. I suspect there was too much truth in this analysis for Obama's tastes.

For example, the President has been bragging about a 14.4 million job growth number. That sounds impressive doesn't it? But the president's number is stretched over almost six full years, while other factors were changing concurrently. For example, during the same period, the working age population grew by 15.8 million. So, the normal growth to sustain jobs was not met. We were short by 1.4 million jobs. We have definitely lost ground on jobs under Obama.

Besides that, the supposed 14.4 million increase in jobs is measured against when the job market hit rock bottom in February 2010 after over a year of Obama, a big recession, and no prospects for an improved economy. If you compare the current number of jobs to the previous jobs peak twoyears earlier during the Bush years, in January 2008—which, by the way is how job growth is normally measured—the number of private-sector jobs has increased by just 5.6 million.

Additionally, when we include the period from 2008 instead of beginning at 2010, during the same time, the population grew by more than 20 million. In other words, there's what can be called a "*jobs gap*" of more than 14 million. That is a lot of jobs that Obama policies kept out of America.

Let's now look at the figure that the President does not want any of us to see. What about "labor force participation"? This is a measure of how many people are working or activity looking for a job. Admittedly, it has recently ticked upward, it is still way below where it was when the jobs recession ended in early 2010.

Let's put this in context with the Reagan recovery. If we compare the Administration's numbers to what happened during the Reagan recovery, when the job market exploded after bottoming out in December 1982. While the population grew 12.4 million in the following six years, the number of jobs shot up by 18.4 million. Yes, I said "UP!"

As a result, the labor force participation rate—which actually started out lower under Reagan than Obama since Reagan had to overcome the stagflation of the Carter years before the engine could start-up again—zoomed upward as strong growth pulled people back into the job market. Reagan had his eyes on jobs. Obama had his eyes on ideology.

There is even more context that Obama never discusses when he brags about his "great" numbers. We already established that 14.4 million jobs were created from February 2010 to March 2016. But, this is not so good when we look at the number of people who dropped out of the labor force -- either because they retired or just quit looking for work. The number of people who for one reason or another, were no longer collecting and could no longer find a job shot up by an astonishing 10 million.

Obama's record is one he should hide because there is still more. The number of people who aren't in the labor force but do want to work is substantially higher today than when Obama took office. And the median length of unemployment is now 11.4 weeks, which is also higher than when Obama took office.

Investors' Business Daily offers their conclusion: "In many areas of life, slow and steady will win the race. But when it comes to job growth, slow and steady ends up leaving millions of workers in the dust."

When we add to all of this the fact that the jobs created were not replacement jobs for manufacturing or meatpacking or Information technology, they were bartenders, waitresses, chambermaids, etc. and we know that the income per job is substantially less. Add again to this the desire for small companies to keep their workforces down so they do not get killed by Obamacare expenses, and so they will not hire their 50th employee. On top of this, those companies that need more hours from more people who do not want anything to do with Obamacare simply create 29-hour per week jobs. All of this adds to the fact that Americans are suffering and Obama has offered nothing for eight years. There are no jobs. Period.

2010 State of the Union-more "promises"

When the President got more into the Cap and Trade energy issues, he asked for more "investment" in advanced biofuels and clean coal technologies. Whether the President knows it or not, he sure does not acknowledge that American power is dependent on coal. That means that many jobs are dependent on coal. It is not clean coal at this point. So this has nothing to do with solving today's Jobs problem. Biofuels are a real joke as it takes substantial energy to produce these fuels. Americans must keep their eye on the ball watching for the head fakes.

The President gave another head fake. The fact is that his focus on clean coal had nothing to do with getting more energy or getting more Jobs. The focus was on the carbon dioxide that is produced from burning coal due to its impact on *global warming*. There goes that head fake again. He was not talking about energy or Jobs. Obama was talking about *global warming*. What can we believe? Not much folks! We have been victims of institutional lying from the highest levels of government on down. Yet there are still many who still do not see it

Call it a head fake if you like. Say, he just faked right and then went left if you like, but in Pennsylvania we have a name for that. It is called a lie. People who do things like that are not called head fakers, they are called liars, plain and simple. Yes, Obama was kidding about Jobs and from January through March, when Obamacare passed onto 2016, that was the last of his Jobs messages. He had more important things on his mind.

Clean coal was just another head fake

At some point even president Obama stopped talking about clean coal, which right now is a myth perpetrated by those who think they can con the environmentalists into seeing something that is not. A year or so after Obama's 2010 SOU, on July 14, 2011, American Electric Power announced it would table plans to build a carbon capture and sequestration project at its Mountaineer Plant in West Virginia. This ended the short-term notion of clean coal for West Virginia.

Yet, coal is really big in West Virginia. And, so, West Virginia University keeps looking for new ways of doing things that can make the technology even cleaner. But nothing in technology happens overnight. It takes a lot of research, and sometimes an idea takes 20 years to develop.

"If coal is going to be here for 250 years, we're going to need newer technologies as we go into the next 250 years that would make coal more energy efficient and make it easier for us to extract these technologies in a cleaner way with less damage to the environment," said Richard Bajura, director of the National Research Center for Coal and Energy at West Virginia University. That day is not here yet but recreational basketball and head fakes to the people are a real thing for sure.

Coal is extremely energy rich and it would be good if a little soap could clean it up. A single fist-size lump of bituminous coal contains about 12,000 Btu--enough energy to power a 75watt bulb for two days. Coal is relatively easy to dig out of the ground and it is still dirt-cheap. Coal costs about 1/6 of oil or natural gas per Btu. Like it or not, a substantial portion of the industrial world was built with coal power and coal keeps it going.

Of course coal has issues. Its ashes are not very pleasant nor is its smoke. We might call these sooty particulates. Coal also has sulfur and nitrogen compounds. These cause acid rain. And, yes, there are traces of mercury and other toxic metals in a wad of coal.

Despite the challenges of purely clean coal, coal-fired power plants are much cleaner than they once were. They are still considered bad news for the environment and human health. Despite this, it is a sure thing that in the northeast especially for many years before the natural gas revolution in the late 1960's, there would have been hundreds of thousands of deaths if there were no coal to heat homes. The question then was can death by freezing during an excessively cold and dank winter evening be a better deal than expiring from an abundance of sooty particulates over a minimally shortened lifetime.

By the way, there is no such thing as an average lifetime. My grandmom and grandpop lived well into their eighties. Gene Wilder, one of my favorite actors died this past week at 83. Gram and gramps lived in our home until they died. We had a Heatrola Stove in between the Dining Room and the Parlor and there was a Wilkes-Barre Stove in the kitchen to heat that area, cook, and provide hot water for the house. We had no furnace.

We took the ashes out and dumped them in the back yard in an area where grass refused to grow. Chicken or Egg? I would bet that my grandma and grandpa would say if asked that coal lengthened their lives. It is a matter of perspective.

The environmentalists would rather people freeze to death than have any emissions at all. It is no coincidence that many leading environmentalists are also major population control proponents. Any motivation that elevates a certain chemical composition of the atmosphere above human life is misguided at best. So, a few frozen bodies every now and then is preferable to some environmentalists than a disfigured tree a bit too close to a nearby coal chimney.

This is not a moral or immoral book though some might argue that no jobs when there can be jobs is a moral issue. Few Americans that I know would carry it as far as major elites in our society such as CNN Founder Ted Turner's perception of how to make sure the environment is clean and safe for him: " "A total population of 250-300 million people, a 95% decline from present levels, would be ideal." Why guys like Turner are not interested in more coal deaths is a mystery indeed.

A recent study concluded that coal emissions contribute to 10,000 premature deaths in the United States each year. I'd like to see that study. How do they know? Besides early deaths, they say that coal is by far the largest single source of greenhouse gases in the U.S. So it is no surprise that coal has long been the primary target of proposals to cut air pollution and carbon-dioxide emissions. One might ask with all the emissions going on in the world, especially China, how is it that anybody or anything is alive?

Just in time to skirt the various plans to cap or tax CO2, coal is getting rebranded. In my opinion, this is claptrap. The new buzzword we already discussed is "clean coal." It is a high-tech, low-emissions fuel of the future. I don't doubt coal can be made cleaner and it should but it will never be clean and clean coal is certainly not an option today. If it were, the US would become the "Saudi Arabia of clean coal overnight." By the way, we are already listed as having more gas and oil than Saudi Arabia or any other country.

One might ask: Why try to reduce our dependence on coal today when fabulous, guilt-free clean coal is just around the corner? The facts again speak loudly: Coal will never be clean. It is possible to make coal emissions cleaner and as noted previously, we should go as far as economically possible to do so. But coal as an energy source has helped my family live our lives in a warm home. It also has provided many jobs to many family members and others in Pennsylvania and other states. It sure can be called a poor man's fuel but it is a powerful energy source for our country. Let's be clear. We should continue research into making coal cleaner--that fuel will be a vital part of our energy mix for decades. Right now it is just a good thought for the future. Meanwhile we have a lot of work to do to create real-world energy alternatives that work today. All of this work and the energy we get adds to the number of jobs available and that is a good thing.

Obama, the "Jobs Man" made just a few comebacks in eight years

It was Obama's first huge fraud on the American people but it benefitted his friends.

Mallory Factor, a political science professor at The Citadel, pointed out in his recent book Shadow Bosses that this huge amount of money—almost \$1trillion created few jobs, but had more to do with lining the pockets of public employee unions:

First by favoring unions only:

As the Wall Street Journal noted, 'There's almost a direct correlation these days between the Obama Administration's complaints about 'special interests' and its own fealty to such interests. Consider the latest decree that federal contractors must be union shops." The Journal was referencing Executive Order No. 13,502, which President Obama issued during his first weeks as President. The Order encourages federal agencies to enter into Project Labor Agreements or PLAs, with labor unions on projects of more than \$25 million. As the Journal noted, "Only 15% of the nation's construction workers are unionized, so from now on the other 85% will have to forgo federal work for having exercised their right to not join a union." In contrast the Bush had preserved open competition for work on federal construction projects by expressly prohibiting PLAs.

By favoring unionized workers, PLAs restrict competition and drive up costs of construction projects about 10 to 20 percent – great for unions, but terrible for taxpayers...

It protected government jobs which protected union jobs and thus protecting union dues.

Of the initial stimulus spending, a whopping \$115 billion was earmarked for education spending like the "Edujobs" program. The program is called Edujobs to focus the public on the fact that teachers' jobs are saved by the program. How did that work? The federal government gave money to the states, supposedly so that states didn't have to lay off teachers. But money is fungible – all this money didn't necessarily go to preserve teachers' jobs. The states basically used this cash to plug holes in their budgets generally and to delay necessary spending cuts – not just to education but to other government services as well. Of course, the discussion is framed in terms of preventing your local teacher from losing her job. The teachers unions are able to pub a face – your local teacher's face – on the budget cuts to get you personally interested. As a result, stimulus spending for education is much more popular with taxpayers than stimulus spending in general... From the teachers unions' perspective, this spending is essential to keeping dues income up. By retaining teachers in forced-dues states, teachers keep paying union dues. If states have to reduce the number of teachers and school workers thanks to the budget crunch, teachers unions get hit.

While the stimulus didn't create many education jobs, it does preserve existing government jobs – and in most cases, that means union jobs. The U.S. Department of Education claims that the stimulus created – or, more accurately, – retained – 367,524 education-related jobs during 2009 – 10 school year, which if true would have also preserved at least \$165 million in teacher's union dues annually, (pg. 91-92).

[If you were not a union-dues-paying teacher, you did not see a dime of this money]

President Obama also through the stimulus monies funded public employee unions directly as well:

Not only did stimulus spending protect dues income, but Obama sent the teachers unions some more goodies. The AFT Educational Foundation received just under \$5 million in stimulus via the Investment in Innovation Fund, which gives grants to applicants – that is, other liberal organizations – with a supposed record of improving student achievement. According to the AFT, the goal was to create "evaluation systems" for the teachers. Because, really who could be better at designing and implementing evaluations of teachers than their unions right?

Would it not be nice if government officials had to take lie detector tests at the end of every business day in order to be released to go home? Because Obama blew all the money on pet projects and opportunities to pay people to vote for him in term # 2, the economy, went neglected. Jobs! Jobs! Jobs! went neglected.

That's why our officials in Washington from the President on down focused on Obamacare instead of the economy? Nothing they tried had worked because they had tried nothing. Essay 4 Worker Visas Take Many American Jobs

The Visa program is often abused

The US Visa programs have been used by corporations and a complicit Congress & President to sell out American intellectuals and skilled service workers in recent years. Ask your kids who live with you if this has helped them increase their wages. In most cases, it gives our kids jobs to a foreigner on a short-term worker visa who has yet to become illegal.

The scam continues even while Americans are unemployed in record numbers. The Visa Program had noble beginnings and there is no obvious problem with the type of people who come in on visas. However under certain visa types, employers get a big bonus as they can access foreign technical talent for slave labor wages. Ask them and they will give you a Sergeant Schultz: "I know nothing!" Exactly!

When I was an active IT Consultant, one of my clients was able to obtain an H-1B visa for an executive. He worked for a song along a bunch of fat cats that ate steak and lobster every night. He ate well but no steak! He was a very bright guy. They were not the nicest of employers. His salary was about 1/3 of the other executives. If I had not witnessed this myself, my words would not be as convincing.

Why was that? Why was his salary 1/3 of the other executives? Because he was in many ways an indentured servant to the

company. If he messed up or made any demands, they held his right to his visa, and he would be back in South Africa at the drop of a hat.

As a demonstration of how endearing this company was to the foreign worker, when he finally became a citizen, he immediately gave his notice and moved to Florida. They could not do without him. Payback is a bi----. He commanded a full executive salary while in Florida and he had a full time job there besides. Some stories work out well.

The point is that foreigners will work for substantially less wages than their American counterparts in high tech jobs. Engineers, computer techs, and many people in many other occupations want to live in America. They make lots more than from whence they came and most are placed on a track to a green card and ultimately citizenship by their corporate sponsor.

As with my friend, those on such Visas do not have a real picnic before they get citizenship. Their job is to please their masters who know their plight and they know they are ripe for abuse in the workplace. They will almost do anything not to be deported and so they do what they must to satisfy the whim of their corporate sponsors. Ironically, they are far easier to deport than an illegal for if they cross their "massa"... they are done.

One of the first spigots to get shut off when the US entered this recession eight years ago was the influx of legal foreign workers. I did not happen. Who needs 'em? But, your Congress took no action even as the unemployment rate shot up to 10%. Yes, your Congress has been complicit in the Visa programs that kill American jobs and which take advantage of the job receivers. It is only fair that whatever is left from the five last pitiful Congresses should be left jobless after this next election and perhaps somebody will pick them up for the minimum wage, or hopefully a lot less!

In my book, Taxation Without Representation (now in its third edition and available at Amazon and Kindle), I wrote a chapter on how American Corporations exploit foreign workers as well as Americans with their special government sanctioned Visa worker programs. There are over 80 different Visa programs and the H-1B is just one program that brings in 65,000 at time each year. For a few years Congress permitted corporations to bring in over 100,000 a year. Their time limit is 6years and so at any one time there might be 600,000 high tech workers in American taking our kids (college graduates) jobs.

Congress stacks the deck against Americans . Some of our trade agreements, for example, such as the WTO, have insisted on our continuing use of the H-1B program to help foreign nationals come to America. Why does the WTO get a say? And, so some suggest that we cannot summarily stop the H-1B spigot. I say we are a sovereign nation and we are in a recession and we can dam well do what we please to help our country before we help one foreign entity.

As with most trade agreements, we were out-snookered by our "adversaries: unless we went in with a give-up strategy which is more likely. Donald Trump, a master negotiator, would love to go up against any of the buffoons that negotiated the mericalast trade agreements of which we are saddled.

I joked with my Marywood Operational Management classes that in trade talks, the US negotiators are the worst able at the table. It's like as if they could do the job, they would not be chosen. It is as if they are programmed to lose. Trump knows this but he can only say so much.

I suggest to my class that it would be far better for the US to ship in a huge block of granite or even a massive pile of feces (sorry!) and place it in the area in which the US negotiators would have been placed. The block of granite or the hunk of feces would have served America's needs far better than the losers who actually sat at the table. At least we would win every now and then. With Trump, we will win all the time. The H-1B is a terrible loss for America's best workforce, its college graduates -- our best and brightest. It is a program that at any point in time is sapping almost 400,000 jobs from the economy. It is a travesty for American workers but especially bright students graduating from America's finest Universities.

They are unemployed while they find their potential jobs taken by foreigners on Visa programs so that corporations can save money on wages. And, yes, there are times when the new H-1B worker comes in and replaces an American making two to three times as much income. The American has the pleasure of training the foreigner prior to his or her getting fired. It's not the way it is supposed to be in America. Obama, not having lived here and learned our customs perhaps does not know this.

H1B Visas for FY 2010 & 2016

We do not have to go all the way to 2016 to begin to chart the problems. For the Fiscal Year 2010 (FY 2010), the US accepted applications for H1B visas. We were in the middle of a huge recession and we were still bringing in foreigners to take the jobs of American college graduates. I find that hard to believe. Yet, it is true. Our government has chosen not to protect America or Americans.

Further proof of the Congressional Deaf ear to the plight of recent college graduates is that they actually tried to make it worse in 2013 for this last year and this year and they are likely to try again. There was proposal in 2013 to increase H1B cap from **65,000** to 110,000 and Masters quota to increase from **20,000** to 25,000. It did not go through as of March 2015. At least, for this FY 2016 season, the quota is fixed and it will be as above and no changes.

The H1B is a nonimmigrant classification used by an alien who will be employed temporarily in a specialty occupation or as a

fashion model. Too bad nobody in the US can fill the bill. This really is crap and you know it is crap and Congress is still bringing in 65,000 foreigners a year under this one of 80 Visa deals to take American jobs. Ask Matt Cartwright or your own Congressman about that! How when Americans are unemployed can we think it is OK to bring in competent workers from overseas who will work for dirt cheap wages to become citizens?.

The filing deadline for H1B visas for Fiscal Years is typically April 1. Under current law, an alien can be in H-1B status for a maximum period of six years at a time. After that time an alien must remain outside the United States for one year before another H1B petition can be approved. Certain aliens working on Defense Department projects [DOES THIS MAKE ANY DEFENSE SENSE?] may remain in H1B status for 10 years. In addition, certain aliens may obtain an extension of H1B status far beyond the 6-year maximum period. Meanwhile a fresh college graduate is unemployed.

As noted the current law limits the cap of H1Bs to 65,000 as the number of aliens who may be issued an H1B visa or otherwise be provided H1B status in a given year. There are 50 plus other Visa programs. Why is this when Americans cannot get jobs? Ask Matt Cartwright or your own dedicated and serving Congressperson. They don't get it.

BTW, because Visa holders are documented, that may be why border jumpers are called undocumented? What about the Visa holders who just never go back, and choose to just blend into the US landscape? Does documentation really matter to the unemployed American worker? At least half of illegals are visa overstayers and since nobody is asking corporations about their employees, after the visa expires, these guys still get paid but not much.

The following quote is from the first version of my book, Taxation Without Representation:

Onshore vs. Offshore

"The big difference between losing your job to a person with an H-1B Visa and having your job offshored is whether the person who gets your job will be playing a home game or an away game. If they get to work in their own country, say India for example, then for them it is a home game. Your job has been offshored. If instead, they get an H-1B Visa, then they get to come to the U.S. to take your job. In the latter scenario, however, your company or the company that would have hired you first lies about your availability to work or they would not get the H-1B Visa slot. The next lie is that they will pay the H-1B Visa worker or any other work Visa, the same pay for the same work that you would have done. Yes, Virginia, Santa Calus is employed by foreign agents today.

Government lies and accept lies as if their own rules do not matter.

The book quote continues past the next heading:

Visa alphabet soup

"We can always thank the Greeks for the alphabet, because overall, the U.S. Visa problem is not stuck on the letters H1B. There are several visa types for just about as many letters fashioned for us by the Greeks and Phoenicians many, many years ago. As you would expect, in addition to H1B, there is an H1A, and there are visa types that start with A and go to T with many variants within those letters. Right now, there are 81 different visa types, each promising somebody in the world the opportunity to come to the U.S. for one reason or another to take an [American employee's job.]

"I have reworked a table from a government site and it is shown in our Table 7-1. To see the whole table, rather than type the four line URL, just type Immigration Classifications and Visa Categories into your browser and you can see the full chart and all of its meaning.

"Actually there are so many Visa types that foreigners interested in coming to the U.S. often use the one type of Visa that they can get rather than the type of Visa that they actually should get for the type of work or study that they are hoping to do. It is a bureaucratic nightmare that only a desperate noncitizen or a lawyer could be paid enough to want to fully understand. That's why the latter make a lot of money on the former trying to squeeze them in."

It is clear that corporations have figured out that they do not have to export production to less developed countries to achieve low labor costs and to find a nice place in which health, safety and environmental enforcement is merely a wink and a nod away. Finally, they don't have to look to developing nations to find a vulnerable, exploited worker class since they have been able to create one right here in the good ole U.S. of A. This pool of illegal workers combined with those on Visas accepts low wages and depresses the entire wage scale so that Americans formerly engaged in these industries can no longer earn a decent wage.

What is the solution?

It really is simple. The only reason that these programs exist at the numeric levels they do is that corporations own your Congress. The solution is not to shut off the opportunities for Americans to mix with foreigners but to limit their numbers so that they do not become inexpensive replacement players for standout academics.

When has Matt Cartwright, my Congressman suggested that this might be an issue for Americans?

Who has ever told you this is an issue? Let me be the first. I wrote about it in my first patriotic book and I say it again for all

to hear. The way this program is used is a travesty. We are not talking about students. Sometimes we are talking about Professors who will work for peanuts. We are talking about workers who are in advanced areas and for the promise of a green card or the right to eventually live in America, they forego six years working for minimal wages while Americans either more so or at least equally qualified remain unemployed.

Americans expect to make a decent wage and none of us are depending on the good will of a corporate manager to decide whether we get put on a fast track to citizenship. Thankfully we are already citizens but our Congress denigrates us and denies us our natural opportunities. What a shame! What a sham!

Can we not all agree to send all 435 members of Congress and the 100 Senators home packing--most in November and the rest when their time comes--for the harm they cause American workers and visitors who should go home loving America. They have no right to stay. They agreed to go home to get the visa but they do not go home. But, why in the first place should they be granted your child's job for six years before anybody thinks about giving them the boot?

As with all the problems we identify in this book about Jobs! Jobs! Jobs!; there is an essay, aka a chapter, coming soon that offers real solutions. Your current Congress has chosen to not consider making it better. So, let's make sure they do not have the opportunity ever again. For America, we have a general election coming.

If you choose to vote for an incumbent, then you had better have the courage to ask your guy or gal what they will do under circumstances as presented in this book. If you do not get what you want from those in the finer class, boot them out. Tell everyone you know to boot them out now. I do not care if they are R or D or L or I or C or whatever, if they are not for America, their time is up! Good Bye!

Essay 5 Offshore Outsourcing Is a Jobs Killer

Outsourcing is not always offshoring

Outsourcing has been with the world for thousands of years. The sale of food, tools, and other goods from one community to another is a form of outsourcing. If you don't grow your own food then you outsource its acquisition. Outsourcing is a necessary facet of every business and it is practiced by every company because nobody can do it all. Offshore Outsourcing as practiced by American corporations, or as it is simply called, Offshoring is simply anti-American. It happens when the business believes it is so important that the workers and the country in which it is franchised, no longer matter. We can fix this!

There were US companies in the 1800s and 1900s who were vertically integrated and thus, they did it all. Rugged individualism was the credo of the day, and if you could not do it all, you could not compete. These companies took care of their own production, mining, manufacturing from raw materials, building finished goods, shipping the goods, and they sold the end products in their own stores.

Many of these companies even went so far as insuring themselves; handled their own bookkeeping and taxes; had their own lawyers etc. Some even designed and built their own buildings as it was viewed as the proper way to expand their enterprises. To do that, they required a major diversity of talent. That was then! Eventually, in American History, it no longer was a matter of pride that a company did it all. It became very difficult to have all the talent required in one business and so companies began to concentrate on what are now called their core competencies. For example, furniture manufacturers began to get their wood from loggers rather than maintain their own forests.

Other manufacturers began to bring in raw materials that were in a more finished state from contractors -- steel sheets rather than iron ore. This is how it began. It has always been with us but it was never designed to hurt American workers. It was to give smaller manufacturers the opportunity to compete.

As service companies began to emerge, the manufacturing companies found it more productive to do business with these firms and gain a number of other services. Firms could never be the best in specific areas that were simply adjunct to their core businesses by relying only on in-house expertise. In the industrial revolution, there was a large growth in the service sector as manufacturers began to purchase needed skills. This was the first form of outsourcing.

Companies needed insurance services, architecture and engineering services, legal and accounting services, and many others. At this time in the U.S., the companies performing the outsourced work were almost always located in the U.S., and most often in the same city, just like their customers. Therefore it was not against national interests to outsource parts of the business to domestic firms.

Corporate globalization takes outsourcing offshore

As the economy became more global as fast ships and large airplanes and fast voice and data communications channels were established, this permitted people and goods and information to be moved rapidly from country to country. Because of these advances, it became feasible to move activities that were once done on-shore in the U.S. to a foreign country, off shore. This process is known as offshore outsourcing or simply as noted previously, "offshoring."

At first it was an experiment but the ingredients of success were in the cards. As relationships were formed in developing countries, it became easier and easier for the next company to do the same thing. Facilitator service companies emerged who would set up the whole offshore deal for any company that did not know how to get it done. In the beginning of course, the outsourcing channels were not greased as well as they are today.

Companies of today, who are ready to outsource, no longer have to do the work themselves. They outsource to "facilitator companies," such as IBM, to gain the outsourcing / offshoring expertise. There are many such firms that are now in place to expedite the entire process.

For the US companies that employ such offshoring avenues, it does help that they write their checks for offshoring to companies such as IBM so that it does not appear to the uninformed that they are un-American. Yet, they are un-American and IBM is un-American and it is time we call them out and show them all for what they are. I am sure you all remember the biblical saying: "If you are not with me, then you are against me."

In the last ten to twenty to perhaps even thirty years the notion of offshoring has become as commonplace as outsourcing onshore had been. Moreover, it has gotten more and more positive press in the business community. It has become very popular, especially in large companies in which business titans and the stockholders believe their company must be as modern as the times permit. Additionally, the big consulting firms have been recommending offshoring as a solution for bad American management for many years now. The tide for years had been against any American working for a corporation to believe they would be able to do their work in America.

In some ways it has now become a corporate management status symbol to have production and even IT overseas, besides just a way of doing business. Companies that have decided to stay American are belittled sometimes by their elite peers and industry moguls for not having taken their businesses overseas. Another little told secret is that even though the corporate big shots would argue against this premise, offshoring often provides little benefit for the sending country. Nonetheless it is true. It will get worse as Americans realize which companies are not American and they have another buying choice.

Low tech jobs were the first jobs to go

The first types of products to be manufactured overseas were the low-tech items such as toys, shoes, and other apparel goods. Eventually, higher value items like high-tech components, computer chips and wafers, and consumer electronics began to appear.

There are no televisions or VCRs or DVD players or Apple Cell Phones made in the U.S. today but who knows that? Apple Computers and iPod and iPhones, and even the new IPad are all made in China. How does that make you feel? I might be for legislation that required Apple's Tim Cook to buy all his food from China. Hey! Why not?

The iPad may have been designed in the United States, but Apple's money-spinning products are manufactured in the hightech factories of East Asia. Asia expects a big uptick thanks to Apple. India is also booming because of US jobs brought there by big name US corporations like IBM and Microsoft, Apple, and others. Welcome to America?

How did we lose the stimulus' green jobs & more?

Over 20,000 green jobs have been shipped to India using our stimulus package. How's that for smart leadership? What was the real purpose of that? Companies used the stimulus money to create jobs in India, and our Congress merely winked. No it isn't fair. Congress needs a replacement ticket.

They argue that there are jobs from green in America but they admit that those jobs are low-wage installation and construction jobs. Though you may think India is where the cheap, low-skill jobs go, this is not true. For the green jobs, India has gotten the very finest and the high paying jobs. Can it be that the US is full of dummies? Ask Congress?

While the US suggests that high speed rail is impractical, more stimulus money will be given China to build, and operate a high speed rail system in California. The Chinese government has been working with the State of California and General Electric to help Schwarzenegger (Governor when project began) get these lines built. American taxpayers are paying.

At least the work will be done in the US but the US has no skills in the area so Chinese engineers will be brought to the U.S. Ironically, 150 years ago, low-wage Chinese workers were brought to America by the railroads for the back-breaking work of setting up the US rails system. So much pressure was exerted that the Chinese rail deal is off so let's not worry about it anymore. But, we should worry how China is so far ahead of the US in rail technology per se. How'd that happen when GE is the biggest diesel engine maker in the world. Is GE no longer favoring American firms? Does GE no longer have plants in America?

Let's get the answer. In 2015, GE Power & Water plans to stop manufacturing gas engines in Waukesha, Wisconsin and open a new facility to build engines in Canada. GE was a pioneer in

taking jobs from America. Never very patriotic, this new Canadian Plant may be in North America but it is not in the United States and it took jobs from Wisconsin. This is the kind of stuff Donald Trump will stop flat.

For far too long, manufacturing trends have been characterized by an emphasis on American companies sending operations overseas in the name of cutting costs and acquiring new business in emerging markets. There was no concern that these companies were leaving Americans way behind in their wake

The American exodus began in the late 1970s and 80s, as large multinationals such as GE began offshoring production and outsourcing to foreign contractors in low-wage environments like China and Southeast Asia, paving the way for mid-market companies to do the same.

According to the top GE guy while the pillaging of the US by GE was occurring, Jack Welch, former CEO, who was a pioneer of the practice, showed no remorse. Instead of a desire to make GE more American, Welch quipped that it would have been ideal to "have every plant you own on a barge to move with currencies and changes in the economy." Thank you Colin Kaepernick., whoops Jack Welch, for your expression of freedom in moving GE out of the USA. America appreciates your patriotism.

Indeed, GE would continue in the Welch years and with Jeffrey Immelt as CEO to send more and more of their manufacturing operations abroad. In fact, GE was so bad they pushed their parts suppliers to also make the move. Across industries, production continued its overseas migration, sparking similar moves among mid-market companies. It was the thing to do. To H___ with America!

China will take all of what America's lack of patriotism will give them. Donald Trump often speaks about the business savvy Chinese beating the US around the world because of dirty tricks. One thing is for sure. The Chinese are not just interested in building trinkets any more. The Chinese take pride in the fact that they are a big exporter and pioneers in bullet trains traveling 215 miles an hour or more. What happened to American business pride? This environmentally friendly technology has permitted China to race past the United States in the last few years.

Soon, now that the President has shut down NASA, and the US is officially out of the Space Race, China and Russia will be taking our astronauts to the space station and back. The truth is that US firms have fought so hard for profits, they have hurt the US in its ability to be a real player on the world's high tech stage.

Regarding the California rail experiment, As everyone knows, there are no high-speed trains manufactured in the United States." Thus the inflexible requirement to use US technology had been a fundamental barrier to financing high-speed rail in the US from day 1. For the past 10 years, the Chinese had patiently waited for policymakers to recognize high-speed rail in the United States as a new enterprise and that allowing trains from countries with decades of safe high-speed rail experience was needed to connect the Southwest region and start this new industry. Unfortunately, for its own reasons, the US is against rail as a national policy. I think that is stupid but more stupid would be for the Chinese to build rail in the US.

I have written a number of articles over the years about rail. After my research I proposed an extensive railway network for the US and offered my research and additional research into improved passenger rail and high speed rail in the US. I also wrote a book titled *Take the Train to Myrtle Beach*. Part of the message in the book is that you cannot get there from here. And, that is a chain.

There are a lot of jobs in a railroad revitalization in this country. In my book, in addition to showing why rail is a great mode of transportation across the world, I show how you can get to Myrtle Beach from anywhere in the Northeast even though you have to stop your trek in Florence SC and rent a car for the last 100 miles to Myrtle Beach. Rental car companies in the area will be happy to pick you up at the Florence Train Station.

Having an interest in passenger train service in the US, especially High Speed Rail, I am most supportive of the US High Speed Rail Association. Donald Trump is going to latch onto their work and piggy back from it to a transcontinental railroad revival—this time with high speed rail.

Their mission is to build widespread public, business, and political support for a major investment in a national high speed rail network.

USHSR is the only organization in America focusing entirely on advancing a state-of-the-art national high speed rail network across the country. They are an independent, nonprofit 501(c)(6) trade association chartered to organize and mobilize the industry with a shared vision for a 21st century, 17,000 mile national high speed rail system built in phases for completion by 2030. Though I like that...I think we can do better. This new national electric transportation project will revive our economy and manufacturing sector by creating millions of new jobs. It will be the catalyst for the next real estate boom, significantly reduce our dependence on oil, shrink our national carbon footprint, reduce congestion, and create efficient mobility that's safe and affordable for its passengers.

Vision

Our vision includes a national HSR Express system connecting cities and states into an integrated system, laid out in phases with an aggressive schedule for full system build out. Our vision sets high standards for interoperable, state-of-the-art dedicated track, advanced control systems, elegant multi-modal train stations, and top-of-the-line 220 mph trains connecting major cities together. Our plan calls for a support network of 110 mph trains connecting smaller cities and towns together with the high speed system.

I love the idea but I also like the idea of an extremely fast high speed cross country train from Washington DC to San Francisco. The Chinese could build it for us tomorrow. Shanghai Maglev, also known as Shanghai Transrapid, was once the fastest train in the world. CRH 380A running between Beijing and Shanghai, was manufactured by CSR Qingdao Sifang Locomotive & Rolling Stock. AGV Italo, touted to be the most modern train in Europe. It has a maximum operational speed of 360kmph as of Aug 29, 2013. Things keep getting faster—even computers. Japan now holds the record. Japan's new maglev bullet train is now the fastest in the world. Japan Railways' latest mag-lev bullet train just broke its own record as the fastest train in the world. The bullet train travelled at 603 kmph (374 mph), blowing through last week's top speed of 590 kmph (366 mph).Apr 22, 2015.

A flight from Washington to San Francisco typically is 2441 miles. Using 366 mph and 2441 distance, the theoretical best time that a train can make the run cross country straight shot would be 2441/366 = 6.7 hours.

To go coast to coast on the ground by train in less than seven hours. Are you kidding me? We would be building transcontinental railways and intercity underground railways for ages to come. Unleashing US energy the Trump way and we can pay for building the system and we can power its American Made GE Diesel Engines for almost an eternity. Who'll be the first to buy some shares in this great new American Company?

Green Jobs!

The new green jobs coming from the US to India include engineers, strategic business management, and major support technicians. These folks are the innovators and are the ones designing the innovative environmental friendly solutions. If you are in India, you can get some good US jobs such as sustainability engineers, marketing and business development executives, data center management engineers, utilities and electric engineers and quality specialists. Pittston PA plant abandoned

Even the analog television faceplates, which were once made by Owens-Corning and later Techneglas in Pittston Pennsylvania are now made in Korea. Over 600 employees lost their jobs. So, discrete manufacturing was the first activity that began to move to offshore destinations in the corporate quest for significantly lower labor costs. I must ask you as a reader, is there anything about American workers losing their jobs because American corporations found a "cheaper way" that you find admirable?

Yet, these corporate economic traitors are protected by our government with endowed rights and privileges to do business in the United States? Why is that? It surely time for that to change, and as you will see in the later essays in this section, I have a plan that means business. And, for US workers, it means good jobs.

Nobody really shows the costs but with energy costs once sky high and now down somewhat, think about the cost of shipping today. Do you think there is much savings for products made in country X if the product must be shipped back to the US? You are right. The wage rate and the tax rate really does not make up for all of that. For products that otherwise would be shipped across the world, however, US companies make a lot more money and save on taxes by doing business outside of the U.S. Maybe it is time to send in some replacement players for these corporations?

Some argue that India and other countries create a better college graduate prepared better to engage the workplace. As a professor, with grade inflation rampant and student evaluations forcing professors to give more A's than anything else, some of that is true. So, yes, US education from K-12, and from Bachelor level to PH.D., all must improve so America again can be the best in all it does.

The corporate income tax is jobs' bad guy

The real culprit for greedy US corporations to turn their backs on America is the corporate income tax. Just look at the balance sheets of American corporations who do lots of work overseas. These companies have figured out how to stiff the US corporate tax system by doing business in foreign countries, and keeping their profits without declaring taxes. Donald Trump knows the system and he will bring equity back to the American people from those who take advantage of us.

The jobs are not about to come back immediately for lots of good reasons. Companies make too much money to ever decide to help the home country without big change in the U.S. tax system and the way corporations and their executives are treated in the U.S. The Trump corporate tax will bring most home. The RRR plan, which we're expecting Trump will endorse shortly will bring them all home.

While the government thinks they are nailing corporations with excessively high taxes (35%), corporations have been proving that they have more might than the US government as they pack up their bags, their plant, and a few of their people, and they take a quick and permanent trip overseas—mostly to avoid the sting of American taxes.

I point that out so that we all have little sympathy for American managers who ship jobs overseas.

IBM offshoring example

Today's poster child for treating workers poorly is the IBM Corporation. IBM has fired as many as 200,000 employees and has shipped their jobs overseas in the last twenty years. Plant sites such as Endicott, New York are decimated as is Rochester Minnesota and other huge hallmarks of IBM's onetime relationship with its American host. Today IBM and even Microsoft and Apple could care less about America and Americans.

What IBM executives, such as their chairman Virginia Rometty, are doing in the US today is dumping experienced and expensive people, who work in expensive countries (US) and moving jobs to low cost countries, using the cheapest resources available there. IBM has decided that the US is an expensive country. Ask them at their next stockholders' meeting.

The IBM Company is pushing everything that can be offshored overseas as fast as it can. If the Chinese built a high speed rail over the ocean, IBM would be its first customer. Additionally, since IBM got so good at stiffing its own workers, it has made a business out of it. IBM makes a ton of money helping other "American" Corporations do the same thing. Thank you IBM!

Greed is the true answer!

"Corporations have been enthroned and an era of corruption in high places will follow, and the money power of the country will endeavor to prolong its reign by working upon the prejudices of the people until all wealth is aggregated in a few hands and the Republic is destroyed."

Who do you think said this?

Could it be: Barack Obama? George Bush? Ronald Reagan? Sean Hannity? Keith Olberman? Katie Couric?

If not the famous, then who? Tom Stites, the author of one of my sources for this piece thinks that the inflammatory rhetoric may "sound like a protester railing against the World Trade Organization?" Then he inquires as I just did in these words:

"Think again. These are the words of a successful corporate lawyer who represented railroads before becoming president of the United States. They resonate for many people in this Era post-Enron, when huge hot-stock corporations have cooked deals with the aid of their auditors and Wall Street bankers to enrich executives at the expense of their employees and shareholders. In this era, corporate lobbyists and campaign donors often have their way despite the interests of the voters, when Federal Reserve figures show that the top 1 percent of U.S. households controls 38 percent of the nation's wealth. But these words... But these words were written in an 1864 letter, by Abraham Lincoln." "Today, Lincoln's prophetic letter turns up more than 1,100 times in an Internet search, largely in writing that provides evidence that concern about corporate power is spreading rapidly—even though the issue is far from popular in our corporate-owned news media."

By the way, just because at this moment in time, I am not damning the "efforts" of the federal government does not mean there is not major culpability. The combination of the government and corporations is worse than either alone. This is known as corporatism. Without this teaming of the wicked, offshoring would never have been an issue and by severing it and by giving back control to the people, offshoring can end. The simple fact is that somebody has to want it to end, and I am not talking about just John Q. Public. Thankfully, we have Donald J. Trump on our side.

Yes, I did use the "G" word in the title for this essay. Greed hath no bounds. If nobody ever said that, please credit me but I think I am not alone. Corporations said "to hell with American citizens who support us and provide us a nice cushy place to live, who protect us as well. We're tickled we get it all, but we want it all." They say it every time they send just one more job overseas.

My best friend Dennis Grimes, whose last name ironically begins with a "G," says that "in an election people vote with their stomach." No student of logic would believe the people would ever put thieves back in office yet it happens all the time in the US because we are trusting and too many vote with their stomach.

There is a parallel between the greed that we all possess and the collective greed of a corporation. In 1886, despite the advice of the Founders, corporations became legal persons under the law. http://www.uuworld.org/2003/03/feature1a.html

You may well remember from US History classes that the British East India Company, an English Corporation, one of many English trading corporations operating in the pre-1776 days, was not very loved by American patriots. In 1773, it was their tea that got dumped into Boston Harbor and Americans have yet to gain a love affair for corporations. It is unlikely that that we ever shall.

Yet the elite establishment in America and the slimy politicians, who they both loathed and loved, brought back the dominance of behemoths like the British East India Company. They legalized corporations. Offshoring is a direct result of their greed.

Making corporations persons under the law was surely an ignoble act by the leaders of this country. Yet such is how we have it today. We all know that compared to US, corporations are huge and powerful. We have similarity only in a metaphor but not in reality. We the people function in many ways like mere atoms in the universe, while the corporations are suns, and moons, and planets. Which of us does not believe in our hearts that in a fair fight, a corporation would simply snuff any of us out.

We too have the same power when we take on one of God's nastiest creations, the mosquito. When we choose to snuff out a mosquito, or any other annoying bug, we have the power. Just like the mosquito after our snuffing is missing from the universe, our absence too from an encounter with a corporation would hardly be noticed.

Regardless of whether we like it or not, the government (activist judges way back) decided that corporations are deemed to be persons, albeit fictitious persons under the law. Despite the high level of disdain and distrust that was held for corporations by our founding patriots, the greed of the rich and the elite brought them back to America. Despite the wishes of the Founders that corporations have only state charters, they now have great federal powers. In fact, I have seen some compare one of our largest corporations, Wal-Mart specifically to the British East India Company.

Think of that idea when you are having a cup of Tea while buying some Chinese trinkets next time you are in the big store. With Walmart as today's reincarnation of the corporate power of the huge English behemoths that helped create the first Tea Party, permit me to say that I don't think the Tea is any better.

The bottom line message is that corporations are not people no matter how much graft was gained by the greedy. In my first patriotic book, Taxation Without Representation, published first in 2008, revised and published again in 2010, and available in a third edition today at Amazon and Kindle, I used this next paragraph to sum up the chicanery that brought personhood to corporations:



"Using its power to divine intent -- even the intent of the Constitution, in 1889, in the Minneapolis & St. Louis Railroad Co. v. Beckwith case, the Supreme Court, in one of its worst rulings of all time, declared that a corporation is a person for both due process and equal protection under the law. Since Shakespeare's time It's been

argued that 'something is rotten in the state of Denmark.' The 1889 Supreme Court decision helped begin the decay of the potential for the American dream, unless, of course, you have no flesh. And that, my dear readers is a travesty. The damage is done but it must be undone. Unless the Obama czars steal away our rights, the people still have the power, and we need to act judiciously through the Congress." Once they got this acceptance as a *person*, corporations kept getting more rights as government gave in to their financial power. For example, personhood has weakened the government's ability to restrain its growth. In the 1970's corporations were awarded more rights. Now they are covered under the Fourth Amendment against warrantless searches. Fifth Amendment double jeopardy protection, Sixth Amendment right to trial by jury came at the same time. With government not able to constrain its power, in many ways corporations, along with government, who often collude with corporations, are out of control today.

Yes, I admit, we already know that but is serves the soul to remember that persons have flesh and blood no matter what crooks and thieves have declared them.

Watch what you say as corporations now have First Amendment guarantees of political speech, commercial speech, and the negative free speech right not to be associated with the speech of others.

Of the top 100 economies in the world, it has been documented that 53 of them are corporations. Think of the raw power. A nation-sized corporation has a huge treasury and it has a legion of lawyers if it wants to exercise its free speech rights in a shouting match with a John Q. Public exercising her or his free speech rights. Ask yourself, how will this battle turn out?

Can this possibly be a fair fight?

So, what can you expect from a scoundrel? US corporations want you to believe they are global corporations so that our

government will let them alone to do their own thing -- even if it is to take all meaningful jobs from Americans and give them to foreigners. They are scoundrels for sure and the Attorney General should proceed against them to have the notion of personhood taken from them. They are not persons.

Can Obama help the corporate problem?

In a word, of course he can if he chooses to do so. But, thankfully he has little time left. I have full confidence Trump will solve this problem. Besides, I have not found many things that I like in the way President Obama solves problems. Mostly it is because he does not typically solve problems. He creates new problems from existing ones or he exacerbates them.

The President is rarely thinking about Brian the computer guy or Joe the plumber. He is thinking about Barack the ideologue in every move he makes. He'd get more done naturally if he cared about America.

President Obama made a speech in 2009 and in this speech, he was absolutely right. He was 100% correct. He had the right idea on offshoring. Yet, since then, unfortunately, he has done nothing about. This is what the President said about companies regarding offshoring.

From an Obama May 2009 speech

".... Even as most American citizens and businesses meet these responsibilities, there are others who are shirking theirs. And many are aided and abetted by a broken tax system, written by well-connected lobbyists on behalf of well-heeled interests and individuals. It's a tax code full of corporate loopholes that makes it perfectly legal for companies to avoid paying their fair share. It's a tax code that makes it all too easy for a number—a

small number—of individuals and companies to abuse overseas tax havens to avoid paying any taxes at all. And it's a tax code that says you should pay lower taxes if you create a job in Bangalore, India, than if you create one in Buffalo, New York.

"Now, understand one of the strengths of our economy is the global reach of our businesses. And I want to see our companies remain the most competitive in the world. But the way to make sure that happens is not to reward our companies for moving jobs off our shores or transferring profits to overseas tax havens. This is something that I've talked about again and again during the course of the campaign."

Amen! But, from this great rhetoric, nothing has appeared. Where's the beef. The President's fine oratory reminded me of a guy on the sidelines complaining about the coach, when in fact, Obama is the coach. He is the president. Instead of rhetoric why are we eight years later looking for a solution he could have brought to us right in the beginning. I have figured him out on this one. Whenever he sounds like he cares about Americans, he is only kidding. Sounds too simple to be true but think about it. He is only kidding. He cares about a lot. America and Americans however, are not on his list.

In this context the President was referring to unpatriated retained earnings. This means that companies who made money overseas and included it on the books of their foreign subsidiaries as retained earnings are permitted to keep the money overseas and not bring it back to the US.

The idea is that they can spend the money where it was earned and invest more in that particular country to help sustain or grow their business. Obama's supposed beef and mine also is that by not declaring the income, they do not pay US taxes.

Overall it helps to have strong corporations that carry the American flag but, as the President notes, there are billions and billions of dollars that companies are playing with overseas thereby making more money by not declaring taxes. Yet, these taxes are really due and American citizens are making up the difference. Because of these loopholes, corporations do not have to pay their taxes when the income is earned overseas. It is safe to say that US firms who have taken operations overseas, not only hurt the employment picture by taking jobs with them, they also hurt the US revenue structure by not paying their taxes as they should.

What if American corporations left US?

So, President Obama's plan if he chose to do something would have been to punish these American Corporations by tightening the rules on retained earnings which, theoretically would flush tons of money back into the US treasury. But, Obama did nothing in eight years and the problem persists.

There are a number of companies such as Microsoft who are not very happy about this idea. Microsoft has offshored many jobs and this would affect them very negatively, and they have whined about this openly and profusely, and in some ways in a threatening manner, though I am the last to call anything hate speech.

If a company such as Microsoft reacts to this punishment by moving all its operations and HQ overseas, it would not have to pay a dime in U.S. taxes, and it would not need any employees in this country either. If the Obama notion ever became law, a number of experts think there would be a huge exodus of "former" US companies. They would trade their US loyalty for a buck in a heartbeat.

They would not choose to stick around and take the punishment when they could easily go somewhere else. I have a great solution to this. Let them go! We will recognize them by their limp and their inability to get anybody in the US to buy their products.

Solution for companies that move HQ offshore

By the way, my solution to these potentially former American corporations taking their corporate HQ overseas to avoid US taxes would be very simple. If they chose never to do business in any way in the US again, it would be a big revenue loss for them. So, what smart company is going to do that? Since they will want to sell their products in this huge marketplace, here is their special deal. You'll like this.

If they moved HQ offshore so they were no longer a US based corporation and they chose to do business in the US by selling products through their own sales subsidiary or an agent, here is a way to make them wish they had been more loyal. I would suggest there be a US Business Permission Permit charge required just for corporations that have chosen no longer to be citizens of the US. The fee for the permit would be equal to the average inflation adjusted corporate taxes paid by the company in the last five years. It would be due every year for infinity.

Of course if there were no products from this company sold or black-marketed into the US, then they could fully avoid payment. Good luck. Each year the rate would be increased by the inflation index. So go ahead corporations, leave town. The people in the US will hate you in your fictitious personhood, but the government will still love you as your corporate tax bill will basically be the same.

Additionally, because the resources of the US had been used to make the corporation successful in the first place, I would suggest that any patent protections acquired and filed in the US (non-defense patents), and enjoyed by the corporation because of the laws of the US, become the property of a new people controlled corporation. This new corporation would be named the "We the People Corporation" and all of the funds from its treasury would help fund things like unemployment compensation as well as social security.

Noncitizens have non-rights. The "We the People" Corporation could then propose to a competing foreign company to come to America, build facilities, and employ Americans. The foreign company could then use the patent rights (only in the US) as once held by the expatriate citizen corporation.

So, a business that may not be a US citizen would be able to come in and buy or build a plant and begin to manufacture and sell similar products as the corporate scoundrel that intentionally left the protection of the U.S. And, American workers would get those good jobs again.

5% corporate tax & a two-tier tax system

So that the "We the People" Corporation does not get into a contentious argument with real American Corporations that have chosen to stay, I would introduce legislation that would change the corporate income tax system to two-tier. This would dis-incent corporations from moving jobs overseas and it would incent them to bring them back. It would be a huge, huge tax reduction.

The domestic corporate income tax rate would be lowered to 5% while the overseas tax rate for products built overseas would stay at 35%. This would encourage the world, including formerly American corporations to invest big-time in the U.S. The rationale for this is once the investments came, the jobs would flow back to the US so fast that people who thought they would never work again would see big jobs again in the US.

Penalize the bad US corporate citizens

My ameliorating friends and consigliore's tell me not to do this but my instincts are that this next notion is what is needed. I am concerned about the companies who have a huge part of their former American workforce overseas already in other countries while their former American workforce remains unemployed. So, in addition to a sweet incentive of a lower tax rate, I would like to add a bad guy fee for those who have abandoned US interests and sought to increase profits by discarding American workers.

In my plan, there would be a schedule to be created that would be called the jobs penalty schedule. It would work via a formula yet to be determined but I would propose that it would be similar if not identical to the following:

Based on the schedule, corporations would pay from 0 to 10% extra tax based on their domestic jobs profile. For example, let's say IBM's domestic employee base is determined to be 200,000 at its highest in the past 20 years. Let's also assume that its current base is 100,000. The job loss would be 100,000. To calculate the percentage job loss, put the job loss # over the current job #. 100,000 / 100,000 = 1.00. The job loss index factor therefore in this scenario is 1.00 or 100%

The formula would multiply the job loss index factor by 10% to get the additional tax percentage penalty for the corporation. If your company placed jobs overseas and if you fired American workers, you would pay from one to ten percent additional tax depending on the percentage of workers you displaced.

For IBM in this case, it would compute to 1 times 10% = 10%. To get IBM's full domestic tax rate, if IBM were the perpetrator (and from what all my friends in IBM say, IBM is an egregious perpetrator), it would be 10% in penalty plus 5% normal tax = 15%. Because IBM would be deemed to no longer be a good corporate US citizen, it would pay three times as much as a percentage than another company in taxes until it brought back its labor force to the US.

Now, suppose IBM brings back 40,000 employees. Their number of domestic employees would then be 140,000 and displaced would be 60,000. So. 60,000/100,000 = .6 or 6%. And, so, IBM's corporate tax rate, if they brought 40,000 workers back would be 5 + 6 = 11% instead of 15%. If IBM brought back all 100,000 jobs, its factor would be zero and its tax rate would go down to 5 + 0 = 5%, which would be the lowest rate possible. Then we in America could say to IBM, you are not only a good corporation, but a good "person."

The thought of bringing 40,000 or 100,000 more employees back to the U.S. probably is not a notion on IBM executives' minds at this time. This program does not care what is on their minds. IBM, Microsoft, HP, Apple, and lots other US corporations who like being known as US corporations do not have a right to positive press when they are hurting Americans.

Their greed hath no bounds. They want positive press for sure but more than that they would like the 30% corporate tax savings they would get under this plan. And the United States for giving that tax reduction would get millions of jobs back. Oh, and each one of the folks who get one of those jobs, they would be paying taxes for the good of America. It's win, win!

To say the same thing just a little more bluntly. Corporations are heartless. All of their motivations are based on greed. Even when they give something, they expect more back. Quid pro Quo would have little meaning if it were not for corporations. The corporate culture is based on greed. That is all corporations understand. They owe no allegiance to the citizens of the United States just like your neighbor does not owe you or any of your other neighbors a beer on a hot day even if he has the only cooler in town. Don't sugar coat corporations because they will not look good anyway. Most corporate executives care about two things other than themselves, which is of course, their prime motivator. Self is a big deal in the corporate boardrooms of America. The other things they care about, after themselves is their family, and then they care about the corporation. Well! I suspect there are cases in which the two of those are reversed. After all important things are taken care of you have the proverbial customer and then all those who watch the company, everything else, and then come the employees.

Understanding CEO motivation is how we bring jobs back to America. If they are paying 35% tax while all the other Harvard guys or the Wharton School MBAs are getting the 5% rate, these guys will fear that they will be fired by the stockholders who also care nothing about John Q. but know that if the CEO is paying 30% more tax than needed, the CEO needs to be replaced. Remember before even one and two above are considered for a CEO, self is the prime motivator.

I love saying this because it is the truth. Corporate executives are motivated by greed. Their self-greed reflects the full greed of the officers of the corporation who would in a second sign up to sell out their fellow Americans for a bonus. Some might give up their cube mate for a pack of Cheetos or a Starbuck's Late'. Let me assure you ladies and gentlemen, IBM and all of the greediest corporations in the US would be very interested in saving 30% from their tax bill. They'd sell out their neighbors to get it. If you live next door to any of these scoundrels, you already know what I mean.

Getting back to the math summary, the corporate tax would be reduced every time the employee index was reduced until a company, such as IBM employed 200,000 again and then its rate would be 5%. Companies that begin to offshore would be likewise affected as their job loss index factor increases, their tax bill would increase. This helps solve the problem of offshoring and with a 10% offshoring tax rate for corporations, it also helps make the US a more competitive country in which to invest. Many economists have offered the notion that the big barrier to success for corporations is that nasty 35% tax rate imposed by the US government. This solves that problem. Country corporations from all-over who have the freedom to make money for their home country will be knocking on the US jobs door to get in on the deal. There may not be a chicken in every pot, but how about a really new deal that puts a paycheck in every mailbox.

As noted, the US corporate income tax right now is 35% and the state corporate tax varies but it is safe to say it is about 10% as an average of all states. So, 45% of most corporate profits goes to the government today even before anything goes to investors. Perhaps states also can also be incented to reduce their rates to put more people back to work.

It is argued that the huge corporate income tax is not really paid by corporations anyway but by consumers. It is fully considered in product pricing. Interestingly, the full corporate income taxes are only paid by those industries who are US corporations and who conduct business within the U.S. The good guys pay and the bad guys get a break on their overseas earnings. This loophole would also be closed.

In the Kelly plan, which one day may be the underpinnings of the Trump Plan, to summarize the information above, the US corporate tax rate, which in Ireland, lowest in the world along with Lichtenstein and Cyprus, sits at 12.5%, would be reduced to 5%. Maybe one day we can make the rate zero (0%) to get even more foreign investments on US soil. Added to the 10% is a potential jobs penalty of up to 10% that can cause the tax to be as high as 15%. Whether the rate is 5 or 10%, however, this is substantially lower than 35%. The idea of the lower tax rate is so that American Corporations will choose to invest again in America and hire employees in America for tax reasons? By the way, their motivation will be the "G" word.

Even though I am not a corporate mogul by trade, I know how US corporations take on the US Treasury and they win huge tax breaks and corporate welfare. All corporate tricks would all have to be repealed in this scenario to level the playing field for all corporations investing in America.

The government for its part has sent a signal to corporations that it expects to gain when the corporation is successful and so more than representing John Q. Public, Congress has been representing the corporations for far too long. When you select anybody for Congress in the future ask them their perspective on jobs in America and corporate offshoring. Forget about what Obama says for he had eight years to change it and did nothing. Hillary says she likes Obama's policies. Expect more of the same if she is elected. God help us!

The very businesses who gain the protection of the United States in order to maximize profits by setting up various aspects of their organizations offshore, feel they have done their best merely by making a profit. Sorry, folks, that is not enough for the new America. To most Americans who observe the behavior that directs jobs to other countries, they see the US Corporations thumbing their noses to US workers by offshoring labor to other countries only to increase their profits by what are mostly negligible margins.

Union or no union, Americans should have a problem finding redeeming value in anything that compromises American workers and benefits the corporate entity over the citizen. Many of us have many ideas on how to improve this. For me, it is another big reason why I devised the plan that we just described and it is why I ran for Congress way back in 2010.

I like saying it over and over because I think it will work well. The plan is to lower the US corporate tax to 5%. To get the lowest tax rate, you would have to be a good American Citizen as a corporation that employs US workers. Good American Citizens do not ship jobs overseas. There are also incentives built in to the rates to bring jobs home.

How about those apples? Notice the lack of capitalization on the word "Apple's. Let's let the master Tim Cook tell America how he would bring Jobs home! If he chose to be on our side, I'd be happy to say, "How about those "Apples?"

Let's keep America strong and prosperous by having Americans fully engaged in the American Dream! Let's not let Corporations or Corporatism stand in our way! We are the people and we deserve to have it our way!

Essay 7 Solving Jobs & Illegal Immigration Together!

Corporations that cannot outsource find another way

What a shame for corporate titans who saw their golfing buddies moving huge portions of their businesses offshore to reduce their labor cost. They saw their buddies being able to move their businesses offshore to take advantage of lower wages and their buds also got "less punitive" environmental conditions. They hoped they could figure out a way that they could create a labor force that was similar to those offshore but with their company staying in America. They succeeded.

They wanted all of the advantages and none of the disadvantages of offshoring for their companies. They wanted a cheap labor source and a labor force that would not complain at all about the work environment. The overriding problem of course for industries such as farming and meatpacking and even construction was that companies that require "American" workers in America cannot offshore the work to other countries. What a problem. These businesses were stuck in America and therefore had to hire American workers. Not so fast!

Suppose, for example, your company packs meat from animals raised on US land or suppose you are selling berries or vegetables grown on US land, or you are building homes in the U.S. You cannot take your enterprise offshore. It cannot work. The poor Corporate titans could not gain the benefits of offshoring unless magically the Chinese and Indian workforce, willing to work for peanuts was brought to the US.

It may not be Chinese workers or Indian workers but the workers came nonetheless, and they are still coming. The US government solved the problem of no labor arbitrage by taking no action when illegal foreign nationals en masse took American jobs. The companies still seem to be able to hire them with impunity and profits never looked so good as wage rates are as depressed as in the Robber Baron days. And, President Obama has no idea why there is a jobs problem.

Somebody is being taken advantage of and somebody else is out of a good job, but a corporate titan is now able to share in the bounty of offshoring without even moving the company. When the government took no overt action to stop the practice during the last several administrations, its nonaction was enough to put a big smile on an industry mogul's unkind face.

With the government choosing not to enforce illegal immigration laws, companies thus became able to create little pockets of employment that had almost all of the "business friendly" characteristics and the big benefits of third world countries right here in the good ole USA. Yup! Because of lax government policy intended by the Republicans to give businesses who could not offshore the financial breaks they needed, life was good. Huge corporations were able to find labor arbitrage opportunities that had not been seen since the Robber Baron days, right here in America. Just as in those days, all the workers suffered and still suffer while management prospers.

Meatpacking industry is top of the list

The story of the meatpacking industry is an egregious affront against the American way. We all seem to think that all illegal

immigrants pick berries or vegetables or otherwise work on a farm. This is not true. The once highly unionized labor force in the meatpacking industry for example once commanded 25% higher wages than other manufacturers. In the early days, meatpacking was an undesirable profession because it was dangerous work and because the wages were depressed.

With the union influence, meatpacking became a desired job because the wages grew to put the many employed black workers into the middle class. New legal immigrants from all countries saw meatpacking as an opportunity for high wages if they could get the jobs. Paying such good wages however soon was too good for companies like Swift and Tyson and others so they figured a way to get the wage rate back to slave level. They shut down their city operations; the built new plants in the middle of no place; and moved their operations to the country.

Their workers for the most part chose not to go with them. A huge proportion of those who lost jobs were black and because of the great wage they once had in this industry, they had lifted themselves well into the middle class. It was too good to last.

When they corporate moguls opened their new meatpacking facilities in rural areas, the plants were non-union or were about to be. The wages were about half of what they had been when the companies were all unionized. Along the way the meatpacking industry came up with a lot of tricks so that unions were never again able to take hold of the industry again. Illegal foreign nationals swarmed into these areas and took as many jobs as possible. They worked for peanuts. They became the offshoring tool and no business person worried about an illegal alien joining a union. It would be almost certain deportation.

Just like the government has begun to lie at a wholesale level, company managers and executives learned to lie so that they could keep their profit margins and they could also avoid jail time. The Immigration and Customs Enforcement (ICE) people did come around, but not too frequently, and most of the time, they came after having been announced. There were few surprise visits. When companies were asked about their workforce, they were quick to verify that they had no illegals working on premise. Of course, they lied. Here is a great story that demonstrates this.

A few years back, the Swift Plant Managers in Greeley Colorado were informed that ICE would be a calling soon. Why ICE would tell them they were going to be raided is another part of the problem. All of the meatpackers in recent years use illegal aliens (foreign nationals) as a major part of their workforce. So, when informed by ICE that a raid was imminent at its plants, Swift immediately went before a judge to ask for an injunction to prevent those raids. Why would that be?

When they got to court seeking injunctive relief, Swift told the court that the raids could severely impact its ability to conduct business. The company argued that it could lose up to 40 percent of its workforce and this would compromise its ability to continue as an employer. This is verifiable by checking Swift's court documents. The funny thing here is that Swift had always claimed that it had never knowingly hired an illegal worker so the idea that they would be harmed in any way was counter to their prior testimony. They lied.

Of course we know and the workers know they lie. The bottom line is that if the company believed it had no illegal workers then where did the 40 percent loss in its workforce estimate come from in a potential immigration raid? Again, the answer is they lied. Those looking at the meatpacking industry over time know that no amount of raids at Swift would ever stop Swift's Greeley plant and other plants from being work havens for illegal foreign nationals. There is just too much money at stake. Since nobody goes to jail, the inconvenience is merely a cost of business. How about fruit, berry, and vegetable pickers? It is a similar scenario to meatpacking and even construction but there are more legal ways to get the job done in those industries. Yet, there are still lots of illegal foreign nationals working on farms and constructing buildings. Obviously farmers cannot offshore their business so they do the next best thing. They find the cheapest labor in town. So, it is possible to bring all of that cheap labor to the farm without having to move the farm.

Of course we know the farm cannot be moved and there is an ample supply of illegal aliens to fill the bill. This is a real coup for businesses that cannot go offshore. Corporations are able to pay substantially less than the prevailing wage to gain the labor supply they need. It is really not good for Americans and it is certainly not a good thing for the impoverished workers.

Today everybody seems to understand that offshoring is the sending of American Jobs to another country and leaving the Americans who once had those jobs out of work. There is an argument that we just presented that most meat and poultry workers, farm workers, and construction workers, whose jobs cannot be outsourced are victims of labor arbitrage with no union protection.

Workers in manufacturing and now customer service industries, as well as IT and Accounting are witnessing massive job depletion by offshoring. So entrenched US industries use illegals for labor arbitrage and healthy corporations that are not bound to the US, simply take the jobs overseas to third world countries. With the major influx of illegal foreign nationals a.k.a. illegal aliens, those corporations that cannot offshore do the same thing onshore. They have been able to bypass labor laws and they have been able to craft a "third world" strategy for the U.S. meat and poultry industry, as well as many other industries.

So, why did I take you through all that?

The solution is actually very easy. I love the notion of cybernetic systems. As a computer systems engineer, I tried to build self-correcting attributes into all the systems I designed. I think the government missed its opportunity years ago of dealing effectively with border jumpers who become illegal workers. Nothing is perfect but regulations are so less than perfect there is an outhouse odor as you even approach a house of regulation. You know that when you try to start a perfectly safe business in which a reasonable prudent person would say --Yeah!; there will be a bureaucrat at some level trying even harder to shut it down.

Yes, there are issues that we all need to be protected from but-not being able to earn a living--is not one of these things. We do not have to be perfect and should not have to be perfect and none of the regulations on any set of books are perfect unto themselves.

Essay 9 The Fair Tax -- An Essential Element for Jobs!

Income tax is bad news!

"The Congress shall have power to lay and collect taxes on incomes, from whatever source derived, without apportionment among the several States, and without regard to any census or enumeration."

Way back in February, 1913, the 16th Amendment was ratified by the states and thus it became a part of the Constitution. As mostly everybody who is affected by income tax and the IRS would like it to go away, even Congress cannot get rid of it. It would take another amendment to the constitution to make that happen and that is not easy.

The problem of the day in 2010 is clearly Jobs! Jobs! Jobs! It's been bad since 2008 and getting worse as time goes by. How does the 16th amendment help business? How does the 16th amendment help Jobs? How does the Sixteenth Amendment help you and me and the next guy assure that tomorrow will be a better day than today? Obviously it does not, or this essay would never have been written.

The 16th Amendment to the Constitution authorizes the "progressive" income tax and the IRS. We all know that more than a mechanism to feed the government's need to defend us, and to enable highways to be built and other things that individuals cannot do, the income tax has more recently been used as a mechanism for wealth redistribution. This is what killed the goose that laid golden eggs for a long time. The income tax was not new in 1913. It had been used to fund the armies of the north in the Civil War. No country can conduct war without cash. So, to bring in a lot of revenue as necessary in 1861, Congress introduced the Revenue Act of 1861 with a flat tax of 3% on annual income above \$800.

The tax self-destructed in 1866 but was almost brought back a number of times by the Socialist Labor Part in 1887, the Populist Party in 1892, and the Democratic Party in 1894 and again in 1908. Notice the Republicans were never openly for the personal income tax. Moreover, for Pennsylvanians, it is nice to know that along with Virginia and Florida, Pennsylvania never took up the proposed amendment that ultimately permits government to do things never intended by the Founding Patriots. It's time for this monster to go, along with 435 members of the House and 33% of the Senate.

On the treasury site, it says, "By 1913, 36 States had ratified the 16th Amendment to the Constitution. In October, Congress passed a new income tax law with rates beginning at 1 percent and rising to 7 percent for taxpayers with income in excess of \$500,000. Less than 1 percent of the population paid income tax at the time. Form 1040 was introduced as the standard tax reporting form and, though changed in many ways over the years, remains in use today."

Lawyers like to use the term slippery slope to mean "give them an inch and they will take a mile." The tax slope was so slippery that when John Kennedy cut back income taxes to save the economy in the early 1960's, the highest tax rate has risen to over 90%. No matter who you are, that is ridiculous. Whether my gross income ever goes about \$100,000.00 or not, I do not deny those people clever enough to beat the business system and become utterly successful.

Without them, we would not have the radio, the TV, the computer or the iPad, and an awful lot of other wonderful things. Surely, the buffoons in the government would never

have brought us such innovation, and so I question any person thinking we should turn to government for hardly any of our needs other than National Defense. Putting the government in charge of healthcare is like finding the worst player on the team when the championship game is tied in the bottom of the ninth, and pinch hitting the best player for the worst player on the team. You're going to lose. It's a certitude.

The 16th amendment like most things that may once have been properly enforced, has been perverted over the years, especially by this administration. Team Obama has openly declared that an individual's wealth should be redistributed merely because government is all powerful. So, they steal from the rich and give some alms to the poor, thereby making the poor dependent on the state.

- 3. The FairTax repeals the taxation of Social Security benefits and adjusts Social Security indexing to protect seniors.

- 4. The FairTax ends all record keeping and income tax filings of any kind for seniors, totally insulating them from the high costs and abusive tactics of tax preparers.
- 5. The FairTax does not tax used goods, giving lowincome seniors choices.
- 6. The FairTax reduces manufacturers', services', and retailers' costs, allowing them to lower costs to seniors.
- 7. The FairTax delivers a tax holiday on IRAs and other tax-deferred plans.
- 8. The FairTax ends gift and estate taxes, along with all of the unfairness to heirs and complex planning for those who earned the money.
- 9. The FairTax allows seniors to sell their homes and pay no capital gains taxes.
- 10. The FairTax generates an economic boom, which eases future budget pressure on seniors' entitlements.
- 11. The FairTax lowers average remaining lifetime tax rates.
- 12. The FairTax ensures your grandchildren have the same opportunity you did.

There is another notion that a sales tax can be a very practical measure by which we will gradually wean ourselves off of our dependence on federal and state services. By slowly lowering the percentage of the tax over time, the size of the government overall can shrink and government services can eventually be returned back to state control where they belong or perhaps, other than those deemed extremely essential, they can be ended entirely and people can keep their own money. How can that be bad?

So that you understand the salient components of the Fair Tax Plan, I have captured from the http://www.fairtax.org/ site, some of its essence below.

What Is the Fair Tax Plan?

The Fair Tax Plan is a comprehensive proposal that replaces all federal income and payroll based taxes with an integrated approach including a progressive national retail sales tax, a prebate to ensure no American pays federal taxes on spending up to the poverty level, dollar-for-dollar federal revenue neutrality, and, through companion legislation, the repeal of the 16th Amendment.

That last notion, ladies and gentlemen means that Congress sets in motion the repeal of the 16th Amendment and with it goes the IRS.

There actually has been an act proposed called the Fair Tax Act (HR 25, S 296). It is nonpartisan legislation. It abolishes all federal personal and corporate income taxes, gift, estate, capital gains, alternative minimum, Social Security, Medicare, and self-employment taxes and replaces them with one simple, visible, federal retail sales tax administered primarily by existing state sales tax authorities.

Because the best approach would be a small corporate income tax in the 10% range and an offshoring penalty of another 10%, I am almost in full agreement with the FAIR TAX as proposed and would be happy to vote for it as is.

The 10% tax would still make the US the lowest taxed nation in the world at the corporate level and this would create major investment in the US. If the FAIR Tax as proposed is enacted, I would introduce legislation to permit a 10% tax penalty for American corporations that offshore jobs.

The Fair Tax taxes us only on what we choose to spend on new goods or services, not on what we earn. The Fair Tax is a fair, efficient, transparent, and intelligent solution to the frustration and inequity of our current tax system.

The following is from fairtaxnation.com. It discusses how easily Congress can switch to the FAIR TAX.

How does this sound for a draft of the 28th Amendment to the Constitution?

Judge Deborah's Proposed Fair Tax Amendment

Proposed Twenty-Eighth Amendment

Section 1. The sixteenth article of amendment to the Constitution of the United States is hereby repealed.

Section 2. The direct taxation of any corporation, small business, farming operation or private enterprise is hereby prohibited.

Section 3. The direct taxation of any private citizen's wages or earnings by Congress is hereby prohibited. Income taxes, payroll taxes, alternative minimum taxes, estate taxes, death taxes, gift taxes, corporate taxes and capital gains taxes are hereby abolished.

Section 4. A federal retail sales tax shall be instituted on the consumption of goods and services in the United States once, without exception, but only once.

Section 5. The Congress shall have power to enforce this article by appropriate legislation. This Amendment will take effect within ninety (90) days after passage of Fair Tax legislation by Congress.

.....

H.R. 25: "A resolution to promote freedom, fairness, and economic opportunity by repealing the income tax and other

taxes, abolishing the Internal Revenue Service, and enacting a national sales tax to be administered primarily by the States."

- Brings transparency and accountability to tax policy
- Ensures Social Security and Medicare funding
- Closes all loopholes and brings fairness to taxation
- Abolishes the IRS

To save you the effort of going out to the Fair tax site, http://www.fairtax.org/PDF/PlainEnglishSummary_TheFair TaxAct2007.pdf, I have copied the summary into this essay. If there is one thing one can say about the Fair Tax that cannot be said about the Income Tax, it is that it is Fair.

The Fair Tax Act of 2007 – HR 25/S 1025 plain English summary

"The Act is called the "Fair Tax Act of 2007." As of Dec. 31, 2008, it repeals all income taxes and payroll taxes, specifically:

- The individual income tax (including capital gains taxes and the alternative minimum tax)
- All individual and employer payroll taxes including Social Security, Medicare, and federal unemployment taxes
- The corporate income tax
- The self-employment tax (a self-employed person pays both the individual and the employer portions of Social Security and Medicare taxes)
- The estate and gift tax

"Effective January 1, 2018 [or whenever it goes into effect] it replaces the above taxes with a national retail sales tax on all goods and services sold at retail. The tax rate is set to be revenue neutral – at the level necessary to replace the revenues generated by the repealed taxes.

"A 23-percent (of the tax-inclusive sales price) sales tax is imposed on all retail sales for personal consumption of new goods and services. Exports and the purchase of inputs by businesses (i.e., intermediate sales) are not taxed, nor are used goods or any savings, investment, or education tuition expenses. The sales tax must be separately stated and charged on the sales receipt. This makes it clear to the consumer exactly how much they are paying in federal taxes.

"There are no exemptions under the FairTax, meaning that no lobbyist, corporation, or individual can obtain tax advantages that are not available to the general public. Also, everyone pays the same rate, but those who spend more pay more total taxes than those who spend less. "The FairTax provides every American family with a rebate of the sales tax on spending up to the federal poverty level (plus an extra amount to prevent any marriage penalty). The rebate is paid monthly in advance. It allows a family of four to spend \$27,380 tax free each year. The rebate for a married couple with two children is \$525 per month (\$6,297 annually). Therefore, no family pays federal sales tax on essential goods and services and middle-class families are effectively exempted on a large part of their annual spending.

"Funding for Social Security and Medicare benefits remains the same. The Social Security and Medicare trust funds receive the same amount of money as they do under current law. The source of the trust fund revenue is a dedicated portion of sales tax revenue instead of payroll tax revenue.

"States can elect to collect the federal sales tax on behalf of the federal government in exchange for a fee of one-quarter of one percent of gross collections. Retail businesses collecting the tax also get the same administrative fee.

"Strong taxpayer rights provisions are incorporated into the Act. The burden of persuasion in disputes is on the government. A strong, independent problem resolution office is created. Taxpayers are entitled to professional fees in disputes unless the government establishes that its position was substantially justified."

Subject: My Feelings ON Our Income Tax System

Broken, complicated, corrupted, expensive, destructive and unfair are the words that best describe the federal income tax system after almost a hundred years of being treated like the personal piggy bank of tax lobbyists and members of Congress.

This is not simple a pigsty but one that is so complex it cost taxpayers and American businesses more than \$300 billion last year in paperwork costs, alone, before a penny of tax was paid. What people owe but don't pay amounted to more than \$350 billion last year—a shortfall that, to make up, increased the average taxpayer's bill by more than a third. In Washington, D.C., however, a new American aristocracy made up of political insiders profits richly by buying and selling pieces of the federal tax code. It is routinely used to buy votes and pit Americans against each other, explaining why almost half of the nation does not pay income taxes while the other half carries the entire load.

Does such pandering represent the 'Achilles Heel' of our Republic and spell inevitable economic ruin?

Essay 11 The Coming Tax Increases & the Chinese Foreclosure

Does cutting taxes really work?

George Bush was continually criticized for his tax cuts and the "Bush Tax Cuts" had been big targets for the Obama / Pelosi / Reid Administration to get off the books. This had been a constant theme of the Administration until they cut a deal and ended some and kept others in 2013. With the 2013 agreement, Congress and President Obama permanently set tax rates at the Bush levels for the most part. Essay 12 Recovering From a Recession-- the Bottom Line for Jobs!


The road to recovery

In other essays, I discussed the problems and we discussed innovative solutions from cutting red tape to solutions for offshoring and illegal immigration and others. This essay is the bottom line on how to get the inertia rolling the other way. This essay outlines the road to recovery from this unprecedented recession to its fraudulent recovery.

We are clearly suffering under a mountain of debt and there are deficits scheduled from here to eternity. A Congress controlled by my party has permitted the deficit to skyrocket to just about \$1.5 trillion in various years and the national debt has more than quadrupled to about \$20 trillion. We have been in recessions before as we discussed in the last essay and they were almost all solved by doing two simple things. The government must stop spending and cut taxes. One of the dumbest things the two know-nothings (Legislative and Executive branches) considered in 2010 and might come up again is something called a value-added-tax or VAT. We must fight this with all our muscle as the fiscal end is near if a VAT is passed as it is an unseen tax and dishonest Congresses love bringing pork home unnoticed.

The VAT would not reduce the deficit anyway. In fact, it would cause the debt to continue to rise because the President and the Congress have insatiable spending appetites. They will take any money we give them to make the economy better and they will just throw it away on expanding the welfare state. This will be another tool with which the government can redistribute wealth and spend much more on stupid and frivolous projects. Though interest rates are being kept artificially low, inflation is already taking hold. Please do not use the consumer price index as a guide to knowing the inflation rate as it is a formal instrument for government lying. Bureaucrats use it to dupe the public to suit their purposes.

One place it is used all the time is to set social security take home pay amounts. They lie like rugs. Go buy a rug and see if it is less expensive when the CPI is low. Better yet, go try to buy a grocery cart full of food. How is everything more expensive and yet the government tells seniors there is no inflation. Again, get its straight, they lie to suit their purposes. Vote the bums out of office.

Taxation through currency devaluation is very easy to do. Moreover it is the politically expedient course; but it is also more damaging as your dollars become the size of the one in Gordon Liddy's Rosland Capital commercial shown on page 150. Go ahead look at it now, it will crack you up!

Government cannot continue secretly taxing through borrowing (a.k.a. deficit spending) yet they are. Is the Fed secretly printing money? Inflation is socially and economically destructive in that it wipes out fortunes for those who are not invested in hard assets. If you want to know the pace at which the dollar is devaluing, look at the price of gold. The stock market is rising strangely enough but that too is because there is nothing worse to own right now than cash.

Inflation is taxation but silent. Though taxation is not the answer, if citizens were forced to pay through direct taxation up front, the voters would be shocked. They would immediately see that there really is no free lunch as promised. Though more and more people understand that nothing is free, still others think government creates money and its job is to get them their fair share.

They secretly believe that in Fort Knox and its surrounds, the US plants the whole world's supply of money trees. The dollar is the world's currency right now because these trees grow various denominations of dollars. The trees cannot grow Euros, for example. Congress would not be able to go out in public if some of the public really knew that the trees do not exist. Politicians spend the people's money. Those who think the government creates money just cannot see the problem.



Before we continue, let's review the notion of a tax. A tax simply is money collected by government directly or indirectly from the people to cover the expenditures of government.

How does the government get the people's money?

Though tax systems are supposed to be voluntary, the Government gets its money by force. We know that intrinsically. The IRS may very well be toting heat in the future when the citizens stop coughing up the cash willingly. What force is typically applied?

Government decrees that you and I and businesses will pay a percentage of our income to the Tax man (the IRS). If you or I or any business refuses, we are faced with fines, imprisonment or both. Since a business per se cannot go to jail, its officers may be held liable and they would be sent to the Big House by the IRS as necessary for it to collect what it is owed.

If somebody else took your money by threat or force, it would be stealing. Government confiscates funds and does with them as it wishes. Your dollars often wind up in the pockets of your neighbors. And, yes, it is stealing.

Let's explore this question briefly: "If government can borrow instead of tax, isn't that good for the people? It's not like the people are borrowing, right?"

Let's review how the government gets its money one more time. They take as much as is politically possible by force through the tax system using the IRS as their collectors. However, if Congress raises taxes too high, the Representatives don't get to come back to serve their next term in Washington.

So, since politicians believe that they serve because they deliver the pork to the home folks, they have figured a way to bring pork home without raising taxes. As we noted above, they know they can borrow and who cares if it is Russia or the Chinese from whom the US is borrowing. One would expect Iran not to be on the list of lenders. Again, who knows? Congress wants to be rich so bad and we pay them just under \$200,000 per year.

This idea called government borrowing is a misnomer. Why the Chinese think they are going to get paid back is a mystery unto itself. There is no chance at all that the government will ever repay any of its debt. Who are they kidding? You may know that there was hardly any debt at the turn of the 20th century. It went from \$2 billion to over \$10 trillion in this past century, and there are at least \$60 trillion in SS pension and Medicare promises via worthless IOUs that will never be paid back.

The US Congress as custodians of the treasury have served no better than a pack of charlatans. They assure their reelections by robbing the treasury to provide pork to their people. When the people take the pork, the people get the government they deserve.

Do the people get hurt when government borrows? The word again is price inflation. When government borrows, and when the Fed is operating normally instead of under Obama constraints, interest rates rise and the Fed lowers those rates by monetizing the Federal IOUs. When there is more money in circulation, your money loses its purchasing power. So, yes, the people do get hurt even when the government borrows instead of raising taxes. Government has figured out how to borrow from the invisible man. The man does not materialize but the freshly cut bills do.

If the dollar were forced to be reduced in size to match its value, Gordon Liddy would in fact have the first printed bill at the correct size for 2010 and it would be representative of bills in circulation in 2016. I love the G. Gordon Liddy Ad but do not see it enough anymore.

Whenever the Liddy Ad would come on TV, I would stop and call my wife's attention to it. It is the face of the future. If the government had to continually reduce the size of the dollar to match inflation, eventually people would need tweezers to hold on to the dollar bills once used to purchase their wares. The smaller the bill, the less it would buy. They say the penny is now worth more as a metal than its currency value. Try collecting pennies big time and watch some copper mine executives calling on you for some "ore."

If the people had to trade in their huge paper dollars for smaller and smaller sized currency worth its value, Congress's game would be up. If they taxed us, we would know it and if they had to resize the currency such as the Liddy Dollar Sizing System, to match its devaluation, we would also know it. And in all cases, G. Gordon Liddy would forever get the first reduced sized dollar. Just as the one we show below.

This picture above was taken in 2010 and inflation has not stopped in between then and now. Think of the dollar continually getting smaller like the Incredible Shrinking Man. Perhaps one day, even tweezers will not be small enough to pay a dollar for a dollar's worth of what once was penny candy?

Inflation without dollar resizing makes it very difficult and probably more like impossible for both consumers and businesses to plan ahead. When businesses cannot plan ahead they like to have fewer employees around to pay if they are not sure that they will need their labor.

So, Jobs! Jobs! Jobs! do not occur in times of economic uncertainty. Since this is and has been a time of uncertainty,

Then the postman, in addition to doing regular mail, could pick up the cash from the mail box and turn it into the US treasury. It may not really be able to be done now (2016) with real dollar bills but if Obama had his way, and he could stay just a little bit longer, this could all be done electronically.

You would then have to spend only what the government has not taken. You could never cheat the government. What a great idea! Can you imagine how easy it would then be to contribute your "fair share?" Nobody would be left out of the reach of the automatic electronic hand of the IRS.

Some might call this a "virtuous cycle" as it adds to the pool of invest-able business credit; it lowers real interest rates; and it creates further business investment and jobs.

Glenn Beck and others have been analyzing our spending patterns, especially as the patterns relate to Defense. Many, many conservatives worry that the President is too naive about the dangers in the world. Many think that he believes that the US should unilaterally disarm. They view him, the President, in his usual and customary role of the Pied Piper enabling all other nations who are apt to follow the Piper, to disarm.

If we can get past that without totally ignoring Obama's propensity to do good even if it is bad for America, Glen Beck and others have shown that major savings could be garnered by getting it all done quickly in Iraq and Afghanistan, and the elimination of ISIS, countless billions and billions could be saved. There are also solutions for Medicare and social security that will not bankrupt anybody and not stiff any current beneficiaries. The more important future scenario is that America still exists and America is still a capitalist country!

So, then what is the simple secret?

Fannie and Freddie are bad twins!

"The Federal Home Loan Mortgage Corporation (FHLMC), known as Freddie Mac (NYSE: FRE), is a government sponsored enterprise (GSE) of the United States federal government... The FHLMC was created in 1970 to expand the secondary market for mortgages in the US."

"The Federal National Mortgage Association (FNMA), known as Fannie Mae, was set up to be a stockholder-owned corporation chartered by Congress in 1968 as a governmentsponsored enterprise (GSE), [it] was set up as a stockholderowned corporation chartered by Congress in 1968 as a government-sponsored enterprise (GSE), but founded in 1938 during the Great Depression.

Fannie and Freddie have a big role in what some might call the welfare state but it goes even further. What do these financial cousins, Fannie and Freddie actually do? Their mission was and is to buy mortgages from savings and loans, banks and other lenders. The bank makes its profit on writing the mortgage up front and Freddie and Fannie assume the mortgage. This gives more cash for banks and other lenders so they can make many more home loans.

Unfortunately for Americans, Fannie and Freddie together, right now either hold or guarantee \$5.5 trillion of mortgages. This is about half of the US's outstanding home loans. Think of how big this trough can become. Thank you Barney, Chris, and Paul.

How did Freddy and Fannie go bad?

So what got these institutions in trouble? Well, as home prices fell, foreclosures went up, and lenders ran into trouble, as did Fannie and Freddie. Loans they backed went bad, capital became harder to come by and it was harder for Fannie Mae and Freddie Mac to find buyers for their loan packages. So, what did they do? The politically correct answer is that they compromised and compromised and this led to lower and lower standards and so they were "forced" to back even riskier mortgages. As we learned in 2008, all this came back to bite them. Barney, Chris, and Paul were there from the beginning, and should take credit for helping to cause the collapse.

Barney, Chris, and Paul had the banks as well as Freddie and Fannie over a barrel so they squeezed them to take on bad loans. The system had to break. The caretakers actually broke it. These are the kind of loans in which the mortgagee brings nothing to the closing and if need be his lawyer, at the closing, types up a fake W-2 and other needed documentation to assure the loan. Everybody at the closing and the approving bank officers all knew this was a sham.

But, by getting the documentation correct, at least the bank would have a record of why they approved the loan to the applicant. It was forced institutional fraud. Everybody knew it was a joke, but they had to commit fraud in order to be in compliance with the banking laws. In the last twenty years or so, being a liar was essential to being trustworthy in the financial industry.

There is no secret anymore. The government knows what happened. Yet, Barney, Chris and Paul are even now trying to pass legislation that makes permanent the notion of too big to fail, subtitled, the government will bail you out if you fail.

Democrats v Republicans on financial solution

In the last third of April 2010 as I was finishing this book for its first edition, the Republicans were trying to figure out how to tell the American people that the big three -- Barney, Chris, and Paul, but mostly Chris, were really not trying to regulate the industry. They were actually trying to set up the country to have to pay for the next bailout. With President Obama out on another campaign tour to sell "banking regulations" to the people, the Republican dilemma is that the people wanted good banking regulations. Unfortunately, many people still trust Obama, Pelosi, and Reid, and even Paul Kanjorski, six years later for that matter. They still can't or won't believe that Congress can intentionally perpetrate a fraud on the American people. The fact is that Republicans and Democrats had a deal going to make sure the legislation stopped Wall Street in its tracks when the Democrats, my political party, with Chris Dodd, a big part of the original financial crisis in charge of negotiations, pulled out and softened the legislation.

Among other things, it created a \$50 billion slush fund to bailout any banks that failed. When that \$50 billion was gone, the legislation authorized Congress to grab another \$50 billion for the next "too big to fails," to not fail. The people want banks to fail if they squander the people's assets. Get bad banks out of the system. The Dodd-Frank legislation did not do that. Yet, such legislation must for the stability of the future.

Despite the facts, with Obama on another whirlwind campaign tour, Republicans had a tough problem convincing the loyalists in the Democratic Party that Congress has set the people up again for a round of perpetual bailouts.

Should Fannie and Freddie Fail? I say yes again. Maybe housing will get so affordable that regular people can afford to buy homes again. We need to get all this bad debt off the books and let the people who gained, pay the price -- not the taxpayers.

Besides dealing with "too big to fail" in a responsible way, the long-known secret to solving the recession is to simply *cut spending and lower taxes*. I would recommend corporate reforms for offshoring and we also need to correct the problem of illegal interlopers holding American jobs. Both of these were well covered and explained in prior essays. If we do all that, we can get this ship floating again without using Gordon Liddy dollars.

How do we know this will work? It has worked every time it has been tried from Andrew Mellon to JFK to Ronald Reagan to George Bush. Obama can make history if he too does what he should. More than likely however, we will have to wait for Donald Trump to be President. Veronique de Rugy of the Cato Institute, a Conservative Think Tank sees it this way:

"Changes in marginal income tax rates cause individuals and businesses to change their behavior. As tax rates rise, taxpayers reduce taxable income by working less, retiring earlier, scaling back plans to start or expand businesses, moving activities to the underground economy, restructuring companies, and spending more time and money on accountants to minimize taxes. Tax rate cuts reduce such distortions and cause the tax base to expand as tax avoidance falls and the economy grows. A review of tax data for highincome earners in the 1920s shows that as top tax rates were cut, tax revenues and the share of taxes paid by high-income taxpayers soared."

Don't expect fundamental change until this fundamental law is followed (enforced) by the current Administration. A better solution is if we are able to change the Congress and the Presidency before it is too late. I hear there is a great leader named Donald Trump ready to take charge of the Executive Branch when elected!

To repeat, the bottom line on ending the recession is to cut spending and reduce taxes. Neither of these will occur, I am afraid, if it is left to the Obama administration. But, the good news of course is they are on their way out!
