Executive Summary:

This book has a unique structure. It consists of three chapters taken from a book titled, Top Ten American Political Books for 2018. The three chapters are synopses of three books I wrote as a total solution for the problem of 60 million illegal aliens residing in the USA.

- 60 Million Illegal Aliens in America!!!
- Pay-to-Go
- Legalizing Illegal Aliens Via Resident Visas

The original full book titles shown above were written in the fall of 2017. The key immigration programs for the 60 million resident interlopers are called Pay to Go and Resident Visa.

These programs solve the problem with 60 million interlopers residing in the US, and also solve DACA and Sanctuary Cities. They also set the stage for better management of current green card holders and anchor citizens.

Here is the solved problem in a nutshell. The benefits come to Americans through a decrease in the crime rate and not having to pay the cost of welfare for non-Americans enrolled in the Resident Visa Program.

1. Crimes:

The 2011 GAO report titled CRIMINAL ALIEN STATISTICS shows the extent of the crime problem caused by illegal aliens. The situation has gotten worse, not better. The report examined 251,000 criminal aliens in federal, state, and local prisons and jails. Those aliens were arrested nearly 1.7 million times for close to three million criminal offenses.

Sixty-eight percent of those in federal prison and 66 percent of those in state prisons were from Mexico. Their offenses ranged from homicide and kidnapping to drugs, burglary, and larceny. The real numbers are actually worse as the statistics are admittedly lacking those crimes committed by illegal aliens who are not incarcerated. The numbers would be higher because prosecutors often agree to drop criminal charges against an illegal alien when they are assured that ICE will deport the alien. We can estimate the cost of illegal aliens on the us criminal system as follows

- At Approximately \$300 per arrest, 1.7 million arrests = \$510 million
- At approximately \$60.00 per jail day, 365 jail days per year for 251,000 criminal aliens comes to \$5.5 billion
- At approximately \$700 as an estimate of the cost of a crime, with 3 million crimes committed by illegal aliens, this comes to this comes to 2.1 billion.
- The total cost of illegal lien crime is thus \$8.1 billion, which is more than likely a low estimate.

2. Dollar costs for medical, welfare, etc.

An estimated 49 percent of households headed by legal immigrants used one or more welfare programs in 2012, compared to 30 percent of households headed by natives. Less-educated legal immigrants make extensive use of every type of welfare program, including cash, food, Medicaid, and housing. Recent restrictions on new legal immigrants' access to welfare have not worked. They have not prevented them from accessing programs at high rates. The overwhelming majority of illegal immigrants have low levels of education; therefore, the high use of welfare associated with lesseducated legal immigrants indicates that their legalization (green card) would likely increase welfare costs, particularly for cash and housing programs.

U.S. law enforcement agencies have observed that identity theft and illegal immigration "go hand in hand." Identity theft in many states is a felony. Because it is virtually impossible to live and work and collect benefits in the United States without documents, interlopers turn to fraudulent document dealers for falsified Social Security cards, forged drivers' licenses, counterfeit green cards, and a wide range of other phony documents. They commit identity theft to get what they need from the US system.

President Trump says that illegal aliens cost the US \$113 billion per year. I have statistics that show that this number is as high as \$500 billion per year. Moreover, professional analysis of the reduced and lost wages for Americans considering that illegal aliens often work

for below minimum wages creates a net loss to Americans approaching another \$500 Billion per year. If Americans knew the cost, they surely would not opt to pay for foreigners.

Think of what can be done with as much as \$500 billion in treasury savings and by increasing the purchasing power of Americans by \$500 billion.

The consensus cost for welfare for non-citizens is about \$30,000 per person per year. It is staggering. Americans would choose not to afford it. Many legal and illegal aliens use welfare as a means of survival.

SOLVED: The Pay-To-Go and Resident Visa Programs solves the problem 100%

These two programs are paid for by either illegal interlopers on welfare agreeing to voluntary deportation with a \$20,000 stipend, or agreeing to the terms of the new "no American cost" Resident Visa" program. The stipulations include full vetting, jobs for Americans first, never voting, no citizenship, and no freebies of any kind. Those not approved for the resident visa program may use self-deportation with a nice stipend through Pay-to-Go or coerced deportation.

As noted, each welfare recipient costs as much as \$30,000 per year. The backup dollar figures are in the chapter synopses in this book, and in the detailed books.

At 100% participation, which would be a requirement for illegals already in the country, estimates are as high as \$500 billion per year cost savings. Plus, with the negative impact on lower wages, and loss of jobs negated with these programs, another \$500 Billion of additional citizen purchasing power would be expected. These are huge numbers and they are real. The US can be as much as \$1Trillion to the good. If we can figure a way for countries to take back their criminals, there is another \$8.1 billion to be recovered.

The cost savings come when all foreign interlopers have either selfdeported, been deported by coercion, or have signed up for the Resident Visa Program. To repeat, once these two programs are in effect, illegal aliens who have not signed up for either of these very generous programs will be deported.

Those currently on welfare may apply for a two-year non-renewable welfare extension to get them through the transition period. At the end of the two years, there will be no more welfare for Resident Visa Holders. Those in this status may be granted benefits under the Payto-Go program including the \$20,000 stipend.

An accountability system should be built anticipating the savings of the programs. During the vetting process, demographic and financial information must be collected on each interloper. This information should not be discarded lost. Instead it should be stored in a permanent accountability database which may be used to store any temporary welfare and/or medical charges for later repayment.

There would be no charge at all for an interloper choosing the Pay-to-Go option and all transportation costs to wherever, would be covered. After one year at \$30,000 off the system, this money will all be back in the treasury.

To attain a resident visa, the first-year fee would be \$200 and the annual renewal fee would be \$100.00. Electronic vetting would be used to determine the annual renewals for the Resident Visa. Resident Visa holders will lose their approved status by not abiding by the stipulations of their contract or by committing a crime. Before being granted status, the interlopers must agree to all the terms and be vetted first at a cursory level and then in person. T



Chapter 8 Legalizing Illegal Aliens via Resident Visas



A great Americans-first plan which saves \$Trillions. Learn how!

Book purpose:

Despite our best efforts pre-Obama, for the 32 years after the 1986 Reagan Amnesty, the flow of interlopers across the border and from visa overstayers brought in from 1 million to 4 million illegal aliens per year. That means anywhere from 32 million to 128 million found homes in America during this period. It is a national crisis.

Obama's lax immigration policies in which he basically told our Border Patrols to stand down made matters even worse over the last eight years.

Meanwhile, many Americans forgot they once had jobs and they began to believe that their depressed wages caused by illegal immigration would never abate. Democrats convinced them that maybe it was their fault.

Former president Obama took no action in eight years to protect Americans and so when President Trump ran for President, there were already many who had been affected negatively and they voted for Trump en-masse. They hoped that the flow of illegal foreign nationals would stop and that we could deport those who had entered illegally.

Liberals try to convince Americans that there are just 11 million illegal foreign interlopers, but nobody is buying it. The same song has been played for the last twenty years. John McCain's estimate is 128 million and my own estimate is 60 million. These people live in the shadows, take American jobs, and for each one on welfare, they cost US taxpayers about \$30,000 per year. The total is about \$500,000,000,000 per year and the effect on low wages and few available on Americans is another \$500,000,000,000 per year. It has to stop now.

Despite the toll on our country, most Americans see deporting 60 million or even 11 million foreigners as cruel and unusual punishment. At least that is what the crooked press wants us to

believe. I wrote this book because I have a better idea. We can legalize all of the 60 million after a comprehensive in-person vetting process and a first-year fee of \$200.00 and \$100.00 in each subsequent year.

If the interlopers agree to the provisos and are approved after vetting, the one-time interlopers would receive an annually renewable new type of visa, called a resident visa.

The notion of a resident visa permits us to solve the problem of 60 million interlopers without any deportations other than for criminals and unsavory characters. It is a permanent program that puts Americans first in all matters. It is such a good idea that it can actually replace the green card and the notion of anchor babies. Instead of birthright citizenship, anchor babies would get a resident visa with no welfare.

illegal foreign national legalized under this program would be eligible for a citizen aspirant designation.

What if a current interloper does not want to give up welfare benefits. Such a person can sign up for a companion program covered in a book titled, Pay-to-Go. A stipend of from \$20,000 to \$50,000 plus transportation costs will be paid to anybody in former illegal status or in green card status or anchor baby status. They can take a nice bundle of cash to their home country with each family member receiving a substantial amount. "In 2005, a left-leaning blogger wrote, "Illegal immigration wreaks havoc economically, socially, and culturally; makes a mockery of the rule of law; and is disgraceful just on basic fairness grounds alone." In 2006, a liberal columnist wrote that "immigration reduces the wages of domestic workers who compete with immigrants" and that "the fiscal burden of low-wage immigrants is also pretty clear." His conclusion: "We'll need to reduce the inflow of low-skill immigrants."

"That same year, a Democratic senator wrote, "When I see Mexican flags waved at pro-immigration demonstrations, I sometimes feel a flush of patriotic resentment. When I'm forced to use a translator to communicate with the guy fixing my car, I feel a certain frustration." The blogger was Glenn Greenwald. The columnist was Paul Krugman. The senator was Barack Obama. See how much they have changed. Today, even these three champions of the left would have their Democrat cards pulled for uttering such speak.

Americans have not changed. We are still not at all happy about any amnesty. Thus, no solution for the 60 million interlopers living freely in the shadows of America with no fear under former president Obama-style protections can come without Americans being the winners.

The Resident Visa Program as proposed in this book takes a hard look at Americans who do not want to deport illegals en masse yet want the country back under full American control. Foreign Nationals should have no say and certainly no vote. Looking at the reality of our times, it is time to offer Americans a solution to the 60 million residents that we can live with and with which, all Americans can prosper.

- 5. Must speak English

The Resident Visa Program (RVP) as proposed in this book provides these assurances for Americans. For an illegal foreign national to be granted such a visa, they would be required to swear that they agree 100% with the five items Americans care most about as well as others that would be part of a total resident visa package.

One at a time, candidates for the program would pay \$200 each to be vetted. If accepted, they would gain a one-year residence pass known as a resident visa, paperwork, and an ID card with biometrics that must be kept on their person at all times. Their visa would be renewable every year for \$100.00 as long as they remain model residents, a term which will be defined to mean all aspects of "keeping their noses clean."

This visa is intended to take all illegal foreign nationals out of the shadows and into the light of day. There may also be some fines and fees for having broken American law that can be paid "on account."

The cost savings for Americans are immense.

No analyst estimate on the cost of illegal aliens is below \$100 billion per year. When all of the services are totaled up, there are estimates of cost savings higher than \$500 billion. America can save \$500 billion or more per year in direct costs by enacting this legislation.

Additionally, there are studies that demonstrate the costs that are born by Americans per year for illegal foreign nationals lowering wages and taking the jobs of Americans. These are estimated at another \$500 billion per year.

It would not take even five years for most of these dollars to begin to flow in America's favor. This is a big economic deal for Americans. Since to be approved, Resident Visa Holders must agree to a "no freebies" clause in the contract, I would suggest a two-year, non-extendable, continuation of existing benefits for those already on welfare. After that, former interlopers would either pay their own way to keep the visa or select the Pay-to-Go option explained in this mini-book.

Side Benefit: DACA & Sanctuary Cities Solved

Among other things, this automatically solves the DACA problem and the sanctuary city problem. No sanctuaries are necessary when everybody can be legal and productive in the USA. As a concession to Democrats, DACA "children" should have their annual renewal fee canceled for ten years, but they still must renew each year. as all other resident visa holders.

Additionally, different forms of the Resident Visa can be created so that we can do away with all of the benefits such as welfare that come with green cards. There would be substantial cost savings there. Rather than ten-year renewable permanent residents in line for citizenship, those who would be green card holders under today's program would become Resident Visa holders instead and those in the green card program would change to resident visa holder at their ten-year renewal. This special visa form would permit citizenship.

No former illegal alien who becomes a resident visa holder under this program would ever be able to change status to get in line for citizenship. Only by going back to the home country and approaching it legally from there would this be possible.

I wrote another book titled *Pay-to-Go*, which is also examined in the Top Ten book from which this book was extracted. *Pay-to-Go* demonstrates the major cost savings that would accrue to the US

by providing huge stipends as high as \$20,000 for illegals who agree to permanently depart the US for their home country.

Restricting their access to welfare has been a principle of American domestic policy since colonial times. The federal law, established in 1882 and strengthened in the early twentieth century, was that immigration officials should refuse entry to any non-citizen who appeared likely to become a "public charge" and should deport those who did, although actual deportations of public charges have been rare. When a sitting president suggests that ICE look the other way on illegal non-citizens, it makes our laws a sham and makes America the caretaker of all the world's poor.

The Obama Agriculture Department blatantly solicited food stamp recipients from among the illegal population.

A Spanish-language leaflet was created in 2013 that the U.S. Department of Agriculture has provided to the Mexican Embassy in Washington advises border-crossing Mexicans that they can collect taxpayer-funded food stamp benefits for their children without admitting that they're illegal immigrants.

Underlined and in boldface type, the document tells immigrants who are unlawfully in the United States that, 'You need not divulge information regarding your immigration status in seeking this benefit for your children.'

While other countries are reducing what they will give to foreigners living legally in their countries, the US gives as much to foreigners as to Americans. No wonder they come here illegally when there is no enforcement of anything. For example, After a recent meeting on the National Immigration and Integration, French Interior Minister Manuel Valls announced significant changes in the country's migration policy. The government will reduce financial assistance to immigrants, and this reduction will be substantial. Starting March 1, French immigrant benefits will be cut by 83 percent.

America is not the only country in this bind of having too many residents from foreign countries who are on the public dole, though America pays the top amount to foreigners living here legally and illegally.

Countries as far away as Australia have problems with migrants taking native jobs. They use a technique called the Assisted Voluntary Return as part of an overall Pay-to-Go plan to incent migrants to leave Australia and return back home. They are OK with these migrants going home with or without Aussie assistance. As noted, one of the books you will take a peek at in this book is titled, "Pay-to-Go." That book explains it all.

This notion, which is not an American idea, across the globe, pays both travel expenses and offers a generous stipend for those in potential despair who sign up for the offer to return home. Ch 1 Is There a Solution? 60 million interlopers cost taxpayer dollars

If we knew how to immediately stop the drain on our government treasury with one bold and very fair move, would America's inept politicians make that move? I have done many analyses and I have concluded that American politicians, from Congress and the Senate on down. will never support Americans unless convinced that they would be out of office otherwise.

Based on what it costs to support illegal foreign nationals (average of \$30,000 per person per year), the US can certainly afford to deport millions of people. But, the dirty politicians and the corrupt press preach a different mantra that puts Americans last and illegal aliens first.

Ironically, though Americans complain about all of the illegal aliens, supporting them, having them take their jobs, and lowering the average wages in America, most would prefer a different solution than rounding them up and deporting 60 million people. But, we can afford deportation if we choose. If nobody was collecting welfare, this would be a lot tougher, and if nobody in illegal status was stealing from Americans, maybe no American would care.

Can we afford a mass deportation of illegal foreign nationals—even without a roundup?

Is there a consensus for or against the idea? It only matters if the US can actually afford to undertake a mass deportation?

Let me prove that we can afford deportation before we move on to solutions that we can stomach. I am not recommending mass deportation, but we can certainly afford it and the US can save lots of money if we chose to do it.

Let's say that 30 million of the 60 million illegal aliens in residence collect some form of welfare from the US to help afford their lives in America. What does that cost us per year?

The cost per year is \$30,000 X 30,000,000 = \$900 Billion per year The cost of deportation is \$10,000 X 30 million = \$300 Billion one time

The first-year savings is a net of \$600 Billion after deportation. The second and subsequent years, the savings would be the full \$900 Billion per year

Rather than look at the unpleasant task of coerced deportation, many countries across the world have instituted what they call Pay-to-Go programs in which a free return and a stipend incentive are offered to the migrants to induce them to return home. In our country we would be incenting illegal interlopers living in the shadows of America.

A very nice stipend amount that would persuade many interlopers to return to their home country is \$20,000. In this way, the deportation is really a voluntary emigration back to the home country.

The cost of the stipend at $20,000 \times 30,000,000 = 600$ Billion one time. This is if the country is the USA.

In this example, the cost of the return and the cost of the stipend would be \$900 billion if every interloper agreed to return home and then executed on their promise.

This is the same amount as the cost to support all interlopers in the US for one year. The difference between the two is the savings. In year 1, in this scenario, the savings would be zero dollars and the cost would be zero dollars. In year two an annual savings of \$900 billion would begin to accrue. Where does the savings come from? It comes from the US not having to pay welfare to illegals as well as Americans being able to get jobs that pay substantially more than when the interlopers were depressing wages by accepting subminimum wage positions.

Suppose the Pay-to-Go stipend were raised to \$50,000, to attract more takers, the annual savings of as much as \$900 billion would begin to accrue in year three so the stipend could be paid for. After year three, the US is in the black on the program.

Talk to your Congress

I predict that the biggest obstacle in solving the problem of 60 million illegal interlopers in America will be both chambers of the US Congress. I am not naïve enough to suggest that the current Congress' predilection for more voters and lower wages for all Americans could be overcome by the fact that this plan to deal with resident interlopers is the best yet conceived. So, if they remain recalcitrant, we may be forced to replace the entire Congress in order to do the right thing for America.

John McCain is known for his personal estimate of about 4 million per year jumping the border. He is talking about Illegal aliens, which we like to refer to as illegal interlopers. An interloper is another word for an uninvited guest.

McCain's estimate is of those who have chosen to cross the southern border. In his estimate, he does not include the million or more a year who simply decide not to go home when their visas expire. Instead they opt for illegal residency in the US. That's how we got into this problem in the first place. We did not invite 60 million people to America to sponge off US taxpayers. However, some of our elite representatives may very well have done exactly that.

US. amnesty advocate John McCain, is a recognized authority on the subject of illegal immigration. In a letter dated February 2004, he wrote that apprehension figures demonstrated that "almost four million people crossed the US border illegally in 2002."

McCain estimates over 10,000 cross every day. If it were exactly 10,000, then 3,650,000 per year would be his estimate. Instead he simply rounded it up to 4 million. That comes to 128 million from 1986, the year of the Reagan amnesty to the end of 2017. If we cut that in half and round it down, we're looking at my long-time estimate of 60 million interlopers in residence today. I know that nobody can prove me wrong on that number.

What about legal immigration?

About 1.2 million green cards are expected to be issued in 2017. In 2014, a total of 1,016,518 persons became lawful permanent residents—aka, LPRs complete with green card status. Over half of the new LPRs (53 percent) already lived in the United States when they were granted lawful permanent residence. Sixty-four percent of the new LPRs were granted lawful permanent resident status based on a family relationship with a U.S. citizen or lawful permanent resident of the United States. The leading countries of birth of new LPRs were Mexico (13 percent), India (7.7 percent), and China (7.5 percent)

The other type of legal resident in the US is known as a birthright citizen, colloquially known as an anchor baby.

If the stipend is a little higher, the Pay-to-Go Program could save the US another ton of funds if it were also used to attract green card holders on welfare, and anchor babies on welfare. When and if they agreed to return to their home countries there would no longer be a cost for their welfare. Think of what the US could do with another half trillion or as much as a full trillion dollars per year to spend on American interests?

The three categories for which the program could be used in the future include the following:

- 1. Current interlopers
- 2. Legal green card holders on welfare
- 3. Anchor babies at any age, including children supervised by a legal or illegal parent.

The recommended stipend for each of the three categories would be as follows:

1.	Current Interlopers	\$20,000
2.	Legal Green Card Holders on Welfare	\$30,000
3.	Anchor Babies or Adults	\$50,000

Anybody opting for a stipend in any of the above categories would be prohibited without special petition from ever returning to the United States for any reason. Any debt accrued that is accounted for in the Accountability system, explained in Chapter 17. would need to be collected prior to any request for readmission to be examined.

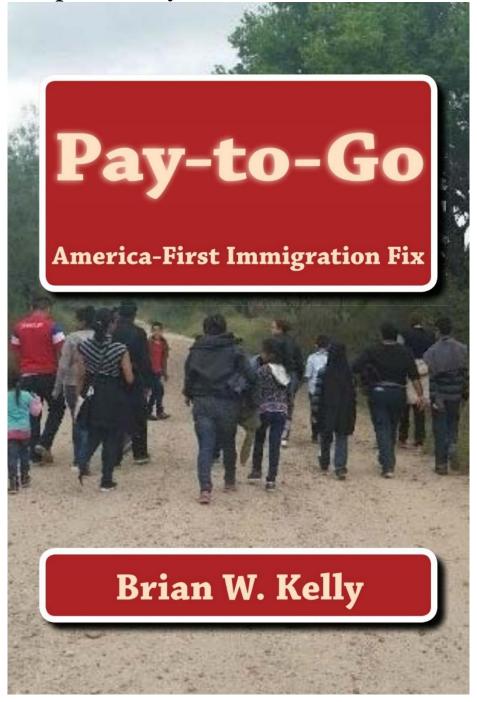
There are 15 million legal immigrants (green card holders) currently in the country. Half of them are on welfare. 7.5 million X 30,000 = 225 Billion per year. There are 6 million birthright citizens (former anchor babies) born to illegal aliens currently in the country. They are almost all on welfare 6 million X 30,000 = 180 Billion per year

The US can thus save an additional \$405 Billion per year by adding the above two categories to the illegal interlopers able to use the Pay-to Go program or any other program that reduces costs to zero. This would make a total of three categories for which the program could be used.

What problem does the Pay-to Go program fix? It is a pro-America and pro-American citizen solution. It is an America-First solution to the major problem of 60 million illegal residents sponging off the taxpayers in the United States.

Once in the continental US, the interlopers either wholly or partially depend on US taxpayer dollars for their daily sustenance. Is your wallet looking a little thinner these days? The problem we plan to solve in this book, the real problem, is that 60 million illegal foreign nationals cost Americans money every day. They just don't pay their way and live here. They take from US.

Chapter 9 Pay-to-Go



America-First Immigration Fix

Book purpose:

In Chapter 8, Legalizing Illegal Aliens Via Resident Visas, we discussed the purpose of a plan that legalizes illegal aliens who choose to stay in America with conditions that include no vote, no welfare, no citizenship, etc. In the beginning of the chapter, we presented a summary of the plan.

This book, Pay-to-Go, with a plan of the same name, Pay-to-Go, is a companion program to the Resident Visa Plan. It has many of the same purposes. The difference between the two major plans is that under Pay-to-Go, illegal foreign nationals choose not to stay in America. Instead, they go back to their home countries for good. To help them out when they get home, the US provides them full transportation costs plus a stipend from \$20,000 to \$50,000 depending on their status:

- 1. Illegal Alien
- 2. Green Card
- 3. Anchor Baby.

After a year or so, based on the cost of welfare, and the size of the stipend, the US government under Pay-to-Go will save \$30,000 for each person who takes this deal. If everybody took the deal, this would save the US over \$500 billion per year. Similar savings are achieved for those who choose to stay in America under the Resident Visa Plan.

Most illegal foreign national live with welfare support

Illegal immigrants living in the shadows use stolen and fake IDs to survive. It is a fact. It is much easier than you would think for those in the hidden economy of the US to gain welfare benefits including healthcare. Hospital social services departments are motivated to sign illegals up for Medicaid rather than absorb the EMTALA (ER) costs themselves. The estimated cost per illegal on welfare is \$30,000 per year. That is a lot of money. The fake news estimate for how many illegals live in America is about 11 million. Donald Trump estimates the number at 30 million. However, if we consider that since 1986, thirty-two years ago, from one to three million per year have crossed our borders without documentation.

That means that by all accounts, we have between 32 million to 96 million foreign interlopers scratching a living from the shadows using fake ids, welfare, and whatever means possible to survive. John McCain has estimated that there are 128 million foreign interlopers in America today. So, for a reality check, let's just say the number is closer to 60 million than 11 million. Yet, our statistics systems are so poor that nobody really knows.

There are estimates that the US welfare agencies at various levels as well as health agencies and school systems spend as much as \$500 billion per year taking care of illegal foreigners. Considering that as many as half of the green card holders, who are permanent legal immigrants are on the welfare dole in one way or another. The costs to American taxpayers are staggering.

If we permitted all such residents who wanted to go home to go home all expenses paid, and we gave them \$20,000 to as much as \$50,000 in the form of a stipend to leave, in as little as one year or as many as three years, the US would have a net gain of as much as \$500 billion per year thereafter. 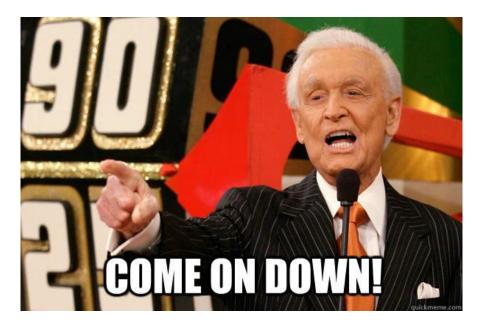

Ch 1 Introduction to Pay-to-Go A Land of Immigrants



The US for all of its existence, even before the War of Independence, would be characterized as a migrant receiving country. From colonial days until now our population went from a few thousand to 325 million and of course everybody here today was not born in America. We are truly a land of immigrants.

We currently take in a million to two million legal immigrants per year and from two-million to four million illegal immigrants aka foreign interlopers. The interlopers (uninvited "guests") get here by either crossing our borders without authorization or over staying legal visas. The four million figure comes from Senator John McCain, a well-known authority on immigration. The US is clearly the largest receiver of migrants in the world.

If you resemble that remark, more than likely, you can thank past President Obama who continually intervened to assure nobody was left behind; nobody was really deported; and there were no restrictions on foreign interlopers taking American jobs—even those that had been in the family for years.

And, yes while simply being employed on a sub-minimum wage scale, our uninvited guests have unwittingly helped millions of greedy businesses lower their normal and customary wage in the country so that it is tough for anybody doing physical labor to make ends meet today.

The US has never used a pay-to-go approach in our history, but it is about time we gave it a try. Our treasury is being overwhelmed by demands from foreigners for more welfare. The cost of interlopers to our economy and our treasury is overwhelming. Pay-to Go (receiving return transportation costs and a stipend for returning home from a host country such as the US) can even the playing field again and save the US hundreds of billions of dollars to boot.

Unlike America, other immigrant-receiving countries have for decades employed policies to encourage unauthorized immigrants to return to their home countries without the cost, legal barriers, and political obstacles of removals or forced returns—i.e. deportations. The US is a young country and we need to examine closely how others have dealt with excessive immigration and what can be termed pay to stay welfare benefits.

In other countries, nudging an interloper to go back home are a series of noncoercive, pay-to-go, voluntary, assisted voluntary, and non-forced returns. The countries generally offer paid travel and/or other financial incentives such as stipends to encourage unauthorized immigrants to cooperate with immigration officials and leave host countries to return home.

Ch 2 Pay-to-Go Plans in Other Countries Paying a migrant to return home can work

Time Magazine online tells a story of Nexar Sambrano, who seemed to be living the immigrant dream in Spain. He had come to Barcelona in 2005 after leaving a near-subsistence existence on a farm in Ecuador. Times were good. He found a good-paying delivery job with the local beer company. Unfortunately, things changed.

After 18 months Nexar was doing so well and had tucked enough savings aside that he was hoping to bring his children and his girlfriend over to join him. Out of nowhere, the recession hit, and it affected everybody. Nexar lost his job. He was talented in the trades and was able to get by with odd jobs such a painting or doing masonry. However, it just was not enough.

Time quotes him as saying: "I was relying on my friends for food." So, when the Spanish government offered him money to go home, he took it. When this Time piece was written it had been over two years since Spain had enacted its Voluntary Return Plan for immigrants, which grants legal residents who lose their jobs the right to receive their entire unemployment benefit in two lump sums — one upon departure, and the second after arriving in their country of origin. This is part of a trend in countries who had once been welcome hosts to migrants when things were good, and they needed extra labor to get the work done.

Over the last several years, some 17,000 documented migrants from the U.S., Eastern Europe, and Africa have signed on to the plan, part of a successful effort, says the government, to reduce the pressure on the Spanish economy and spark development in other parts of the world.

Too many people in a country is not good

The last thing that any country needs, especially as we have yet to fully climb out of The Great Recession is an excess of people. Among other things, they will be demanding to eat and to have a minimum of modest amenities. In the US of course, do-gooders want them all to have colored TV sets, iPads, and other goodies to make their stays comfortable. All of this is very costly to the host country.

Ch 3 Pay-to-Go Programs in History The US would not be the first Pay-to-Go!

World governments have used voluntary return programs with stipend incentives (Pay-to-Go), and without incentives, long before the recent economic downturn and long before interlopers crossed borders illegally to take advantage of the host country's major benefit packages. Pay-to-Go has served various policy goals beyond coping with economic issues, such as what we are examining in America -- combating illegal immigration, addressing the detention of rejected asylum seekers, migrant overpopulation reduction, and promoting development through return migration. For example, France, Germany, Belgium, and the Netherlands experimented with Pay-to-Go programs from the mid-1970s until the mid-1980s due to a poor economic climate, and the infamous 1973-1974 big oil embargo, among other circumstances. These countries sought to provide incentives for both employed and unemployed guest workers to return to their countries of origin. The host countries could not afford to keep them when their own people were not working.

Sixty million illegal foreign interlopers in the US today in a busted economy would not make the situation easier but for sure there would be a lot of takers.

The 2008-2009 Great Recession prompted massive unemployment among the approximately 350,000 Nikkeijin (Latin American workers residing in Japan who at one time emigrated from Japan), residing in Japan. Between November 2008 and January 2009, 9,296 foreigners registered as employment seekers. This was an 11-fold increase from the same period a year earlier.

There have been a number of immigration surveys conducted in Japan. Approximately 40 percent of Latin American workers, most of them Nikkeijin, were unemployed by the end of 2008 and the beginning of 2009, compared to the 5 percent unemployment rate among Brazilians and Peruvians in Japan in 2005.

The recession hit Nikkei (Nikkeijin) workers hardest, as many relied on contract-based employment and jobs that are sensitive to economic fluctuations.

With the economic hardships, massive return migration to Latin America has occurred, primarily due to large-scale layoffs of Nikkei workers and their inability to find new jobs before their unemployment insurance expires.

The point of all this discussion is that Japan uses incentive methods as necessary to move segments of the population to other countries to help its own citizens.

Ch 4 Pay-to-Go Down Under No coercion necessary

The informal notion of a voluntary return or voluntary repatriation is most simply explained as a migrant, after arriving in a host state willingly deciding (no coercion) that they would like to return home (aka country of origin). More formally, we can say that it is the return of a displaced person, a rejected asylum seeker, a refugee, a victim of trafficking, or a stranded migrant who is unable or unwilling to remain in the host country and who volunteers to return to their country of origin.

There are various programs in different countries to help such people leave and return to their home countries when it is appropriate or simply when they are ready to come back home. The programs are most often built with some level of assistance in the expenses of travel to get home and sometimes they also include a stipend and sometimes they include assistance in the home country for reintegration and resettlement.

In Australia, for example, their AVR program is used as a vehicle to help migrants. It is also used to thin out any overpopulation of migrants who, in times of recession, may very well hold positions that citizens desire. The program helps the return of migrants who have no ongoing legal avenue to stay. However, the program once in effect is generally available to any migrant who needs assistance to return home.

Through small policy changes, Australia had been able to learn from AVR programs in other countries who are suffering similar circumstances with an over population of foreign-born noncitizens. The learning has helped Australia achieve a greater number of returns, thereby reducing the drain on their treasury.

As much as the US is a major magnet for the world's migrants, it is also substantially easier and far less expensive to get to than Australia. Australia might in fact be even more crowded than the US if the migrant population could get there by walking, by motor car or motor coach, or by railroad.

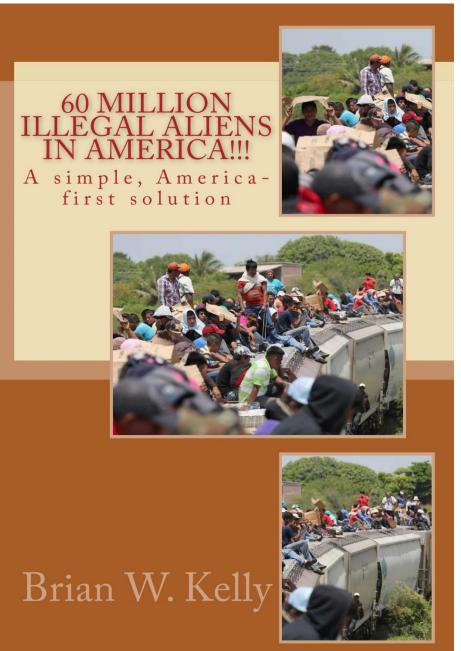
Pay-to-Go AVR programs

All AVR programs are designed to assist migrants to return home. The kind of assistance to a migrant varies from case to case depending on the national policy of a particular host country. The US would do well to follow Australia's lead.

I wrote this book to help Americans know what our President and Congress can do to help force our government to regain control of our borders, ensure our national security, keep our culture, enforce our laws, protect American jobs, make our language the language of the nation, and keep all Americans from being overwhelmed by illegal foreign nationals who offer few benefits and no allegiance to America.

At first look, I found no real solutions other than either amnesty or follow the law with deportation. The Resident Visa solution is unique, and everything needed to implement it is already in place.

The Resident Visa solution directly addresses the issues that having 60 million illegal foreign nationals in residence have brought upon America. The Gang of Eight approach rewards illegal activity and makes everybody OK and is a bad example, and another approach gives most people a bad, sinking feeling in their gut. That's why nobody has come forward to suggest that 100% deportations are really a good idea for the country. Americans have big hearts. Deportation is fair of course as these folks have broken our laws. But, our politicians are culpable as they made it too easy for foreigners to break our laws. Amnesty is not a solution as Americans have already paid a big price for the largesse of politicians wanting low wages and those wanting the future votes of today's interlopers.

Ideally, the solution would be to go poof, and every foreign interloper would be taken back to where and when they crossed the border years and years ago. Where is a used Star-Trek Transporter when we need one? This time, however, they would not be re-admitted if they tried to cross.

The raw facts say that the problem never should have reached the level of severity that it is today. Nobody can perform miracles and tricorders and transporters are not invented yet so when we have the closest ingenious thought to a miracle as a solution, we should examine it and embrace it. It is this plan. Doing nothing makes it worse.

After defining the problem in my early books, I developed a methodology that would make Americans pleased and would remove all interlopers from the shadows—and into the light of the American day or back home with some cash in their pockets if they choose.

Like they did in the 1920's, progressives are again trying to undermine America.

I looked at all the things that Americans want in a real plan things they liked and things they do not like. I wanted interlopers to embrace the plan, so they could get out of the shadows without hurting Americans. So, among other things, I examined what interlopers liked about living in America.

In my first cut at solving the problem in 2013, I figured out a way to permit well-behaved interlopers to stay in America one year at a time with a realistic annual renewal fee, while giving Americans priority in all ways. It was a good plan but not as perfect as I had hoped. The biggest problem with the plan was that it was difficult to explain in clear concise terms.

I was convinced that the plan actually would work and that it would solve the problem for the long haul and take a huge financial burden off the backs of Americans. And, so, I kept at it, continually improving it until it was perfected.

Every plan requires fine tuning and we would expect this to continue to be the case with the Resident Visa Plan. By implementing the current iteration of the plan, the long-sought solution to the result of illegal immigration is around the corner.

To see what US officials on the pro-American side of the issue would think about such a plan for America, I contacted Pennsylvania Congressman, Lou Barletta. Many know Lou Barletta as a tireless advocate for fighting illegal immigration and amnesty. He is running for the Senate against a very poor legislator, Bob Casey, Jr., in my state of Pennsylvania. I presented a detailed PowerPoint of my ideas in late January 2015 to the Congressman and his chief aid at the time, Joseph Gerdes. After perfecting the plan even more, I reached out again and presented again in 2016 to the Congressman. I am scheduled for another meeting soon.

The Congressman was most pleased with my presentation and the detail that backed up each and every point of the presentation. The Congressman and I continued to engage in a lengthy dialogue on these issues. We spoke about the difficulties in getting immigration legislation for Americans through the House and the Senate, and he updated me as to where the Congress was with some new initiatives in securing the border.

During this interchange, the Congressman helped me understand what was really happening in Washington. For my part, I helped the Congressman to fully understand the benefits of this immigration fix for as many as 60 million foreign nationals residing illegally in America.

Both Congressman Barletta and President Trump have made the wall and border security their # 1 priorities. This plan addresses those interlopers who are already here. We need to protect the border and handle the 60 million interlopers at the same time for the good of America.

My strong recommendation to Congressman Barletta and President Trump is that we add this immigration fix, which I call "The Resident Visa Plan," to the "Beautiful Wall" and the Bills and the Amendments on Border Security. This would be the best anybody could do to solve the problem of resident interlopers in America once and for all.

This would be the first comprehensive and comprehensible immigration plan ever put forward that favored America and Americans over foreign nationals. It is America-First.

I sent the Congressman a text version of the presentation with its new logical flow so that he could take it, read it, and share it without having to figure out the hidden messages within the bullets of a PowerPoint. This new update and the updates in the two books subsequent to this will be in Senator Barletta's hands at the same time that they are on the street for sale.

As I examined the document that I produced that comprises this book, I realized that it was much more complete than the original Kelly Plan. Its sequencing is much better; and the additions from the Barletta presentation / interview add a lot of missing pieces to the package. And, so, I decided to re-work the text document to make it even better.

In 2013, Americans rejected the Gang of Eight Amnesty Bill. So, here I am again, in my 129th book writing again about the problem of 60 million interlopers making it tough for Americans. This time, however, it is far more simplified and easier to implement.

A key element of this plan is that each year the clock resets on foreign nationals who are permitted here under the Resident Visa Plan. This book, thus focuses on interlopers signing up to become Resident Visa Holders with appropriate renewal assurances for good behavior.

This is **the** tool to accomplish the goal of an America and American-First solution to 60 million interlopers. There are a lot of other adjunct notions besides the Resident Visa Plan such as a solution for visa over stayers, green card holders, as well as a unique solution for current birthright citizens.

The solution for the illegal interloper issue is large enough to warrant its own book. President Trump already has a team of people working on other solutions in the immigration umbrella such as border security and the wall, visa overstays, sanctuary cities and other issues not directly related to the 60 million interlopers taking from Americans every day.

In addition to showing why amnesty is not the right medicine, I take the time to explain in detail the best plan for America to again become a sovereign state with America-loving Americans in charge.

Ch 1 The CliffsNotes Version 60 million interlopers in 60 seconds

I do not have to go far out on a limb to suggest that if we knew how to immediately stop the drain on our government treasuries with one bold and very fair move, our representatives would be forced to adopt the measures necessary to achieve the gains. In this case, it would be to stop the major treasury drain that occurs each and every day to support a population segment of illegal interlopers. The term interloper, whether legal or illegal, means *uninvited guest*.

Based on what it costs to support illegal foreign nationals. we can certainly afford to deport millions of people. However, there are many good reasons why we should not deport anybody other than criminals. Most of the 60 million illegal residents are hardworking and living quiet, orderly lives. We also cannot allow them, as a result of their illegal entry, to become citizens. This would violate the basic premise of following the rule of law that is a key standard of citizenship. This book offers two great solutions to solve this big problem.

By the way, in this abbreviated "CliffsNotes" chapter, we net it out, so it can be well understood. I predict that the biggest obstacle in solving the problem of 60 million illegal interlopers in America will be both chambers of the US Congress. I am not naïve enough to suggest that the current Congress' predilection for more voters and lower wages for all Americans could be overcome by the fact that this plan to deal with resident interlopers is the best yet conceived. So, we may be forced to replace them all (Congress) in order to do the right thing for America.

We cannot let our corrupt Congress get in the way of our solving our problem with the 60 million. I admit that this would probably be more difficult than stopping the treasury loss but at least we would all know what we must do, and seeing Congress packing would be a pleasure to the senses.

John McCain is known for his estimate of a clip of about 4 million per year. Illegal aliens (interlopers) have chosen to cross the southern border or they have chosen to simply overstay their visas in order to gain residence in the US. Amnesty advocate John McCain, who is a recognized authority on the subject of illegal immigration, in a letter dated February 2004, wrote that apprehension figures demonstrated that "almost four million people crossed the US border illegally in 2002."

McCain estimates over 10,000 cross every day. Adding it up, that comes to 128 million by the end of 2017. If we cut that in half and round it down, we're looking at my estimate of 60 million interlopers in residence today. I know that nobody can prove me wrong.

The name of the plan to solve the problem of 60 million interlopers makes sense when you think about it. It is the *Stipend Return / Resident Visa Plan*. The little slash means *or* in this case. The program immediately takes 60 million illegal foreign nationals out of the shadows and saves the US treasury a minimum of a half-Trillion dollars each year after year 1. Should Congress and /or the President pursue this plan? Of course!

What problem does the program fix? It is a pro-America and pro-American citizen solution. It is an America-First solution to the major problem of 60 million illegal residents sponging off the taxpayers in the United States. Once in the continental US, the interlopers either wholly or partially depend on US taxpayer dollars for their daily sustenance. Is your wallet looking a little thinner these days? The problem we plan to solve in this book, *the real problem*, is that 60 million illegal foreign nationals cost Americans money every day. They just don't pay their way and live here. They take from US.

What if interlopers do not want to go home

If a resident illegal foreign national really does not want to go home regardless of the incentive, then there is another option that actually costs taxpayers nothing and permits the interloper to stay in America indefinitely in a legal state as long as they "behave." The program provides for granting interlopers in good standing what we are about to call a Resident Visa. This is a new visa type that, unlike other visa types can be renewed each and every year with conditions.

With this, former foreign nationals would be legal under the protection of the Resident Visa and could remain in America as long as they behave in a lawful manner according to the exact terms of their visa.

There are many differences between illegally gaining benefits in the United States and becoming legal by gaining a Resident Visa. Those choosing to employ the Resident Visa to stay in America, are welcome to do so; but the terms of the relationship with US officials will not be the same as when they were illegal.

For example, there would be no more cash incentives. The former interloper would be temporarily legalized after applying for a special US passport and then a Resident Visa and after being approved for both. The visa will be special in that it will be renewable with a fee of \$100 required annually after a renewal application, a record update (demographics, etc.), and a re-vetting of the applicant, and a special oath of allegiance.

Why should an illegal alien residing in America in the shadows find either of these two different plans acceptable?

- ✓ Stipend-Assisted Return Program
- ✓ Resident Visa Program
- 1. No more living in the shadows of America.
- 2. Opportunity to go home travel-free if desired with a big stipend paid by Americans.
- 3. US will budget \$15 Billion for safe cities in home countries for returning immigrants
- 4. US will develop 15 safe settlements / cities with 10 in Mexico
- 5. Can get in line (back of line) in home country for citizenship without leaving US.
- 6. With renewals, the opportunity to live in America a lifetime.
- 7. Can obtain a driver's license, insurance, etc.
- 8. Can keep any job that is already held.
- 9. Can apply for any job available in America.

- 10. Can live wherever they want in America.
- 11. Can get same paid by patient medical insurance as Americans.
- 12. Can get installment loans from US Government on an exception basis to help with medical and educational expenses. Must be paid back.
- 13. After five years but no more, living with a Resident Visa, can still opt for stipend to go home.
- 14. Anchor family stipends to go home are huge (\$50,000 per birthright citizen) and cumulative with a no-return promise.

I would suspect that list above provides a lot more advantages for interlopers than most would ever believe from how the corrupt US press will preview this program. Yet, this is just one of two major options that under the Stipend Return / Resident Visa Program, from which illegal residents may choose.

Many of the advantages for current interlopers are listed in the fourteen points above. The first plan provides a pay-to-go option that is more generous than any other country in the world. The second plan is the Resident Visa Program since getting a Resident Visa is all that is needed to win the illegal alien game. If you want to win and stay in America, this is the plan for you.

Winning the illegal alien game thankfully does not mean that Americans are shut out. Any illegal foreign national who opts for the stipend deal and departs for home under the Stipend-Assisted Return Program should have no regrets as all expenses are paid and the stipend is nice, and it includes \$20,000 for each alien dependent who are also in the program. A three-child family can provide a \$100,000 stipend for the family in the home country and the US can more than afford to pay it.

Knowing this is so beneficial to interlopers, why should Joe America want this program? In a nutshell, it is because Joe America is smart and knows this will save a ton of dollars for him and all Americans.

Many Americans do not trust the government, period. So, why would Americans think this is a good deal if the illegal foreign national does not choose to exit America with a stipend? Then what? If an illegal foreign national chooses not to accept this US government act of kindness, and does not go home, and does not sign up for The Resident Visa Program—the only two options in the Stipend Return / Resident Visa Program, there is only one course of action left for the government. The interloper will be asked to leave the country at their own expense. They will be deported otherwise.

By the enactment of this new visa and this new "return home" plan, the idea of residing in America in an illegal alien status is being eliminated, period. The lack of a decision by an illegal interloper to choose one or the other will unfortunately provoke immigration authorities to deport them.

Why should an American citizen like these two plans?

- 1. The days of the free lunch are over.
- 2. Fee based passport & Resident Visa is designed to be cost free to Americans
- 3. Return Home stipends pay for themselves in one year
- 4. Illegal aliens must agree to terms of Resident Visa-- all benefits eliminated after 1st year.
- 5. Once an illegal alien returns home, cannot come back; no cost is accrued after year 1
- 6. No birthright citizenship for illegals, permanent residents, and Resident Visa Holders
- 7. No cash, medical services, education, welfare, or other benefits permitted for those with a Resident Visa.
- 8. No citizen-only privileges permitted
- 9. Resident Visa Holders have no right to vote in any election
- 10. New jobs must go to American citizens first—all things being equal.
- 11. Fees, fines on employers will help pay for Resident Visa program kickoff. Will generate approximately \$400 Billion.
- 12. When program in high gear, US will save more than \$500 Billion per year on interloper expenses.
- 13. Resident Visa holder must be employed (1 yr. to get a job)
- 14. Resident Visa holder must have self-paid or employer-paid healthcare
- 15. Resident Visa holder must pass English test in two years

- 16. Resident Visa holder must take oath of allegiance to be approved for 1st renewal
- 17. No more green cards for family reunification-instead use Resident Visa.
- 18. All green card permanent residence visas are eliminated when expired. No new green cards. Use Resident Visa.
- 19. Next 10-yr green card renewal becomes a Resident Visa
- 20. No path to citizenship without going home to get in line (begin a process like all others from that country)
- 21. Citizenship line -- jumping the line is not permitted.
- 22. Major cost savings for America

The end of Sanctuary Cities

Victor David Hanson writes: "Sanctuary cities protect illegal aliens from federal immigration agencies in a way that is not true of American citizens who arrive at airports and must go through customs, with no exemption from federal agents examining their passports and personal histories. If crimes or infractions are found, there is no safe space at an airport exempt from federal enforcement."

The SR/RV program either pays illegal interlopers to go or it provides a Resident Visa that offers many benefits to both interlopers and American citizens. For example, it saves about \$500,000,000,000 per year after year one of its implementation. With no more illegal aliens in the country, a major advantage is that the divisive notion of Sanctuary Cities and the term Sanctuary Cities can be removed from the US vocabulary. There will be no need for them with residents all being legal.

Anchor babies qualify

The Stipend Return program is also available to those who became citizens through the anchor baby loophole of the 14th amendment. When an Anchor child with parent chooses to join the Stipend Return program, each anchor citizen child will receive a \$50,000 stipend and each of his or her interloper parents will receive their own \$20,000 for a total of \$70,000 for a two-person family and \$90,000 for a three-person family with one child. A family of four anchor children with a mom or dad would receive \$240,000. With mom and dad, the sum would be \$240,000. This is very affordable for US citizens considering the lifetime cost of one anchor baby can be as much as \$2 million or more.

DACA "children" also qualify

The SRRV program solves the problem for DACA children also. DACA children qualify for the full \$20,000 stipend in the Stipend Return Program. Those in the DACA program also qualify for the Resident Visa Program if they want to stay in the US. As an additional DACA concession for the "Children" who opt for the Resident Visa, there will be no charge for the visa for the first five renewal years. DACA "children" will be vetted when they apply for a resident passport. Gang members, of course, will be deported without benefits.

The evidence is on the table.

Nobody in their right mind wants life to continue with a shadow population who in many ways have been victimized similar to how slaves were victimized many years ago. The Stipend Return and the Resident Visa are programs that provide a way out of the mess for both interlopers and regular Americans.

Greedy fat cat business persons and politicians at the highest levels created this mess for both factions. Consequently, the plan includes substantial fees and fines for those businesses who hired illegal interlopers instead of Americans. Being greedy will cost the fat cats over \$400 Billion and perhaps more.

They made a ton of money off the backs of Americans with lower wages while poor interlopers were living in squalor with subminimum wages. American industry as represented by the Chamber of Commerce should show some remorse and voluntarily chip in to help solve this problem and back the Stipend Return / Residence Visa Plan as it is a winner for all decent Americans and the long-suffering communities whose only solace is the shadows of America.
